FIRST COUNT:

On or about October 21, 2023, within the District of Columbia, Quinton A. Thomas wrongfully obtained and used property of value, belonging to CVS, consisting of merchandise, with the intent to appropriate the property for his own use and to deprive CVS of a right to and benefit of the property. (Second Degree Theft - Felony, in violation of 22 D.C. Code, Sections 3211, 3212(c) (2001 ed.))

SECOND COUNT:

On or about November 1, 2023, within the District of Columbia, Quinton A. Thomas wrongfully obtained and used property of value, belonging to CVS, consisting of merchandise, with the intent to appropriate the property for his own use and to deprive CVS of a right to and benefit of the property. (Second Degree Theft - Felony, in violation of 22 D.C. Code, Sections 3211, 3212(c) (2001 ed.))

THIRD COUNT:

On or about November 5, 2023, within the District of Columbia, Quinton A. Thomas wrongfully obtained and used property of value, belonging to CVS, consisting of merchandise, with the intent to appropriate the property for his own use and to deprive CVS of a right to and benefit of the property. (Second Degree Theft - Felony, in violation of 22 D.C. Code, Sections 3211, 3212(c) (2001 ed.))

FOURTH COUNT:

On or about November 18, 2023, within the District of Columbia, Quinton A.
