The Grand Jury charges:

FIRST COUNT:

Keyon Slaughter, within the District of Columbia, while armed with a firearm, purposely and with deliberate and premeditated malice, killed Dana Bailey, Jr. by shooting Dana Bailey, Jr. with a firearm on or about December 5, 2022, thereby causing injuries from which Dana Bailey, Jr. died on or about December 5, 2022. (First-Degree Murder While Armed (Premeditated), in violation of 22 D.C. Code, Sections 2101, 4502 (2001 ed.))

SECOND COUNT:

On or about December 5, 2022, within the District of Columbia, Keyon Slaughter did possess a firearm while committing the crime of First-Degree Murder as set forth in the First Count of this indictment. (Possession of a Firearm During Crime of Violence or Dangerous Offense, in violation of 22 D.C. Code, Section 4504(b) (2001 ed.))

THIRD COUNT:

Keyon Slaughter, within the District of Columbia, while armed with a firearm, in perpetrating and attempting to perpetrate the crime of First-Degree Burglary of a Dwelling While Armed, as set forth in the Fifth Count of this indictment, killed Dana Bailey, Jr. by shooting Dana Bailey, Jr. with a firearm on or about December 5, 2022, thereby causing injuries from which Dana Bailey, Jr. died on or about December 5, 2022. (First-Degree Murder While Armed - Felony Murder, in violation of 22 D.C. Code, Sections 2101, 4502 (2001 ed.))

FOURTH COUNT:

On or about December 5, 2022, within the District of Columbia, Keyon Slaughter did possess a firearm while committing the crime of First-Degree Murder as set forth in the Third Count of this indictment. (Possession of a Firearm During Crime of Violence or Dangerous Offense, in violation of 22 D.C. Code, Section 4504(b) (2001 ed.))

FIFTH COUNT:


On or about December 5, 2022, within the District of Columbia, Keyon Slaughter, while armed with a firearm, entered the dwelling of Dana Bailey, Jr., while Dana Bailey, Jr. was inside that dwelling with the intent to commit an assault. (First-Degree Burglary While Armed, in violation of 22 D.C. Code, Section 801(a), 4502 (2001 ed.))

SIXTH COUNT:

On or about December 5, 2022, within the District of Columbia, Keyon Slaughter did possess a firearm while committing the crime of First-Degree Burglary as set forth in the Fifth Count of this indictment. (Possession of a Firearm During Crime of Violence or Dangerous Offense, in violation of 22 D.C. Code, Section 4504(b) (2001 ed.))

SEVENTH COUNT:

On or about December 5, 2022, within the District of Columbia, Keyon Slaughter, knowing he had previously been convicted in any court of a crime punishable by imprisonment for a term exceeding one year, owned, kept, and had within his possession and control, a firearm. (Unlawful Possession of a Firearm (Prior Conviction), in violation of 22 D.C. Code, Section 4503 (a)(1),(b)(1) (2001 ed.))
