Between January 1 and September 30, 2024:

- 7,512 cases charged in D.C. Superior Court
 - 2,304 defendants charged with at least one felony offense
- 1,083 felony cases indicted in D.C. Superior Court
- 1,382 guilty pleas in felony D.C. Superior Court cases
- 454 trials in D.C. Superior Court

As of September 30, 2024: 2,896 active felony prosecutions in D.C. Superior Court
