The Grand Jury charges:

FIRST COUNT:

The Conspiracy

Between on or about April 6, 2022 and on or about July 12, 2023, within the District of Columbia and elsewhere, Derricko Johnson, also known as "Maxxo," also known as "Rico," also known as "Diddy," Ronald Henderson, also known as "Rondon," also known as "Day Day," also known as "gbglilactive," also known as "gbglilact," Daveon Robinson, also known as "Sosa," also known as "Sowap," Demarco Robinson, also known as "Dirt," also known as "Dirty," and Dionzai Parker, also known as "Moneybag Jefe," also known as "Jefe," also known as "Jefe," also known as "Mook," and other persons whose identities are known and unknown to the grand jury, who are members of a criminal organization or crew referred to by many names, to include "the Z" and/or "Get Back Gang," which is affiliated with a larger criminal organization or crew referred to as "Fox 5 Gang," and/or "YGA," did knowingly and willfully combine, conspire, confederate, and agree together to assault and kill anyone whose interests were contrary to those of the defendants and their associates, to include members and associates of rival crews and groups, in violation of 22 D.C. Code Sections 401, 402, 2101, 2103, and 4502.

Objects

The principal goals and purposes of this conspiracy were for the co-conspirators, including Derricko Johnson, Ronald Henderson, Daveon Robinson, Demarco Robinson, and Dionzai Parker, and other persons whose identities are known and unknown to the grand jury, to: (1) assault and kill anyone whose interests were contrary to those of Get Back Gang members and their associates, particularly members and associates of rival crews and groups to include "Deuce Deuce," 23rd and Savannah Terrace SE, and 3500 Stanton Road SE; (2) safeguard and protect their members and their turf and base of operations, which encompasses an area north of Alabama Avenue SE, east of 15th Place SE, and south and west of Bruce Place SE, Washington, D.C. known as "Henson Ridge," "the Z," and "the 5," within which area the crew engaged in illegal activities including the trading and sale of firearms and distribution of narcotics; and (3) hinder and prevent efforts by law enforcement to investigate, arrest, and prosecute, for their illegal activities, members and associates of Get Back Gang.

Manner and Means

The ways, manner, and means by which members of Get Back Gang, to include Derricko Johnson, Ronald Henderson, Daveon Robinson, Demarco Robinson, and Dionzai Parker, and other persons whose identities are known and unknown to the grand jury, acted in order to assault and kill individuals with contrary interests, to safeguard and protect their turf and base of operations, and to prevent apprehension and prosecution by law enforcement include but are

not limited to:

- Members and associates of Get Back Gang promoted and enhanced their status and reputation within the crew and throughout the Washington, D.C. area through the use of social media, including but not limited to YouTube, Instagram, and TikTok.
- Members and associates of Get Back Gang sought to discourage rivals and those with contrary interests from retaliating against them by promoting the violent nature of the Get Back Gang on social media, including but not limited to YouTube, Instagram, and TikTok.
- Members and associates of Get Back Gang often possessed and carried firearms and also shared in the possession of firearms, in part, so that they were always ready to launch an attack against rivals or others with contrary interests.
- 4. Members and associates of Get Back Gang would assist one another in their efforts to evade detection by law enforcement by, for example, attempting to remove various incriminating postings from social media, by warning one another of the presence of law enforcement, and by attempting to hide firearms and other illegal contraband, in an effort to evade detection by law enforcement and to obstruct the due administration of justice.

Overt Acts

In furtherance of the conspiracy, and in order to affect the objects thereof, members and associates of Get Back Gang, to include Derricko Johnson, Ronald Henderson, Daveon Robinson, Demarco Robinson, and Dionzai Parker, and other persons whose identities are known and unknown to the grand jury, alone and in various combinations, in the District of Columbia and elsewhere, directly and indirectly committed overt acts including, but not limited to, the following:

- On April 6, 2022, Daveon Robinson and Derricko Johnson, and other individuals whose identities are known and unknown to the grand jury, communicated regarding the purchase of a firearm.
- On April 9, 2022, Daveon Robinson, and others whose identities are known and unknown to the grand jury, communicated regarding the purchase of a firearm.

- 3. On April 9, 2022, at approximately 8:39 pm, Demarco Robinson sent a message to a group of individuals that included Derricko Johnson, Ronald Henderson, Daveon Robinson, and others whose identities are known and unknown to the grand jury, that included a screenshot of an Instagram post tagging an individual known to be associated with "Deuce Deuce" and the message "They in Frontline Men."
- On April 9, 2022, Derricko Johnson and Ronald Henderson responded to the group message, informing the group that they possessed firearms and asking what car to use.
- On April 11, 2022, Daveon Robinson messaged a group of individuals that included
 Derricko Johnson, Ronald Henderson, Demarco Robinson, and others whose identities are known and unknown to the grand jury regarding the location of a firearm.
- On April 11, 2022, at approximately 1:27 pm, Daveon Robinson obtained a firearm from inside of a house associated with a person with the nickname "Money" whose identity is known to the grand jury.
- 7. On April 11, 2022, at approximately 2:31 pm, Ronald Henderson asked the group "[h]ow it look" and messaged the group "I got a factory 19 wit 30 ima show ya when I get back a Nigga gave it to me for free."
- 8. On April 11, 2022, a white Honda HR-V was stolen by persons whose identities are known and unknown to the grand jury.
- On April 12, 2022, at approximately 9:00 am, Derricko Johnson asked an individual with the nickname "Bone" whose identity is known to the grand jury to "[t]ell the young Niggas take me ra."
- On April 12, 2022, at approximately 10:21 am, Daveon Robinson warned Derricko
 Johnson that "the fed on bikes."
- On April 12, 2022, beginning at approximately 10:22 am, Daveon Robinson and Derricko
 Johnson discussed the location of an "ap" firearm that belonged to Demarco Robinson.
- 12. On April 12, 2022, beginning at approximately 11:46 am, Derricko Johnson messaged Demarco Robinson "on the way" and "[h]e not out there nm."
- 13. On April 12, 2022, prior to 12:21 pm, Derricko Johnson armed himself with a firearm.
- On April 12, 2022, prior to 12:21 pm, Derricko Johnson and other persons whose identities are known and unknown to the grand jury entered a white Honda.
- 15. On April 12, 2022, at approximately 12:21 pm, Derricko Johnson exited the white Honda

- and fired a firearm in the direction of businesses located in the 2200 block of Savannah Street, S.E.
- On April 12, 2022, as Derricko Johnson was firing his weapon in the general direction of the decedent, Clayton Marshall, Mr. Marshall was shot and killed.
- On April 12, 2022, as Derricko Johnson was firing his weapon in the general direction of the victim, James Jackson, Mr. Jackson was shot and injured.
- 18. On April 12, 2022 at approximately 12:27 pm, Derricko Johnson sent a message to an individual with the nickname "Bone" whose identity is known to the grand jury "[t]ell them get my phone from out the car."
- 19. On April 12, 2022, at approximately 12:28 pm, Derricko Johnson sent two messages to the individual with the nickname "Bone" whose identity is known to the grand jury "[h]urry up bruh" and "[m]y phone."
- On April 12, 2022, at approximately 12:30 pm, Derricko Johnson asked Demarco
 Robinson for "Bone's" number, and said "[h]urry up and send it to me."
- 21. On April 12, 2022, at approximately 12:33 pm, Demarco Robinson sent Derricko Johnson a message with a number that is associated with an individual with the nickname "Bone" whose identity is known to the grand jury.
- 22. On April 12, 2022, at approximately 6:08 pm, Derricko Johnson sent a text message to an individual whose identity is unknown to the Grand Jury stating he was "[t]ryna swap my 17."
- On April 13, 2022, at approximately 5:30 pm, Derricko Johnson traded a firearm with an
 individual whose identity is unknown to the grand jury in exchange for another firearm.
- 24. On May 1, 2022, Derricko Johnson communicated with another individual whose identity is known to the grand jury about the purchase and sale of ammunition.
- 25. On May 26, 2022, at approximately 7:46 am, Derricko Johnson sent two messages to Ronald Henderson "[w]hat your man say about the eggs" and "[c]ause u can grab the joint from bone."
- 26. On May 26, 2022, at approximately 7:46 am, Ronald Henderson sent two messages to Derricko Johnson "I got 11" and "[f]rom the yungins."
- 27. On May 26, 2022, at approximately 7:50 am, Derricko Johnson sent an individual whose identity is known to the grand jury two messages "[y]a used em rq" and "[d]id ya use em?"
- 28. On May 26, 2022, at approximately 7:51 am, the same individual whose identity is

- known to the grand jury sent a message to Derricko Johnson "[n]ah we gave dem to rondon last night."
- 29. On May 26, 2022, at approximately 7:55 am, the same individual whose identity is known to the grand jury sent a message to Derricko Johnson "[n]vm he tryna get em now but Melly not answering."
- 30. On May 26, 2022, at approximately 7:55 am, Ronald Henderson sent two messages to Derricko Johnson "[a]t melly house but he ain't answering I'm trn get the 11" and "[h]e live across from Jefe alley."
- 31. On May 26, 2022, at approximately 8:00 am, Ronald Henderson sent two messages to Derricko Johnson "I got the eggs" and "11."
- 32. On May 26, 2022, at approximately 8:37am, an individual whose identity is known to the grand jury sent two messages to a group including Derricko Johnson, Ronald Henderson, Demarco Robinson, and other individuals whose identities are known and unknown to the grand jury, "[m]y man just text me" and "[h]e said it's 20 feds around the z."
- 33. On May 26, 2022, at approximately 8:43 am, Ronald Henderson sent two messages to a group including Derricko Johnson, Demarco Robinson, and other individuals whose identities are known and unknown to the grand jury. "Iffluck them" and "It'lhey gone."
- 34. On May 26, 2022, at approximately 8:49 am, Derricko Johnson sent a message to a group that included Ronald Henderson, Demarco Robinson, and other individuals whose identities are known and unknown to the grand jury, "Rondon wya.?"
- 35. On May 26, 2022, prior to 11:22 am, Derricko Johnson armed himself with a firearm.
- 36. On May 26, 2022, prior to 11:22 am, Ronald Henderson armed himself with a firearm.
- On May 26, 2022, as Derricko Johnson was firing his weapon in the general direction of the decedent, Justin Johnson, Mr. Johnson was shot and killed.
- 38. On May 26, 2022, as Ronald Henderson was firing his weapon in the general direction of the decedent, Justin Johnson, Mr. Johnson was shot and killed.

group that included Derricko Johnson, Daveon Robinson, Demarco Robinson, and other individuals whose identities are known and unknown to the grand jury, "[t]he only person name that's coming up is max fr."

- 41. On May 28, 2022, at approximately 12:19 pm, Daveon Robinson sent two messages to a group that included Derricko Johnson, Ronald Henderson, Demarco Robinson, and other individuals whose identities are known and unknown to the grand jury "[t]hey don't know" and "[a]ll he said was the streets talking."
- 42. On May 28, 2022, at approximately 1:03 pm, Ronald Henderson sent three messages to a group that included Derricko Johnson, Daveon Robinson, Demarco Robinson, and other individuals whose identities are known and unknown to the grand jury, "[t]hey do know," "[t]hey said max name come up," and "[f]or it."
- 43. On June 7, 2022, at approximately 4:16 pm, Ronald Henderson sent a message to a group including Derricko Johnson, Demarco Robinson, and other individuals whose identities are known and unknown to the grand jury "[e]verybody leave the gc #wop."
- 44. On August 30, 2022, Ronald Henderson posted a music video to YouTube titled "Tappn Dat Nugget" in which Ronald Henderson references "Get Back Gang" and depicts several objects that appear to be consistent with real firearms.
- 45. On September 28, 2022, Ronald Henderson posted a music video to YouTube titled "Walkin Wit 50," in which Ronald Henderson references "Get Back Gang" and depicts several objects that appear to be consistent with real firearms.
- 46. On October 12, 2022, Ronald Henderson posted a music video to YouTube titled "Dawg Shit (drag)," in which Ronald Henderson references "Get Back Gang" and depicts several objects that appear to be consistent with real firearms.
- 47. On October 12, 2022, Derricko Johnson, Daveon Robinson, and Demarco Robinson appear in the YouTube video titled "Dawg Shit (drag)," around the time that several objects appearing to be consistent with real firearms are depicted.
- 48. On January 1, 2023, Ronald Henderson posted a music video to YouTube titled
 "GBGLILACTIVE 'Last Diss' (Official Music Video) Dir. @waxbando" in which Ronald Henderson
 references "Get Back Gang," the "opps," and depicts several objects that appear to be consistent
 with real firearms.
- 49. On January 1, 2023, at approximately 11:50 am, Daveon Robinson sent two messages to

- a group that included Ronald Henderson, Demarco Robinson, and other individuals whose identities are known and unknown to the grand jury "[w]e done shooting in the air" and "[l]et's put up on some cars."
- 50. On January 1, 2023, at approximately 11:51 am, Ronald Henderson "[l]iked a message" in a group that included Daveon Robinson, Demarco Robinson, and other individuals whose identities are known and unknown to the grand jury.
- 51. On January 1, 2023, at approximately 6:03 pm, Daveon Robinson sent a message to a group that included Derricko Johnson and other individuals whose identities are known and unknown to the grand jury "[w]e going give them what they want."
- 52. On January 2, 2023, at approximately 9:24 am, Daveon Robinson sent a message to an individual whose identity is known to the grand jury "[t]ake me threw."
