MINUTE ORDER as to ABU AGILA MOHAMMAD MAS'UD KHEIR AL-MARIMI. A status hearing is scheduled for April 1, 2025 at 10:30 a.m. in person in Courtroom 24A. For the reasons stated in the March 12 hearing -- namely, the complex nature of the case, the amount of time required to adequately prepare for pretrial proceedings and for trial, see 18 U.S.C. § 3161(h)(7)(B)(ii), the voluminous discovery, including evidence located in other countries, id. § 3161(h)(8), and the need for the defense to determine how best to defend this case, see id. § 3161(h)(7)(B)(iv) -- the Court finds that the "ends of justice outweigh the best interest of the public and the defendant in a speedy trial." 18 U.S.C. § 3161(h)(7)(A). Accordingly, pursuant to the Speedy Trial Act, the time from March 12, 2025 through May 12, 2025 shall be excluded in computing the date for a speedy trial in this case. So Ordered by Judge Dabney L.
