The Grand Jury charges:

FIRST COUNT:

On or about January 22, 2025, within the District of Columbia, Tywana Johnson, while armed with and having readily available a dangerous and deadly weapon that is a knife, by force and violence, against resistance and by means of sudden and stealthy seizure and snatching, and by putting in fear, stole and took from the person and from the immediate actual possession of Patrick McCue property of value belonging to Patrick McCue, consisting of a cell phone. (Robbery While Armed, in violation of 22 D.C. Code, Section 2801, 4502 (2001 ed.))

The Grand Jury further charges that at the time Tywana Johnson committed the crime of violence set forth in this Count against Patrick McCue, Patrick McCue was traveling on a mass transit vehicle within the District of Columbia. (Crime of Violence Committed Against a Mass Transit Passenger, in violation of 22 D.C. Code Section 3751.01(a-1) (2001 ed.))

(Robbery While Armed, Crime of Violence Committed Against a Mass Transit Passenger (Post March 12, 2024), in violation of 22 D.C. Code, Section 2801, 3751.01(a-1), 4502 (2001 ed.))

SECOND COUNT:

On or about January 22, 2025, within the District of Columbia, Tywanna Johnson, while armed with a knife, assaulted Patrick McCue with intent to steal and take valuable goods and property, that is, a cell phone, from the person and from the actual immediate possession of Patrick McCue by force and violence, against resistance and by putting in fear. (Assault With Intent To Commit Robbery While Armed, in violation of 22 D.C. Code, Sections 401, 4502 (2001 ed.))

The Grand Jury further charges that at the time Tywanna Johnson committed the crime of violence set forth in this Count against Patrick McCue, Patrick McCue was traveling on a mass transit vehicle within the District of Columbia. (Crime of Violence Committed Against a Mass Transit Passenger, in violation of 22 D.C. Code Section 3751.01(a-1) (2001 ed.))

(Assault With Intent To Commit Robbery While Armed, Crime of Violence Committed Against a Mass Transit Passenger (Post March 12, 2024), in violation of 22 D.C. Code, Sections 401, 4502, 3751.01(a-1) (2001 ed.))

THIRD COUNT:

On or about January 22, 2025, within the District of Columbia, Tywanna Johnson assaulted Patrick MCCue with a dangerous weapon, that is, a knife. (Assault with a Dangerous Weapon, in violation of 22 D.C. Code, Section 402 (2001 ed.))

The Grand Jury further charges that at the time Tywanna Johnnson committed the crime of violence set forth in this Count against Patrick McCue, Patrick McCue was traveling on a mass transit vehicle within the District of Columbia. (Crime of Violence Committed Against a Mass Transit Passenger, in violation of 22 D.C. Code Section 3751.01(a-1) (2001 ed.))

(Assault with a Dangerous Weapon, Crime of Violence Committed Against a Mass Transit Passenger (Post March 12, 2024), in violation of 22 D.C. Code, Section 402, 3751.01(a-1) (2001 ed.))

FOURTH COUNT:

On or about January 22, 2025, within the District of Columbia, Tywana Johnson, while armed with and having readily available a dangerous and deadly weapon that is a knife, unlawfully assaulted and threatened Patrick McCue in a menacing manner and intentionally, knowingly, and recklessly caused significant bodily injury to Patrick McCue. (Assault with Significant Bodily Injury While Armed, in violation of 22 D.C. Code, Section 404 (a)(2), 4502 (2001 ed.))

The Grand Jury further charges that at the time Tywana Johnson committed the crime of violence set forth in this Count against Patrick McCue, Patrick McCue was traveling on a mass transit vehicle within the District of Columbia. (Crime of Violence Committed Against a Mass Transit Passenger, in violation of 22 D.C. Code Section 3751.01(a-1) (2001 ed.))

FIFTH COUNT:

On or about January 22, 2025, within the District of Columbia, Tywana Johnson threatened to injure or kidnap Patrick McCue. (Threatening To Injure/Kidnap a Person, in violation of 22 D.C. Code, Section 1810 (2001 ed.))
