I am presenting the memorandum of Hicham Abu Agila Mohammad Masud Al-Marimi

Birthdate: 31/03/1976 CE, Tripoli

I am the son of the convicted defendant/ Abu Agila Mohammad Masud al-Marimi in case number (630 for the year 2012 CE), in which the court sentenced him to (10 years) of imprisonment

He was summoned on 17/09/2011 CE by the National Security Center and placed in the (National Security Center) then in an apartment in (the Soldier's Building) belonging to them, and then in (the Salah al-Rajbani Villa), a touristic accommodation, and then in (the house of Debnoun) in the Ghout al-Shaal region. (Mohamed Khelifa al-Waer – Misbah al-Mabrouk Rabi – Fayez Kaal – Mohsen Al-Hadi al-Lamouji – and Said Ibrahim al-Gharyani – [and] Abdullah Ali Filfil) were placed with him. [handwritten: Abdullah al-Shaalani]

On 20/01/2012 CE they were placed in the al-Rouaimi Prison. The people in charge of the prison at that time were/ Issam al-Qudairi and Abdullah Abu Draa.

On 23/02/2012 CE, he was moved to the city of Misrata on the instructions of Mr./ Fawzi Abdel Aal in his capacity, at that time, as Minister of the Interior. He was placed in (Al-Ribat Prison), and the people in charge there was Hicham Samir, Sofian al-Qobbi, Ibrahim al-Taeb, and Ibrahim Ben Katou.

On 15/04/2014 CE, he was moved to the (air Force College Prison Misrata). The person in charge of the College was Jamal Abu Bardaa.

On 31/10/2014 CE, he was moved to Tripoli and placed in the (Military College al-Hadba). Khalid al-Sharif was in charge of the College. He was sentenced on 26/06/2015 CE to ten years of imprisonment in the Military College.

On 26/06/2017, all the prisoners were moved to the former site of the Doctrinal Education [facility] in the region of Eastern al-Hadba after the College was attacked by the (Tripoli Revolutionaries) Brigade.

On 26/05/2017 CE, he was moved to the (Al-Rouaimi) Prison in the Ain Zara region, and he remains there, serving his sentence, as of the date of this memorandum.

Whereas the head of our family suffers from several diseases, including (diabetes – high blood pressure – prostate – herniated disc – he needs operations on both eyes – he was injured during the war on Tripoli by shrapnel in his leg, and he thereafter underwent treatment and surgery at the Royal Medical Center on Al-Shawk Road al-Hadba), in addition to his advanced age, and he requires specialized care.

We, his family, ask Your Excellency, for the period from 05/09/2011 CE until 24/08/2013 CE.

For humanitarian reasons, and because he has served a third of his sentence, and because of the chronic illnesses he suffers, because of his poor state of health, and because he is elderly.


