**JOINT MOTION FOR BRIEFING ON MOTION TO SUPPRESS HEARING**

The United States of America, by and through its attorney, the United States Attorney for the District of Columbia, and the defendant by and through undersigned Defense Counsel, hereby respectfully request that the Court set a briefing schedule regarding the public's right of access to evidence the Court may accept at the hearing on the defendant's motion to suppress.

The parties have discussed the issue and, with some differences, are mostly aligned on what the proper outcome should be. However, each party has some different interests that cause them to come to their positions. Accordingly, the parties believe it would benefit the Court to hear from both sides before deciding the issue. The parties thus propose that the defendant file an opening brief on the issue by December 30, 2025, that the government file its response by January 13, 2026, and that the defendant file any reply by January 20, 2026. The Court would then have three weeks to decide the issue prior to the hearing date that the parties have proposed.

Wherefore, the parties respectfully request that the Court sign the attached proposed order implementing the briefing schedule describe above.
