The Grand Jury charges:

FIRST COUNT:

On or about August 4, 2021, within the District of Columbia, Dyrell Gamble, also known as Dyrell Muhammad, engaged in a sexual contact with C.M., and caused C.M. to engage in and submit to a sexual contact, that is, contact between Dyrell Gamble's, also known as Dyrell Muhammad's, penis and C.M.'s hand, with the intent to abuse, humiliate, harass, degrade, and arouse and gratify the sexual desire of any person, when Dyrell Gamble, also known as Dyrell Muhammad, was an employee of a treatment facility and C.M. was a client and patient therein.

The Grand Jury further charges that Dyrell Gamble, also known as Dyrell Muhammad, has been found guilty of committing sex offenses against two or more victims.

(Second Degree Sexual Abuse of a Patient or Client (with Aggravating Circumstances), in violation of 22 D.C. Code, Sections 3014 and 3020(a)(5) (2001 ed.))
