The Grand Jury charges:

FIRST COUNT:

On or about February 4, 2023, within the District of Columbia, Herbert Young, while armed with and having readily available a dangerous and deadly weapon that is a knife, assaulted Charles Peeler, a person sixty-five years of age or older, with intent to kill him. (Assault With Intent To Kill While Armed of a Senior Citizen, in violation of 22 D.C. Code, Section 401, 4502, 3601 (2001 ed.))

SECOND COUNT:

On or about February 4, 2023, within the District of Columbia, Herbert Young, while armed with and having readily available a dangerous and deadly weapon that is a knife, did by any means, knowingly and purposely cause serious bodily injury to Charles Peeler, a person sixty-five years of age or older. (Aggravated Assault While Armed of a Senior Citizen, in violation of 22 D.C. Code, Section 404.01, 4502, 3601 (2001 ed.))

THIRD COUNT:

On or about February 4, 2023, within the District of Columbia, Herbert Young assaulted Charles Peeler, a person sixty-five years of age or older, with a dangerous weapon, that is, a knife. (Assault with a Dangerous Weapon of a Senior Citizen, in violation of 22 D.C. Code, Section 402, 3601 (2001 ed.))

FOURTH COUNT:

On or about February 4, 2023, within the District of Columbia, Herbert Young did carry, openly and concealed on or about his person, in a place other than his dwelling place, place of business or on other land possessed by him, a dangerous weapon that is, a knife. (Carrying a Dangerous Weapon (Outside Home or Place of Business), in violation of 22 D.C. Code, Section 4504(a)(1) (2001 ed.))
