The Advanced Gang Investigations training provides insight into techniques to investigate gang crimes and advanced tools for gang investigations, including information regarding how to integrate intelligence analysis and crime analysis. The training provides awareness of existing tools, resources, and guidelines for gang investigators. In addition, attendees are presented with a view beyond their traditional suppression duties to explore law enforcement's role in gang prevention and intervention.
