## **STATUTORY SENTENCES**

Conspiracy to Possess with Intent to Distribute and Possession with Intent to Distribute at least 500 grams, but less than 5 kilograms of cocaine, a Schedule II controlled substance is punishable by not less than 5 years' incarceration, but less than 40 years' incarceration with a possible fine up to \$5,000,000, and not less than 4 years' supervised release.

Conspiracy to Possess with Intent to Distribute and Possession with Intent to Distribute at least 28 grams, but less than 280 grams of cocaine base, a Schedule II controlled substance is punishable by not less than 5 years' incarceration, but not more than 40 years' incarceration with a possible fine up to \$5,000,000, and not less than 4 years' supervised release.

Conspiracy to Possess with Intent to Distribute and Possession with Intent to Distribute at least 50 grams of methamphetamine (actual), a Schedule II controlled substance is punishable by not less than 10 years' incarceration, up to life incarceration with a possible fine up to \$10,000,000, and not less than 5 years' supervised release.

Possession with Intent to Distribute at least 5 grams, but less than 50 grams of methamphetamine (actual), a Schedule II controlled substance is punishable by not less than 5 years' incarceration, but less than 40 years' incarceration with a possible fine up to \$5,000,000, and not less than 4 years' supervised release.

Conspiracy to Possess with Intent to Distribute and Possession with Intent to Distribute less than 500 grams of cocaine, a Schedule II controlled substance is punishable by not more than 20 years' incarceration in the Bureau of Prisons with a possible fine of up to \$1,000,000, and not less than 3 years supervised release.

Conspiracy to Possess with Intent to Distribute and Possession with Intent to Distribute less than 100 grams of heroin, a Schedule I controlled substance is punishable by not more than 20 years' incarceration in the Bureau of Prisons with a possible fine of up to \$1,000,000, and not less than 3 years supervised release.

Conspiracy to Possess with Intent to Distribute and Possession with Intent to Distribute less than 50 kilograms of marijuana, a Schedule I controlled substance is punishable by not more than 5 years' incarceration in the Bureau of Prisons with a possible fine of up to \$250,000, and not less than 2 years' supervised release.

Felon in Possession of a Firearm and Possession of a Stolen Firearm are punishable by not more than 10 years' incarceration in the Bureau of Prisons with a possible file of up to \$250,000, and not more than 3 years supervised release.

Possession of a Firearm in Furtherance of a Drug Trafficking Crime is punishable by not less than 5 years, not more than life incarceration in the Bureau of Prisons, consecutive to any other sentence, with a possible fine of up to \$250,000, and not more than 3 years supervised release.
