**FACTUAL BASIS**

If this case were to proceed to trial, the Government would prove the defendant guilty beyond a reasonable doubt. In count one of this one-count indictment, defendant, ANGEL ENO CORNEJO-MORENO a/k/a "Angel Cornejo", is charged with illegally re-entering the United States of America after having been removed from the United States. The Government would establish the following through reliable and competent evidence:


On December 8, 2014, Special Agents of Immigration & Customs Enforcement (ICE) New Orleans Criminal Alien Unit encountered ANGEL ENO CORNEJO-MORENO at the Jefferson Parish Jail in Gretna, Louisiana. The agents were informed by the Jefferson Parish Jail officials that Jefferson Parish Sheriff deputies had arrested CORNEJO-MORENO on December 6, 2014 for driving while intoxicated and driving without a license. During the arrest, deputies also discovered that CORNEJO-MORENO had two outstanding fugitive warrants.

On December 8, 2014, ICE agents learned that CORNEJO-MORENO has been deported from the United States to Honduras on two previous occasions. CORNEJO-MORENO was ordered removed by Immigration Judge Glenn P. McPhaul on May 18, 1999 and was subsequently deported via Taca Airlines flight #221 from New Orleans, Louisiana to Honduras on June 12, 2003. On October 28, 2008, CORNEJO-MORENO was encountered by ICE agents in the

Nassua County jail in New York and was served an I-871 Notice of Intent To Reinstate Prior Removal Order. CORNEJO-MORENO was subsequently deported on January 26, 2009 via the Justice Prisoner & Alien Transportation System (JPATS) from El Paso, Texas to Honduras.

On December 8, 2014, after learning of his two prior deportations, ICE agents then took custody of CORNEJO-MORENO and transported him to the ICE New Orleans office for processing. An ICE records check revealed that CORNEJO-MORENO is not a citizen of the United States but is, in fact, a citizen of Honduras. Records also confirmed CORNEJO-MORENO's June 12, 2003 and January 26, 2009 removals from the United States to Honduras. When CORNEJO-MORENO reentered the United States after he had been deported, he did not enter at a port of entry designated by the Attorney General or his successor, the Secretary of Homeland Security, and he was not inspected, admitted, or paroled by a United States Immigration Officer. Also, CORNEJO-MORENO received no waiver from the Attorney General or his successor, the Secretary of Homeland Security, to reenter the United States. CORNEJO-MORENO has made no applications or petitions to remain lawfully in the United States, and none have been made on his behalf. CORNEJO-MORENO has no legal status in the United States. Agents also advised CORNEJO-MORENO of his rights to consular notification, communication and access.

Finally, CORNEJO-MORENO admits that he illegally re-entered the United States of America after having previously been removed from the United States, and he acknowledges that said conduct constitutes a knowing violation of Title 8, United States Code, Section 1326(a).
