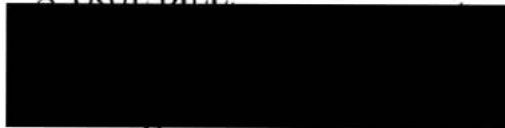
DELAY OR DESTRUCTION OF MAIL

On or about December 8, 2014, within the Eastern District of Louisiana, and elsewhere, the defendant, AVA SMITH ("SMITH"), being a Postal Service employee, did unlawfully secret, destroy, detain, and delay letters, postal cards, packages, bags, and mail entrusted to her and which came into her possession, and which were intended to be conveyed by mail and carried and delivered by any carrier and other employee of the Postal Service, and forwarded through and delivered from any post office and station thereof established by the authority of the

Postmaster General and the Postal Service, to wit, **SMITH** discarded approximately 573 pieces of First Class Mail, approximately 142 pieces of Standard Mail, and approximately 30 pieces of Non-Profit Mail; all in violation of Title 18, United States Code, Section 1703(a).
