The Grand Jury charges that:

COUNT 1

On or about January 8, 2018, in the Eastern District of Louisiana, the defendant, **MARVIN DAVID OYUELA LOPEZ, a/k/a Marvin Alvarez, a/k/a Marvin Qyuelalopez, a/k/a Marvin Lopez**, an alien, was found in the United States after having been officially deported and removed therefrom on or about December 10, 2013, and without the Attorney General of the United States or his designated successor, the Secretary of the Department of Homeland Security, as provided for in Title 6, United States Code, Sections 202(3), 202(4), and 557, having expressly consented to the defendant's reapplication for admission into the United States; all in violation of Title 8, United States Code, Section 1326(a).

NOTICE OF SENTENCING ENHANCEMENT

Now comes the United States of America, by and through Duane A. Evans, the United States Attorney for the Eastern District of Louisiana, to give notice that on or about September 30, 2013, in the 24th Judicial District Court Parish of Jefferson, Louisiana, the defendant, **MARVIN DAVID OYUELA LOPEZ, a/k/a Marvin Alvarez, a/k/a Marvin Qyuelalopez, a/k/a Marvin Lopez**, was convicted of Possession of Cocaine. Because of this felony conviction, if the defendant is convicted of a violation of Title 8, United States Code, Section 1326(a), the defendant's sentence will be subject to a maximum sentence of imprisonment for not more than 10 years. Title 8, United States Code, Section 1326(b)(1).


