#### COUNT 1

On or about December 20, 2017, in the Eastern District of Louisiana, the defendant, DARREN RUFFIN, having previously been convicted of a crime punishable by imprisonment for a term exceeding one year, to wit: a conviction on November 4, 2015, in the Orleans Parish Criminal District Court, under Case No. 520-142, Section "J," for aggravated flight from an officer, in violation of Louisiana R.S. 14:108.1(C), did knowingly possess in and affecting commerce, a firearm, to wit: .40 caliber Glock model 27 pistol, serial number BAKK112, said firearm having been shipped in interstate and foreign commerce, all in violation of Title 18, United States Code, Sections 922(g)(1) and 924(a)(2).

#### NOTICE OF GUN FORFEITURE

1. The allegation of Count 1 of this Indictment is realleged and incorporated by reference as though set forth fully herein for the purpose of alleging forfeiture to the United States of America pursuant to the provisions of Title 18, United States Code, Section 924(d)(1) and Title 28, United States Code, Section 2461(c).

2. As a result of the offense alleged in Count 1, the defendant, **DARREN RUFFIN**, shall forfeit to the United States pursuant to Title 18, United States Code, Section 924(d)(1), and Title 28, United States Code, Section 2461, any firearm or ammunition, which was involved in or used in knowing violation of Title 18, United States Code, Section 922(g), as alleged in Count 1 of the Indictment.

3. If any of the property subject to forfeiture pursuant to Paragraph 2 of this Notice of Forfeiture, as a result of any act or omission of the defendant:

- a. cannot be located upon the exercise of due diligence;
- b. has been transferred or sold to, or deposited with, a third person;
- c. has been placed beyond the jurisdiction of the Court;
- d. has been substantially diminished in value; or
- e. has been commingled with other property which cannot be subdivided without difficulty;

it is the intent of the United States, pursuant to Title 21, United States Code, Section 853(p), to seek forfeiture of any other property of said defendant up to the value of the above forfeitable property.
