The Grand Jury charges that:

COUNT 1

(Distribution of a Quantity of a Mixture or Substance Containing Heroin)

On or about January 20, 2018, in the Eastern District of Louisiana the defendant, **MICHAEL C. CRAWFORD, JR.**, did knowingly and intentionally distribute and possess with intent to distribute a quantity of a mixture and substance containing a detectable amount of heroin, a Schedule I controlled substance, all in violation of Title 21, United States Code, Sections 841(a)(1) and 841(b)(1)(C).

COUNT 2

(Distribution of a Quantity of a Mixture or Substance Containing Heroin)

On or about January 24, 2018, in the Eastern District of Louisiana the defendant, **MICHAEL C. CRAWFORD, JR.**, did knowingly and intentionally distribute and possess with intent to distribute a quantity of a mixture and substance containing a detectable amount of heroin, a Schedule I controlled substance, all in violation of Title 21, United States Code, Sections 841(a)(1) and 841(b)(1)(C).

COUNT 3

(Distribution of a Quantity of a Mixture or Substance Containing Heroin)

On or about January 30, 2018, in the Eastern District of Louisiana the defendant, **MICHAEL C. CRAWFORD, JR.**, did knowingly and intentionally distribute and possess with intent to distribute a quantity of a mixture and substance containing a detectable amount of heroin, a Schedule I controlled substance, all in violation of Title 21, United States Code, Sections 841(a)(1) and 841(b)(1)(C).

NOTICE OF DRUG FORFEITURE

1. The allegations of Counts One, Two and Three of this Indictment are realleged and incorporated by reference as though set forth fully herein for the purpose of alleging forfeiture to the United States of America pursuant to the provisions of Title 21, United States Code, Section 853.

2. As a result of the offenses charged in Counts One, Two and Three, the defendant, **MICHAEL C. CRAWFORD, JR.**, shall forfeit to the United States pursuant to Title 21, United States Code, Section 853, any and all property constituting or derived from any proceeds the defendant obtained directly or indirectly as a result of said violations and any and all property used

or intended to be used in any manner or part to commit and to facilitate the commission of the violations alleged Counts One, Two and Three of this Indictment.


3. If any of the property subject to forfeiture pursuant to Paragraph 2 of this Notice of Forfeiture, as a result of any act or omission of the defendant:

- a. cannot be located upon the exercise of due diligence;
- b. has been transferred or sold to, or deposited with, a third person;
- c. has been placed beyond the jurisdiction of the Court;
- d. has been substantially diminished in value; or
- e. has been commingled with other property which cannot be subdivided without difficulty;

it is the intent of the United States, pursuant to Title 21, United States Code, Section 853(p), to seek forfeiture of any other property of said defendant up to the value of the above forfeitable property.


All in violation of Title 21, United States Code, Sections 853, 841(a)(1), and 841(b)(1)(C).


