The Grand Jury charges that:

COUNT 1

On or about December 4, 2018, in the Eastern District of Louisiana, the defendant, **KEITH ANTHONY RAMIREZ**, by force, violence and intimidation, did take from the person or presence of another approximately \$668.00 of United States currency, belonging to and in the care, custody, control, management, and possession of the Capital One Bank, in Covington, Louisiana, a bank whose deposits were then insured by the Federal Deposit Insurance Corporation, in violation of Title 18, United States Code, Section 2113(a).

NOTICE OF BANK ROBBERY FORFEITURE

1. The allegations of Count 1 of this Indictment are realleged and incorporated by reference as though set forth fully herein for the purpose of alleging forfeiture to the United States of America pursuant to the provisions of Title 18, United States Code, Section 2113, made applicable through Title 28, United States Code, Section 2461.

2. As a result of the offenses alleged in Count 1 the defendant, **KEITH ANTHONY RAMIREZ**, shall forfeit to the United States pursuant to Title 18, United States Code, Section 2113, made applicable through Title 28, United States Code, Section 2461, any and all property, real or personal, which constitutes or is derived from proceeds traceable to a violation of Title 18, United States Code, 2113.

3. If any of the property subject to forfeiture pursuant to Paragraph 2 of this Notice of Forfeiture, as a result of any act or omission of the defendant:

- a. cannot be located upon the exercise of due diligence;
- b. has been transferred or sold to, or deposited with, a third person;
- c. has been placed beyond the jurisdiction of the Court;
- d. has been substantially diminished in value; or
- e. has been commingled with other property which cannot be subdivided without difficulty;

it is the intent of the United States, pursuant to Title 21, United States Code, Section 853(p), to seek forfeiture of any other property of said defendant up to the value of the above forfeitable property.


