The Grand Jury charges that:

**COUNT 1**  
**(Theft or Receipt of Stolen Mail Matter)**

On or about December 9, 2021, in the Eastern District of Louisiana, the defendants, **KYLE ARMSTRONG** and **KAREEM MADISON**, did steal and take from and out of an authorized depository for mail matter and post office letter box located at the Metairie Main Post Office, 3301 17th Street, Metairie, LA 70002, U.S. Mail matter, in violation of Title 18, United States Code, Sections 1708 and 2.

**COUNT 2**  
**(Unlawful Possession of Postal Key)**

On or about December 9, 2021, in the Eastern District of Louisiana, the defendants, **KYLE ARMSTRONG** and **KAREEM MADISON**, did knowingly and unlawfully possess a key adopted by the Postal Service and in use on authorized receptacle for the deposit of mail matter with the intent unlawfully and improperly to use the same, in violation of Title 18, United States Code, Sections 1704 and 2.

**COUNT 3**  
**(Felon in Possession of a Firearm)**

On or about December 9, 2021, in the Eastern District of Louisiana, the defendant, **KAREEM MADISON**, knowing that he had been convicted of a crime punishable by imprisonment for a term exceeding one year, to wit: a conviction on October 30, 2014, in Jefferson Parish, Case No. 14-01931, for violating La. R.S. 40:966(C), possession of a Schedule I controlled dangerous substance, did knowingly possess a firearm, that is a Glock 26, 9mm handgun bearing serial number AFPL899, said firearm having been in and affecting interstate commerce, in violation of Title 18, United States Code, Sections 922(g)(1) and 924(a)(2).

**NOTICE OF FORFEITURE**

1. The allegations of Counts 1 through 3 of this Indictment are incorporated by reference as though set forth fully herein for the purpose of alleging forfeiture to the United States.
2. As a result of the offense alleged in Counts 1, the defendants, **KYLE ARMSTRONG** and **KAREEM MADISON**, shall forfeit to the United States pursuant to Title 18, United States Code, Section 981(a)(1)(C), and Title 28, United States Code, Section 2461(c),

any property real or personal which constitutes or is derived from proceeds traceable to said offense.

3. As a result of the offense alleged in Count 3, the defendant, **KAREEM MADISON**, shall forfeit to the United States pursuant to Title 18, United States Code, Section 924(d)(1), and Title 28, United States Code, Section 2461(c), any firearm or ammunition involved in or used in the commission of said offenses, including but not limited to the following:


Glock model 26, 9mm handgun, bearing serial number AFPL899, with an extended magazine.

4. If any of the above-described property, as a result of any act or omission of the defendant:

- a. cannot be located upon the exercise of due diligence;
- b. has been transferred or sold to, or deposited with, a third person;
- c. has been placed beyond the jurisdiction of the Court;
- d. has been substantially diminished in value; or
- e. has been commingled with other property which cannot be subdivided without difficulty;

the United States shall seek a money judgment and, pursuant to Title 21, United States Code, Section 853(p), forfeiture of any other property of the defendant up to the value of said property.
