The Grand Jury charges that:

COUNT 1

(Felon in Possession of a Firearm)

On or about December 27, 2021, in the Eastern District of Louisiana, the defendant, **JAKARI BROWN, a/k/a "Jakari Lemar,"** knowing that he had been convicted of a crime punishable by imprisonment for a term exceeding one year, to wit: a conviction on or about June 23, 2016, in the 22nd Judicial District Court, Parish of St. Tammany, State of Louisiana, under case number 573893-1, for attempted simple burglary, in violation of LA. R.S. 14:27:62, and a conviction on or about October 21, 2019, in the 22nd Judicial District Court, Parish of Washington, State of Louisiana, under case number 19-CR2-141621, for attempted possession of a firearm by

a convicted felon, in violation of LA. R.S. 14:27:95.1, did knowingly possess in and affecting commerce, a firearm, to wit: a Smith & Wesson, Model SW9VE, 9mm pistol, bearing serial number PDN3440, in violation of Title 18, United States Code, Sections 922(g)(1) and 924(a)(2).

NOTICE OF FORFEITURE

1. The allegations of Count 1 of this Indictment are incorporated by reference as though set forth fully herein for the purpose of alleging forfeiture to the United States.

2. As a result of the offense alleged in Count 1, the defendant, **JAKARI BROWN, a/k/a “Jakari Lemar,”** shall forfeit to the United States pursuant to Title 18, United States Code, Section 924(d)(1), and Title 28, United States Code, Section 2461(c), any firearm or ammunition involved in or used in the commission of said offense, including but not limited to:

a Smith & Wesson, Model SW9VE, 9mm pistol, bearing serial number PDN3440.

3. If any of the above-described property, as a result of any act or omission of the defendant:


- a. cannot be located upon the exercise of due diligence;
- b. has been transferred or sold to, or deposited with, a third person;
- c. has been placed beyond jurisdiction of the Court;
- d. has been substantially diminished in value; or
- e. has been commingled with other property which cannot be subdivided without difficulty;

the United States shall seek a money judgment and, pursuant to Title 21, United States Code, Section 853(p), forfeiture of any other property of the defendant up to the value of said property.
