The Grand Jury charges that:

COUNT 1

On or about May 4, 2022, in the Eastern District of Louisiana, the defendant, **RONNIE DAVIS**, knowing that he had been convicted of a crime punishable by imprisonment for a term exceeding one year, that is, a conviction on June 23, 2016, in the State of Louisiana, Parish of Orleans, case number 527-901, for illegal carrying of a weapon with a controlled dangerous substance, in violation of LA-R.S. 14:95(E); possession with intent to distribute marijuana, in violation of LA-R.S. 40:966(A)(2); possession of cocaine, in violation of LA-R.S. 40:967(C); and possession of heroin, in violation of LA-R.S. 40:966(C); did knowingly possess two firearms, that is, a Taurus 9 mm handgun bearing serial number TLY91169, and a Century Arms "Draco" style

7.62x39 mm rifle bearing serial number PMD-10511-19 RO, said firearms being in and affecting foreign and interstate commerce, in violation of Title 18, United States Code, Sections 922(g)(1) and 924(a)(2).

NOTICE OF FORFEITURE

1. The allegation of Count 1 of this Indictment is incorporated by reference as though set forth fully herein for the purpose of alleging forfeiture to the United States.

2. As a result of the offense alleged in Count 1, the defendant, **RONNIE DAVIS**, shall forfeit to the United States, pursuant to Title 18, United States Code, Section 924(d)(1), and Title 28, United States Code, Section 2461(c), any firearm or ammunition involved in or used in the commission of said offense, including but not limited to the following:

Taurus 9 mm handgun bearing serial number TLY91169;

Century Arms "Draco" style 7.62x39 mm rifle bearing serial number
PMD-10511-19 RO

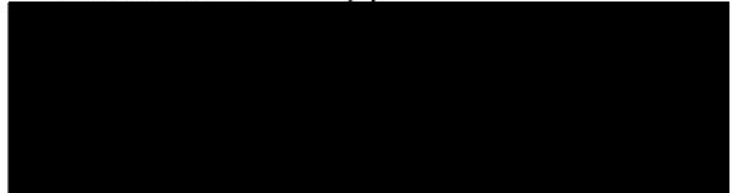
3. If any of the above-described property, as a result of any act or omission of the defendant:

- a. cannot be located upon the exercise of due diligence;
- b. has been transferred or sold to, or deposited with, a third person;
- c. has been placed beyond the jurisdiction of the Court;
- d. has been substantially diminished in value; or


- e. has been commingled with other property which cannot be subdivided without difficulty;

the United States shall seek a money judgment and, pursuant to Title 21, United States Code, Section 853(p), forfeiture of any other property of the defendant up to the value of said property.
