INDICTMENT

COUNT ONE

THE GRAND JURY CHARGES THAT:

At all times material to this indictment:

1. Garcia Grocery, located at 1327 Dyre Street in Philadelphia, Pennsylvania, was a business and corner grocery store engaged in and affecting interstate commerce by providing to customers tobacco products and other goods produced in, and purchased and transported from, other states to Pennsylvania.
2. On or about January 27, 2015, in Philadelphia, in the Eastern District of Pennsylvania, defendants

obstructed, delayed, and affected commerce and the movement of articles and commodities in commerce, and attempted to do so, by robbery, in that, defendants CARTER and WILLIAMS

unlawfully took and obtained, and aided and abetted the unlawful taking and obtaining of, money, from the Garcia Grocery located at 1327 Dyre Street, in Philadelphia, Pennsylvania, a business engaged in interstate commerce, against their will, by means of actual and threatened force, violence, and fear of injury, immediate and future to them and property in their possession, that is, by pointing loaded firearms at the employees of Garcia Grocery, and then demanding and stealing money at gunpoint.

In violation of Title 18, United States Code, Sections 1951(a) and 2.

COUNT TWO

THE GRAND JURY FURTHER CHARGES THAT:

On or about January 27, 2015, in Philadelphia, in the Eastern District of Pennsylvania, defendants

**DAVORIS CARTER and
RODNEY WILLIAMS**

used and carried, and aided and abetted the use and carrying of, firearms, that is, a 12 gauge Mossberg 500 shotgun, loaded with one live shot shell, one black Charter Arms .38 caliber special revolver, loaded with five rounds of ammunition, and one silver Clarke .22 caliber revolver, loaded with five rounds of ammunition, during and in relation to a crime of violence, that is, Hobbs Act robbery, as charged in Count One of this indictment, and brandished, aided and abetted the brandishing of, those firearms.

In violation of Title 18, United States Code, Sections 924(c) and 2.

NOTICE OF FORFEITURE

THE GRAND JURY FURTHER CHARGES THAT:

As a result of the violations of Title 18, United States Code, Section 924(c)(1) as set forth in this indictment, defendants

**DAVORIS CARTER, and
RODNEY WILLIAMS**

shall forfeit to the United States of America the firearms and ammunition involved in the commission of these offenses, that is,

- 1) a 12 gauge Mossberg 500 shotgun, loaded with one live shot shell;
- 2) one black Charter Arms .38 caliber special revolver, loaded with five rounds of ammunition; and,
- 3) one silver Clarke .22 caliber revolver.

All pursuant to Title 28, United States Code, Section 2461(c), and Title 18, United States Code, Section 924(d)(1).
