INDICTMENT

COUNT ONE

THE GRAND JURY CHARGES THAT:

On or about February 27,2015, in Lititz, in the Eastern District of Pennsylvania,
defendant

JEREMY HACHEY

knowingly received a visual depiction, that is a video file named „Chinese baby sucking
cock.3gp." using a means and facility of interstate commerce, and the production of these visual
depictions involved the use of minors engaging in sexually explicit conduct and the visual
depictions were of minors engaging in sexually explicit conduct.

In violation of Title 18, United States Code, Section 2252(a)(2).

COUNT TWO

THE GRAND JURY FURTHER CHARGES THAT:

On or about December 15, 2015, in Lititz, in the Eastern District of Pennsylvania,
defendant

JEREMY HACHEY

knowingly possessed one or more books, magazines, periodicals, films, video tapes and other matter, namely one computer hard drive, which contained visual depictions that had been shipped and transported in interstate and foreign commerce, and were produced using materials that had been mailed, shipped, and transported in interstate and foreign commerce. The production of these visual depictions involved the use of prepubescent minors engaging in sexually explicit conduct and the visual depictions were of prepubescent minors engaging in sexually explicit conduct.

In violation of Title 18, United States Code, Section 2252(a)(4)(B).

NOTICE OF FORFEITURE

As a result of the violations of Title 18, United States Code, Section 2252, set forth in this indictment, defendant

JEREMY HACHEY


shall forfeit to the United States, pursuant to Title 18, United States Code, Sections 2253(a)(1) and (a)(3), all visual depictions described in Title 18, United States Code Section 2252, and all property, real or personal, used or intended to be used to commit or promote the commission of the offenses of conviction, including but not limited to the following items that were seized from defendant on December 15, 2015:

- a. Child pornography images;
- b. One HP laptop computer bearing serial number 5CG3453SJQ and its components; and
- c. One CM Storm Tower bearing serial number SGC2000KKN11100100388 and its components.

All pursuant to Title 18, United States Code, Section 2253.
