

SETTLEMENT AGREEMENT

This Settlement Agreement (Agreement) is entered into between the United States of America, acting through the United States Department of Justice and on behalf of the Office of Inspector General (OIG-HHS) of the Department of Health and Human Services (HHS), (collectively the "United States"), and the Confederated Tribes of the Colville Reservation (collectively the "CCT") through each of its authorized representatives.

RECITALS

A. The CCT is a federally recognized, sovereign Indian tribe, with tribal offices located at Nespelem, Washington, on the Tribes' reservation. The CCT is comprised of more than 9,000 descendants of 12 aboriginal tribes of Native Americans. The CCT land base covers 1.4 million acres in north-central Washington, primarily within the areas of Okanogan and Ferry Counties. The CCT established a Behavioral Health Unit to serve the mental health needs of tribal members. The CCT also contracted a portion of its mental health services out to independent health care providers.

B. In furtherance of the goals of the Indian Health Care Improvement Act (IHCIA), 25 U.S.C. § 1601, *et seq.*, and to fulfill the United States' trust and treaty obligations to the CCT's members, the Secretary of HHS entered into a Title I Contract and Annual Funding Agreement with the CCT on a government-to-government basis to provide health and social services to tribal members and other eligible individuals pursuant to the Indian Self-Determination and Education Assistance Act, 25 U.S.C. § 450aaa, *et seq.* (ISDEAA).

C. The CCT is entitled to bill federal health care programs for services provided to tribal members and other eligible individuals under its ISDEAA Contract and Annual Funding Agreements with the Secretary and, independently, by the

IHCIA, 25 U.S.C. § 1641. Sections 1880 and 1911 of the Social Security Act require the Tribes' facilities to meet all the conditions and requirements for Medicare and Medicaid providers as a condition of billing for Medicare and Medicaid services.

D. The CCT held medical-provider contracts with the Washington State Medicaid Program. Through this contractual arrangement, the CCT submitted claims for reimbursement to Medicaid for services provided to eligible tribal members and their families under Medicaid Provider Number 1980812.

E. The United States contends that the CCT submitted, or caused to be submitted, claims for payment to Medicaid, Title XIX of the Social Security Act, 42 U.S.C. §§ 1396-1396w-5.

F. The United States contends that it has certain civil claims against the CCT arising from its submission of claims to Medicaid for the mental-health care services identified in Attachment A because the identified services were either not actually provided or were not medically reasonable and necessary. That conduct is referred to herein as the "Covered Conduct" and covers the claims for services submitted to Medicaid for payment from July 14, 2010, through December 13, 2010. Attachment A to this Agreement is incorporated into this Agreement by this reference.

G. This Agreement is neither an admission of liability by the CCT nor a concession by the United States that its claims are not well founded.

To avoid the delay, uncertainty, inconvenience, and expense of protracted litigation of the above claims, and in consideration of the mutual promises and obligations of this Settlement Agreement, the Parties agree and covenant as follows:

TERMS AND CONDITIONS

1. The CCT agrees to pay the United States the sum of Two Hundred

Forty-Five Thousand Eight Hundred Sixty Dollars (\$245,860) ("Settlement Amount") and this sum shall constitute a debt due and owed to the United States no later than five (5) days after the Effective Date of this Agreement. The Settlement Amount shall be paid by the CCT by electronic funds transfer pursuant to written instructions to be provided by the United States Attorney's Office for the Eastern District of Washington.

2. Subject to the exceptions in Paragraph 3 (concerning excluded claims) and conditioned upon the CCT's full payment of the Settlement Amount, the United States releases the CCT from any civil or administrative monetary claim the United States has for the Covered Conduct under the False Claims Act, 31 U.S.C. §§3729-3733; the Civil Monetary Penalties Law, 42 U.S.C. §§ 1320a-7a; the Program Fraud Civil Remedies Act, 31 U.S.C. §§ 3801-3812; or the common law theories of payment by mistake, unjust enrichment, and fraud.

3. In consideration of the obligations of the CCT in this Agreement and the Voluntary Tribal Compliance Agreement (VTCA), entered into between OIG-HHS and the CCT, and conditioned upon the CCT's full payment of the Settlement Amount, the OIG-HHS agrees to release and refrain from instituting, directing, or maintaining any administrative action seeking exclusion from Medicare, Medicaid, and other Federal health care programs (as defined in 42 U.S.C. § 1320a-7b(f)) against the CCT under 42 U.S.C. § 1320a-7a (Civil Monetary Penalties Law) or 42 U.S.C. § 1320a-7(b)(7) (permissive exclusion for fraud, kickbacks, and other prohibited activities) for the Covered Conduct, except as reserved in Paragraph 4 (concerning excluded claims) and as reserved in this Paragraph. The OIG-HHS expressly reserves all rights to comply with any statutory obligations to exclude the CCT from Medicare, Medicaid, and other federal health care programs under 42 U.S.C. § 1320a-7(a) (mandatory exclusion) based upon the Covered Conduct, and

the CCT explicitly reserves and does not waive any defenses and rights whatsoever, including administrative and judicial defenses and rights, that it may have in the event the OIG-HHS asserts such claims. Nothing in this Paragraph precludes the OIG-HHS from taking action against entities or persons, or for conduct and practices, for which claims have been reserved in Paragraph 4.

4. Notwithstanding the releases given in Paragraphs 2 and 3, or any other term of this Agreement, the following claims of the United States are specifically reserved and are not released:

- a. Any liability arising under Title 26, U.S. Code (Internal Revenue Code);
- b. Any criminal liability;
- c. Except as explicitly stated in this Agreement, any administrative liability, including mandatory exclusion from federal health care programs;
- d. Any liability to the United States (or its agencies) for any conduct other than the Covered Conduct;
- e. Any liability based upon obligations created by this Agreement;
- f. Any liability for express or implied warranty claims or other claims for defective or deficient products or services, including quality of goods and services;
- g. Any liability for failure to deliver goods or services due;
- h. Any liability for personal injury or property damage or for other consequential damages arising from the Covered Conduct;
- i. Any liability of individuals.

5. The CCT waives and shall not assert any defenses the CCT may have to any criminal prosecution or administrative action relating to the Covered Conduct

that may be based in whole or in part on a contention that, under the Double Jeopardy Clause in the Fifth Amendment of the Constitution, or under the Excessive Fines Clause in the Eighth Amendment of the Constitution, this Agreement bars a remedy sought in such criminal prosecution or administrative action. Nothing in this Paragraph or any other provision of this Agreement constitutes an agreement by the United States concerning the characterization of the Settlement Amount for purposes of the Internal Revenue laws, Title 26 of the United States Code.

6. The CCT fully and finally releases the United States, its agencies, officers, employees, servants, and agents from any claims (including attorney's fees, costs, and expenses of every kind and however denominated) that the CCT has asserted, could have asserted, or may assert in the future against the United States and its agencies, officers, employees, servants, and agents, related to the Covered Conduct and the United States' investigation and prosecution thereof.

7. The Settlement Amount shall not be decreased as a result of the denial of claims for payment now being withheld from payment by any Medicare contractor (e.g. Medicare Administrative Contractor, fiscal intermediary, carrier) or any state payer, related to the Covered Conduct; and the CCT agrees not to resubmit to any Medicare contractor or any state payer any previously denied claims related to the Covered Conduct, agrees not to appeal any such denials of claims, and agrees to withdraw any such pending appeals.

8. The CCT agrees to the following:

a. Unallowable Costs Defined: All costs (as defined in the Federal Acquisition Regulation, 48 C.F.R. § 31.205-47; in Titles XVIII and

XIX of the Social Security Act, 42 U.S.C. §§ 1395-1395kkk-1 and 1396-1396w-5; and the regulations and official program directives promulgated thereunder) incurred by or on behalf of the CCT, its present or former officers, directors, employees, shareholders, and agents in connection with:

- (1) the matters covered by this Agreement;
- (2) the United States' audit(s) and civil and any criminal investigation(s) of the matters covered by this Agreement;
- (3) the CCT's investigation, defense, and corrective actions undertaken in response to the United States' audit(s) and civil and any criminal investigation(s) in connection with the matters covered by this Agreement (including attorney's fees);
- (4) the negotiation and performance of this Agreement;
- (5) the payment the CCT makes to the United States pursuant to this Agreement; and
- (6) the negotiation of, and obligations undertaken pursuant to the VTCA to: (i) retain an independent review organization to perform annual reviews as described in the VTCA; and (ii) prepare and submit reports to the OIG-HHS;

are unallowable costs for government contracting purposes and under the Medicare Program, Medicaid Program, TRICARE Program, and Federal Employees Health Benefits Program (FEHBP) (hereinafter referred to as Unallowable Costs). However, nothing in paragraph 15.a(6) that may apply

to the obligations undertaken pursuant to the VTCA affects the status of costs that are not allowable based on any other authority applicable to the CCT.

b. Future Treatment of Unallowable Costs: Unallowable Costs shall be separately determined and accounted for by the CCT, and the CCT shall not charge such Unallowable Costs directly or indirectly to any contracts with the United States or any State Medicaid program, or seek payment for such Unallowable Costs through any cost report, cost statement, information statement, or payment request submitted by the CCT or any of its subsidiaries or affiliates to the Medicare, Medicaid, TRICARE, or FEHBP Programs.

c. Treatment of Unallowable Costs Previously Submitted for Payment: If applicable, the CCT further agrees that within 90 days of the Effective Date of this Agreement it shall identify to applicable Medicare and TRICARE fiscal intermediaries, carriers, and/or contractors, and Medicaid and FEHBP fiscal agents, any Unallowable Costs (as defined in this Paragraph) included in payments previously sought from the United States, or any State Medicaid program, including, but not limited to, payments sought in any cost reports, cost statements, information reports, or payment requests already submitted by the CCT or any of its subsidiaries or affiliates, and shall request, and agree, that such cost reports, cost statements, information reports, or payment requests, even if already settled, be adjusted to account for the effect of the inclusion of the unallowable costs. The CCT agrees that the United States, at a minimum, shall be entitled to recoup from the CCT any overpayment plus applicable interest and penalties as a result of the inclusion of such Unallowable Costs on

previously submitted cost reports, information reports, cost statements, or requests for payment.

Any payments due after the adjustments have been made shall be paid to the United States pursuant to the direction of the Department of Justice and/or the affected agencies. The United States reserves its rights to disagree with any calculations submitted by the CCT or any of its subsidiaries or affiliates on the effect of inclusion of Unallowable Costs (as defined in this Paragraph) on the CCT or any of its subsidiaries or affiliates' cost reports, cost statements, or information reports.

d. Waiver of Rights: Nothing in this Agreement shall constitute a waiver of the rights of the United States to audit, examine, or re-examine the CCT's books and records to determine that no Unallowable Costs have been claimed in accordance with the provisions of this Paragraph.

9. This Agreement is intended to be for the benefit of the Parties only. The Parties do not release any claims against any other person or entity, except to the extent provided for in Paragraph 10 (waiver for beneficiaries' paragraph), below.

10. The CCT agrees that it waives and shall not seek payment for any of the health care billings covered by this Agreement from any health care beneficiaries or their parents, sponsors, legally responsible individuals, or third party payors based upon the claims defined as Covered Conduct.

11. Each Party shall bear its own legal and other costs incurred in connection with this matter, including the preparation and performance of this Agreement.

12. Each party and signatory to this Agreement represents that it freely and voluntarily enters in to this Agreement without any degree of duress or compulsion.

13. This Agreement is governed by the laws of the United States. The exclusive jurisdiction and venue for any dispute relating to this Agreement is the United States District Court for the Eastern District of Washington. For purposes of construing this Agreement, this Agreement shall be deemed to have been drafted by all Parties to this Agreement and shall not, therefore, be construed against any Party for that reason in any subsequent dispute.

14. This Agreement constitutes the complete agreement between the Parties. This Agreement may not be amended except by written consent of the Parties.

15. The undersigned counsel represent and warrant that they are fully authorized to execute this Agreement on behalf of the persons and entities indicated below.

16. This Agreement may be executed in counterparts, each of which constitutes an original and all of which constitute one and the same Agreement.

17. This Agreement is binding on the CCT's successors, transferees, heirs, and assigns.

18. All parties consent to the United States' disclosure of this Agreement, and information about this Agreement, to the public.

19. This Agreement is effective on the date of signature of the last signatory to the Agreement (herein "Effective Date of this Agreement"). Facsimiles of


