<u>About the Office</u> :	The United States Attorney's Office represents the United States in criminal and civil actions in federal district court throughout the state of Idaho. It has offices in Boise, Pocatello, and Coeur d'Alene. The Civil Division has seven attorneys. It is based in Boise. The Criminal Division has approximately 22 attorneys, with attorneys in Boise, Coeur d'Alene, and Pocatello. This Special Assistant United States Attorney (Special AUSA) position is located in the Criminal Division, in the main office in Boise, Idaho. Boise is located in the Treasure Valley. The Special AUSA will be
	employed by the Ada County Prosecuting Attorney's Office. Although the Special AUSA will be officially employed by Ada County, the attorney will work in the U.S. Attorney's Office in Boise and will work exclusively on federal criminal cases in U.S. District Court.
<u>Responsibilities and</u> <u>Opportunity Offered</u> :	This position will be in the Criminal Division in Boise. The selected applicant will be responsible for handling a heavy criminal caseload prosecuting drug trafficking organizations operating in Ada and Canyon Counties, using a broad array of federal criminal statutes, including distribution of drugs, possession with intent to distribute drugs, drug conspiracy, maintaining drug-involved premises, possession of firearms in furtherance of drug trafficking crimes, money laundering, continuing criminal enterprises, and asset forfeiture.
	This position is funded by the High Intensity Drug Trafficking Areas (HIDTA) program. The program was created by Congress in the Anti-Drug Abuse Act of 1988. It provides assistance to federal, state, local, and tribal law enforcement agencies operating in areas determined to be critical drug-trafficking regions of the United States. HIDTA has funded the position through the Ada County Prosecuting Attorney's Office.
Qualifications:	<u>Required qualifications</u> : Applicants must possess a J.D. degree, be an active member of the Idaho State Bar, and have at least two years post-J.D. experience.
	<u>Preferred qualifications</u> : Ideally, an applicant will have: a record of academic excellence, demonstrated commitment to public service, experience as a federal or state law clerk, three to seven years of experience as a prosecutor, a strong desire to practice in Idaho, and experience planning and executing case strategy. In addition, the ideal applicant will demonstrate superior written and oral communication skills, superior research skills, and a demonstrated ability to work well

	with others, including support staff, peers, investigative agents, and supervisors.
<u>Travel</u> :	Occasional travel is required, both within and outside the District of Idaho.
<u>Type of Position</u> :	This position, which is dependent on HIDTA funding, may be for a term up to three years but may extend beyond that, at the discretion of the U.S. Attorney's Office and Ada County Prosecutor's Office. Presently, funding for two years is authorized with funding available through the close of calendar year 2024. Beyond that, additional funding will be requested, but is not yet authorized.
Salary Information:	Pay will be determined, in part, based on the number years of attorney experience. The range of pay is \$85,000 to \$100,000.
<u>Status</u> :	Full-time with benefits

Relocation Expenses:	Relocation expenses will not be authorized.
