



An ERT Casebook, which is a typed version of the handwritten paperwork, was created after leaving the scene. The original was placed into a 1A envelope and a copy is attached hereto.

Digital photographs were taken by Timothy Swec, Courtney Pillsbury and Alicia Duff and were archived to DVD by Meredith Burke. The original and a backup were placed into a 1A envelope and maintained in the case file. A photographic log was prepared and is included in the 1A envelope.

On 7/06/2011, 26 pieces of evidence were recovered from the search.

A copy of the search warrant was signed by all law enforcement personnel entering the search location and is included in the 1A envelope.




