On July 6, 2011, DR. REZA RAY EHSAN was interviewed at his place of business, West LA Urgent Care, 11600 Venice Blvd., Los Angeles, California. After being advised of the identities of the interviewing agents and the nature and purpose of the interview DR. EHSAN related the following information:

BULGER had a temper and would push the nurses around. BULGER introduced his wife CAROL as his girl. EHSAN later found that BULGER lived in Santa Monica. BULGER liked the clinic because it was clean. BULGER told EHSAN, "You run a clean place, I like to come to you." BULGER came to the clinic alone on his first visit. BULGER brought CAROL on his 2nd visit. She had blue eyes and was pretty for an older lady. CAROL told EHSAN that she had issues for health care.

EHSAN suggested a cortisone shot, which BULGER did not want to get. BULGER told EHSAN that he was scared of needles. The shot cost \$160 so it was not the money BULGER was concerned about.
