AFFIDAVIT IN SUPPORT OF APPLICATION FOR CRIMINAL COMPLAINT

I, Special Agent Eric D. Poalino, having been sworn, state:

INTRODUCTION AND AGENT BACKGROUND

- I am a Special Agent with the Federal Bureau of Investigation ("FBI") and have been since June 2021. I am currently assigned to the Boston Field Office, North Shore Gang Task Force ("FBI Task Force"). The primary mission of the FBI Task Force is to identify, investigate, disrupt, and dismantle violent criminal organizations operating in cities north of Boston. My responsibilities include the investigation of possible violations of federal law, including illegal possession/transfer of firearms, firearms trafficking, narcotics trafficking, and violent crimes involving firearms and narcotics trafficking. I have received training and experience in various aspects of criminal law and procedure, including electronic and physical surveillance, interrogations, stops, searches, seizures, and arrests for a variety of criminal offenses. Through my training, knowledge, and experience, I have become familiar with the habits, methods, routines, practices and procedures commonly employed by persons engaged in the use and trafficking of illegal firearms and narcotics, including persons involved in criminal organizations. My investigations have included the use of surveillance techniques and the execution of search, seizure, and arrest warrants.
- 2. I have written and/or participated in the execution of numerous search warrants resulting in the seizure of controlled substances and paraphernalia involved in the manufacture and distribution of controlled substances; United States currency, records of narcotics and monetary transactions, drug customer lists and other documents relating to the manufacturing, transportation, ordering, purchasing and distribution of controlled substances, as well as the collection, expenditure, accounting, transportation, and laundering of drug proceeds. I have participated in the debriefing of numerous defendants, informants and witnesses who had personal knowledge regarding large-scale narcotics trafficking organizations. I have participated in all aspects of drug investigations including conducting surveillance, executing searches pursuant to court-ordered search warrants, executing arrests, and participating in court-authorized Title III wiretaps of cellular phones. I have received extensive specialized training in the field of controlled substance identification, investigation and enforcement. Based on my training and experience, I am familiar

with narcotics traffickers' methods of operation, including methods used by them to distribute, store and transport narcotics and to collect, expend, account for, transport, and launder drug proceeds.

- 3. All dates, time and amounts set forth in this affidavit are approximate. Because this affidavit is being submitted for the limited purpose of securing the requested search warrants, I have not included each and every fact known to me concerning this investigation. I make this affidavit based upon personal knowledge derived from my participation in this investigation and upon information (whether received directly or indirectly) that I believe to be reliable from numerous sources including, but not limited to, the following:
 - a. My training and experience investigating drug trafficking, violent crimes, and money laundering crimes;
 - b. Oral reports, written reports, and documents that I have received from other federal, state, and local law enforcement agents;
 - c. Physical and electronic surveillance conducted by me and other federal, state, and local law enforcement officers;
 - d. Confidential sources of information (referred to as CI and their #) and cooperating witnesses (referred to by CW and their #);
 - e. Public records;
 - f. Business records;
 - g. Telephone toll records, pen register and trap and trace information, and telephone subscriber information;
 - h. Precise location information for cellular telephones;
 - i. Queries of law enforcement records and intelligence databases;
 - j. Execution of search warrants;
 - k. Social media postings, videos and images;
 - 1. Review of data and information obtained by Search Warrants;
 - m. Review of cellular phones searched and seized during this investigation; and
 - i. Arrests of co-conspirators.

I. PURPOSE OF AFFIDAVIT AND BACKGROUND

- 2. I make this affidavit in support of an application for Criminal Complaint charging HARVEY RODRIGUEZ, A/K/A "BIG OPP" with the following: Count One, from a period of approximately January 2020 through December 2024, Conspiracy to Manufacture, Distribute, and Possess with Intent to Distribute, Controlled Substances, in violation of 21 U.S.C. § 846. Based on this information set forth in this affidavit, there is probable cause to believe that RODRIGUEZ and multiple other individuals conspired to distribute controlled substances and possess controlled substances with intent to distribute, in violation of 21 U.S.C. § 846.
- 3. I also make this affidavit in support of a second count charging RODRIGUEZ with Conspiracy to Interfere with Commerce by Robbery, relating to an armed home invasion robbery that took place on or about January 30, 2023, in Woburn, Massachusetts, that targeted a drug customer of RODRIGUEZ. During the home invasion robbery, RODRIGUEZ and multiple coconspirators robbed the victim of over \$20,000 of drug proceeds at gunpoint. Based on this information set forth in this affidavit, there is probable cause to believe that RODRIGUEZ, and multiple other individuals conspired to interfere with commerce by robbery (Conspiracy to Commit Hobbs Act Robbery), in violation of 18 U.S.C. § 1951(a).
- 4. I am familiar with Harvey RODRIGUEZ, a/k/a "Big Opp," who has a date of birth of xx/xx/1996. RODRIGUEZ is the leader of the Big Opp Entertainment, or Brothers Over Everything, otherwise known as the BOE criminal enterprise. RODRIGUEZ is known to be a distributor of pressed fentanyl pills, fentanyl, pressed methamphetamine pills, cocaine, and is known to have conducted at least one armed robbery. RODRIGUEZ has a number of prior arrests but no convictions. A photograph of RODRIGUEZ follows:



- 5. With respect to the charged drug conspiracy in Count One, I note that at least four specific drug transactions have been conducted over the course of this investigation where RODRIGUEZ and his coconspirators, including known coconspirators whose identity I am omitting but who I will refer to as CC-1 and CC-2, sold drugs to confidential informants or cooperating witnesses on recording. One such transaction involved CC-2 who delivered drugs in accordance with a transaction that a cooperating witness had negotiated with RODRIGUEZ. These four controlled purchases are in addition to the numerous instances of manufacturing and transactions reflected in digital evidence such as text messages and photographs and videos or described by cooperating witnesses as having taken place historically. Those controlled purchases can be summarized as follows:
 - a. RODRIGUEZ and CC-2: on or about December 11, 2023, where CC-2 provided a cooperating witness with over 275 grams of counterfeit Adderall pills continuing methamphetamine, from a transaction arranged with RODRIGUEZ.
 - b. RODRIGUEZ: on or about December 12, 2023, where RODRIGUEZ provided a cooperating witness with over 275 grams of counterfeit Adderall pills continuing methamphetamine.
 - c. RODRIGUEZ: on or about June 18, 2024, where RODRIGUEZ provided a cooperating witness with over 220 grams of cocaine.

d. RODRIGUEZ: on or about June 26, 2024, where RODRIGUEZ provided a cooperating witness with over 80 grams of counterfeit Percocet pills continuing fenantly.

II. BASIS FOR PROBABLE CAUSE

A. HISTORICAL PILL MANUFACTURING IN ESSEX COUNTY

- 6. The FBI NSGTF continues to investigate various ongoing criminal enterprises in areas north of Boston. That investigation continues to focus on large-scale drug trafficking and pill manufacturers, including those related to traffickers who were identified and targeted during prior investigations, including Schuyler OPPENHEIMER, a/k/a "SK", Vincent CARUSO, a/k/a "Fatz", Lawrence Michael NAGLE, a/k/a "Mikey", and Harvey RODRIGUEZ, a/k/a "Big Opp." According to multiple cooperating witnesses, OPPENHEIMER, RODRIGUEZ, CARUSO, and NAGLE were historically linked and aligned in the manufacturing of counterfeit Percocet pills containing fentanyl during the period of approximately 2018 through early 2020 in the Saugus and Lynn areas of Massachusetts. At the time, the clandestine manufacture of counterfeit prescription pills containing fentanyl through the use of desktop pill presses was a relatively new phenomenon and drug users were willing to pay over \$10 per counterfeit pill, based on the novelty of counterfeit pills and common misperception that the pills were in fact authentic.
- 7. In January 2020, Massachusetts State Police (MSP) executed a series of search warrants at multiple townhouses on Founders Way in Saugus, Massachusetts that were used as manufacturing and distribution locations by RODRIGUEZ, CARUSO and other conspirators. Following these search warrants, the group largely discontinued working together in the same manner. CARUSO, in particular, believed that an individual named DAVID MARTINEZ, a/k/a "40" was the confidential informant referred to in a search warrant affidavit submitted by MSP and that MARTINEZ was therefore responsible for the January 2020, raids. I am aware from my investigation that this belief was the product of CARUSO's lawyer reviewing discovery materials produced in the Saugus case. MARTINEZ is also believed to have been a familial relation of RODRIGUEZ.

- 8. I am aware from review of police reports and publicly reported information that DAVID MARTINEZ and a second individual were shot and killed in Charlestown, Massachusetts, in September 2020. Data from cellular phones recovered from the crime scene and phones seized during the CARUSO investigation have been reviewed by investigators. I know from the review of those devices that MARTINEZ and CARUSO exchanged threats over the phone in the days prior to MARTINEZ's murder. Additionally, in MARTINEZ's cellular phone there was a recording made by MARTINEZ that captured a phone call between MARTINEZ and CARUSO's lawyer on the pending Saugus case, where MARTINEZ accuses the lawyer of identifying him as the confidential informant. During the recording, the lawyer denies being responsible. Separately, CARUSO is also known to have claimed to have paid "40 for 40", meaning he had paid \$40,000 to procure the murder of "40", which was MARTINEZ's street name.
- 9. Apart from no longer working together, the group also threatened to commit and actually has committed violence against each other. For example, following the murder of MARTINEZ, it is believed that RODRIGUEZ placed a \$100,000 bounty on the head of CARUSO and CARUSO's associate ERNEST JOHNSON, a/k/a "Yo Pesci." JOHNSON in fact made a number of public social media posts regarding the bounty. This supposed bounty being placed was prompted by RODRIGUEZ's belief that CARUSO was responsible for procuring the death of MARTINEZ. Additionally, following a verbal dispute between CARUSO and NAGLE, CARUSO orchestrated the gunpoint robbery of NAGLE in May 2021, outside of his residence in Saugus, Massachusetts. Additionally, I am aware that OPPENHEIMER punched Lawrence Michael NAGLE's brother, Christopher NAGLE, a/k/a "CUDA", who was also charged in the NAGLE drug case.
- 10. Apart from RODRIGUEZ, each leader of this North Shore Pill Collective has been federally investigated, charged, and prosecuted. Though CARUSO and NAGLE are believed to have stopped directly working with the overall group at the time, as I will discuss RODRIGUEZ and OPPENHEIMER are known to have continued to work together with respect to the manufacturing and distribution of controlled substances in 2022, 2023, and 2024.

B. RODRIGUEZ AND BROTHERS OVER EVERYTHING

- 11. RODRIGUEZ is the leader and organizer of a street gang and criminal enterprise known as "BOE", which means "Brothers Over Everything" and also "Big Opp Entertainment." BOE is known to distribute fentanyl and cocaine and possess numerous firearms, including fully-automatic handguns with selector switch attachments. Through this investigation, I have confirmed that BOE members possess firearms, distribute controlled substances, and engage in violent criminal acts.
- 12. BOE is purported to be structured around the creation of rap music and promotes itself publicly through a secondary and more public-facing meaning of the acronym as a rap label known as "Big Opp Entertainment" (named for RODRIGUEZ). Though purportedly for legitimate commercial ends, the members of BOE are in fact engaged in the commission of the drug and firearm offenses. This BOE enterprise does in fact further the musical endeavors of associated BOE members and provide a putative lawful source of income and a means to invest drug proceeds. Of note, one individual who I will refer to as Coconspirator 1 (or "CC-1") is a rap artist and is known to be affiliated with Big Opp Entertainment. Indeed, BOE is known to have invested substantial drug proceeds into a diamond-encrusted chain that depicts the acronym BOE. A public facing Instagram of CC-1 contains a photograph promoting BOE and CC-1's rap album, in which the "BOE" chain can be observed and the neck tattoo of CC-1 can be seen. In fact, OPPENHEIMER can be seen commenting on this post. Investigators know that RODRIGUEZ would lend the BOE chain to CC-1 in order to promote the label and its music. It is my understanding that BOE has been in fact sold due to recent financial difficulties faced by RODRIGUEZ.



- 13. BOE has a symbol associated with it that is a bullseye with crosshairs. Multiple members and associates of BOE have this target logo tattooed on their body, and their neck in particular to signify their membership in the gang. The BOE diamond studded chain contains an arrow hitting the target of the "O" further demonstrating the use of this symbol.
- 14. There does not appear to be a formal leadership structure of BOE, apart from Harvey RODRIGUEZ, a/k/a "Big Opp," who directs the manufacturing of controlled substances, and has a source of supply for fentanyl and cocaine. Based on his control over the distribution of controlled substances, and the gang being largely reflective of his street name ("Big Opp Entertainment"), RODRIGUEZ is believed to be the leader of BOE and other members fall under him. Due to his position, I believe that other lower-level members of BOE serve as his runners and drug distributors, thereby insulating him from threats and law enforcement interdiction. Multiple sources of information have described lower-level and juvenile associates of BOE holding drugs and firearms for RODRIGUEZ in order to commit violence and deal drugs on his behalf, and to take charges in the event of law enforcement locating the weapon.

- 15. I am familiar with one such incident involving a juvenile taking place in June 2023. In this incident, Harvey RODRIGUEZ was charged with causing a minor to distribute drugs. *See* Lynn District Court, Docket No. 2313CR001831. Investigators reviewed the related Lynn Police Reports for these charges, and they can be summarized as follows:
 - a. On June 13, 2023, RODRIGUEZ and a juvenile male were in a vehicle outside of the recording studio in Lynn, and they were stopped for operating a motor vehicle with a suspended registration. The juvenile was observed with commercially packaged marijuana in his pocket. It was illegal for him to be in possession as a juvenile so an officer conducted a frisk search of the subject. The officer found a 2.5 inch folding knife and multiple packages of marijuana stored in sandwich bags hidden in the juvenile's underwear. When the officer explained to RODRIGUEZ that they were arresting the juvenile for being a minor in possession of a controlled substance, RODRIGUEZ claimed the drugs were his. Officers subsequently arrested RODRIGUEZ.

C. HISTORICAL DRUG DISTRIBUTION

- 1. CW-5
- 16. In April 2021, May 2021, and June 2022, CW-5¹ provided information regarding CARUSO, OPPENHEIMER and RODRIGUEZ.
 - a. CW-5 described an individual, later identified as OPPENHEIMER, as being associated with Vincent CARUSO, a/k/a "Fatz", when CARUSO was residing in Saugus. CW-5 stated that OPPENHEIMER would put switches on firearms for Vincent CARUSO. CW-5 also stated that OPPENHEIMER put CARUSO's automated press together and would fix CARUSO's pill press when CARUSO's operation was located in Saugus.



- b. CW-5 also provided information related to the historical association of Harvey RODRIGUEZ, Vincent CARUSO, Schuyler OPPENHEIMER, and NAGLE, when CARUSO's DTO was based in Saugus, Massachusetts. CW-5 stated that Harvey LNU (identified to be RODRIGUEZ), was a neighbor of CARUSO in Saugus. CW-5 stated that Harvey manufactured and distributed cocaine and Xanax.²
- 17. Investigators reviewed the extraction of a cellular phone seized from CW-5 and noted a conversation with OPPENHEIMER over Instagram using the Instagram account "sdot_k" on January 8, 2020, which was the day when Vincent CARUSO's operation in Saugus was subject to a search warrant executed by Massachusetts State Police. CW-5 communicated with OPPENHEIMER and told OPPENHEIMER to call him ASAP and identified himself as Vinny's friend and that "They", likely referring to the CARUSO Drug Trafficking Organization, instructed CW-5 to contact OPPENHEIMER.

2. CW-27

- 18. In August and September 2021, Agents from the Drug Enforcement Administration (DEA) interviewed an individual whose identity is known to me who I will refer to as CW-27.³ In sum and substance, CW-27 provided the following pertinent information:
 - a. CW-27 described working for an individual known to investigators to be Harvey RODRIGUEZ, a/k/a "Big Opp", distributing pressed fentanyl pills. CW-27 went on to say that RODRIGUEZ produces a large amount of blue counterfeit Percocet pills, and that CW-27 can produce 250,000 pills in five days. CW-27 stated that the presses used

² This information was corroborated as MSP executed a search warrant at RODRIGUEZ's residence next door to CARUSO's shortly after searching CARUSO's residence. CW-15 was interviewed by investigators in August 2021, and CW-15 provided information that CW-15 was the listed tenant for the apartment that "Harvey" resided in at the complex. V. CARUSO lived at Founders' Way for approximately one year before moving out. CW-15 stated that "HARVEY" (in fact, HARVEY RODRIGUEZ) lived there for about six months and paid the rent while the apartment was in CW-15's name. Vincent CARUSO was the one who arranged for CW-15 to rent the apartment for "HARVEY". CW-15 stated that Vincent CARUSO filled out the application on CW-15's behalf. I know from review of reports that CW-15 rented unit 2001, which was actually occupied by RODRIGUEZ, and V. CARUSO rented unit 2002, which was nearby.

by RODRIGUEZ were kept in a house in a central Massachusetts, but CW-27 believed the house is currently vacant. CW-27 stated that CW-27 knows of at least two pill press machines utilized by RODRIGUEZ.

- b. CW-27 stated that one of the pill press machines is always with "SK" (known to investigators to be Schuyler OPPENHEIMER). CW-27 described the pill presses as portable, but they are extremely heavy and require at least two people to be moved. CW-27 did not know where RODRIGUEZ purchased the pill press machines, but they might have been purchased through Vinny CARUSO, aka "Fatz," since they lived next to each other in Saugus. CW-27 explained that RODRIGUEZ and CARUSO sold Xanax pills together which resulted in a raid in Saugus in 2020. Investigators know from review of records from the State Police investigation that this information is accurate.
- c. CW-27 stated that RODRIGUEZ produces the pills with "SK" (OPPENHEIMER) and an individual known to CW-27 as "Drac" and that they stay up all night and day to make a batch of pills. CW-27 further stated that when RODRIGUEZ, "Drac", and OPPENHEIMER are together at the same time then they are more than likely producing pills. CW-27 believed the pills were Oxycontin and did not realize they were fentanyl pills until CW-27 met "Drac". CW-27 further stated that Drac was the source of supply for the fentanyl and that they were purchasing fentanyl for \$40,000.00 USD per kilogram, which yielded 250,000 pills. CW-27 stated that each pill was sold for a minimum of \$4.00 each. CW-27 further stated that Drac was RODRIGUEZ's fentanyl source of supply and is connected to a Mexican Cartel.
- d. CW-27 stated that RODRIGUEZ has a boss above him who is ultimately in charge and is a millionaire. CW-27 stated that RODRIGUEZ has told him about this "boss" on several occasions but has never met this "boss". CW-27 further explained that RODRIGUEZ has never met the unknown male in person either and that RODRIGUEZ was introduced to him through CARUSO.
- 19. I am aware that the time frame of the operation described by CW-27 was during 2020 through 2021.

D. JANUARY 30, 2023, HOBBS ACT ROBBERY

20. In January 2024, investigators interviewed an individual I will refer to as VICTIM-2. VICTIM-2 was initially interviewed with the promise that the information provided would not be used against VICTIM-2. Subsequently, VICTIM-2 has been accorded immunity in exchange for continued cooperation and truthful testimony. Later, investigators also interviewed CW-32 concerning this robbery.⁴

- During the interview, VICTIM-2 described being robbed during a transaction where he intended to purchase a kilogram of cocaine from an individual, who was later identified by investigators as RODRIGUEZ. VICTIM-2 described being robbed of approximately \$25,000 in cash that was itself derived from VICTIM-2 drug distribution activities and the sales derived from a kilogram of cocaine. VICTIM-2 had purchased from an individual identified to be RODRIGUEZ in December 2024. One of the robbers, CW-32, was well known to VICTIM-2. CW-32 and VICTIM-2 had known each other for several years and VICTIM-2 would sometimes sell drugs to CW-32. In December 2022, CW-32 offered to sell VICTIM-2 a kilogram of cocaine in exchange for \$25,000.
- 22. During the evening hours on or about December 19, 2022, CW-32 and RODRIGUEZ delivered a kilogram of cocaine to VICTIM-2 at VICTIM-2's apartment. RODRIGUEZ remained in a mask and long jacket and his face was not visible to VICTIM-2. VICTIM-2 was not able to identify RODRIGUEZ as the source of the kilogram. However, the investigation identified RODRIGUEZ as the source through review of cellular phones and text messages concerning the transaction and information provided by CW-32. This transaction is captured in text messages between RODRIGUEZ and CW-32. The transaction was completed: RODRIGUEZ arrived at VICTIM-2's apartment and provided a kilogram of cocaine in exchange for an amount of cash in excess of \$20,000.
- 23. In January 2023, VICTIM-2 arranged with CW-32 to buy a second kilogram of cocaine for another \$25,000. During the evening hours on or about January 30, 2023, CW-2 arrived and accessed VICTIM-2's apartment with a pin code provided by VICTIM-2 to CW-32. VICTIM-2's girlfriend at the time was on the balcony grilling. The balcony door as well as the balcony's curtain were both closed.

VICTIM-2 had previously placed the approximately \$25,000 in an unmarked soft black lunch box which was on the living room coffee table. CW-32 counted the money in the lunch box and once the count was complete, CW-2 placed the money back in the lunch box. CW-2 then advised VICTIM-2 that CW-2's source was going to drop off the kilogram of cocaine.

- 24. CW-32 subsequently departed the apartment in order to allegedly retrieve the cocaine from their associate. Shortly thereafter, two males "bum rushed" VICTIM-2's apartment, each pointing firearms at VICTIM-2. VICTIM-2 stated they are familiar with firearms and believed both guns were semiautomatic, Glock pistols. VICTIM-2 did not know the identity of RODRIGUEZ but recognized the individual to be the same person who accompanied CW-32 during the previous cocaine sale. VICTIM-2 did not know the identity of the second armed gunman, but I know this person to be CLAUDIO MELO based on multiple witnesses identifying MELO as a participant in this robbery.
- 25. In a forceful and threatening manner and while continuing to point their firearms at VICTIM-2, RODRIGUEZ and MELO demanded to know where VICTIM-2's money was. VICTIM-2 indicated the black lunch box and told the robbers to take it. CW-32 had reentered the apartment and was seemingly pretending to be surprised by the robbery. VICTIM-2 took the robbers to another room to open his empty safe and when they returned to the living area CW-32 had already left. Shortly thereafter both robbers departed.
- 26. In addition to CW-32 and MELO, another cooperating witness, CW-34,⁶ was the fourth member of the conspiracy to rob VICTIM-2. CW-34 was interviewed on multiple occasions and provided

⁵ VICTIM-2 admitted that this money was proceeds from the sale of drugs, including the previous obtained kilogram of cocaine.

information to investigators concerning the robbery of VICTIM-2. CW-34 provided the following information:

- a. On the day of the robbery CW-32, CW-34, MELO, and RODRIGUEZ, met at RODRIGUEZ's apartment in Stoneham, MA to stage for the criminal act. CW-34 had previously overheard CW-32 on the phone with others talking about the robbery and knew that it had been planned in advance. Prior to the robbery, all of the conspirators were aware that the plan was to rob VICTIM-2 of cash that VICTIM-2 had obtained from the sale of cocaine and other drugs and was intending to buy cocaine.
- b. Later the funds were split between RODRIGUEZ, MELO, and CW-32 at RODRIGUEZ's Stoneham apartment where they met before the robbery. I know from this investigation that around the time of the robbery RODRIGUEZ was living at Alta Clara Apartments located at 21 Executive Drive, Stoneham, MA under the fraudulent identity. The property manager at that address was familiar with RODRIGUEZ from numerous interactions. The property manager retrieved a photocopy of the tenant's driver's license and confirmed that the individual pictured was not the occupant he knew. I then showed him an RMV picture of RODRIGUEZ who he identified as the person who had rented the apartment. I believe that the Alta Clara address used by RODRIGUEZ was the same address he used to plan and facilitate the robbery. CW-34 believed that approximately \$24,000-\$26,000 was stolen. CW-34 knew that CW-32 received approximately \$3,000-\$4,000 and the rest was split between RODRIGUEZ and CW-34.
- 27. In summary, of the five individuals that were involved in the robbery (CW-32, MELO, RODRIGUEZ, CW-34, and VICTIM-2), investigators have interviewed at least three. Each individual was interviewed separately, and each individual was not aware that other interviews concerning this particular crime were conducted. I have found the information that they each individually provided corroborates and is corroborated by the information I received from the other cooperators. Furthermore, at least two of the coconspirators (CW-32 and CW-34) identified RODRIGUEZ as one of the armed men that stole approximately \$25,000 of drug buy money from VICTIM-2 at gun point with MELO.



E. DECEMBER 11, 2023 CONTROLLED BUY OF METHAMPHETAMINE


28. On December 11, 2023, CW 7 conducted a controlled purchase of methamphetamine pills from RODRIGUEZ and the BOE Enterprise. This transaction was audio-video recorded and conducted




while under surveillance of investigators. Specifically, CW- arranged for the purchase of 1,000 counterfeit Adderall pills believed to contain methamphetamine from Harvey RODRIGUEZ. RODRIGUEZ used a phone number ending in 0631 (hereafter, the 0631 number) to coordinate the transaction with CW. This sale was arranged over text message communications that were preserved. Screenshots of the coordination for the meeting follow:









F. DECEMBER 12, 2023 CONTROLLED BUY OF METHAMPHETAMINE

31. On December 12, 2023, CW— scheduled a second purchase of 1,000 methamphetamine pills from RODRIGUEZ in exchange for \$700. The transaction was audio and video recorded and I have reviewed those recordings. CW— contacted RODRIGUEZ on the 0631 number and continued to communicate with RODRIGUEZ on the 0631 number throughout the transaction. CW— received instructions from RODRIGUEZ to meet again at the Burlington Mall. Screenshots of these text messages follow:



32. CW— met RODRIGUEZ inside of the mall which is equipped with CCTV cameras. Two investigators were also inside the mall on foot in order to continue surveillance. At approximately 4:25 PM, RODRIGUEZ instructed CW— to enter the mall and then directed them to the bathroom. After meeting in the bathroom to conduct the deal, CW— and RODRIGUEZ proceed to walk around the mall. The meeting of CW— and RODRIGUEZ was observed by physical surveillance, CCTV, and other audio/visual recording equipment. RODRIGUEZ was observed wearing a black mask, black puffer jacket, and red pants. A screenshot of RODRIGUEZ from CCTV footage follows (CW— was walking with RODRIGUEZ at the time and they have been edited out in order to protect their identity.):



33. After CW— departed and was met by investigators, RODRIGUEZ remained in the mall for some time while under surveillance by other investigators. At approximately 5:07 PM, RODRIGUEZ exited the mall and was observed walking down the sidewalk near the Cheesecake Factory. RODRIGUEZ then entered a silver Toyota Camry where he pulled his mask down revealing his face. Investigators took a photograph of RODRIGUEZ at the moment when he lowered his mask. I am familiar with the likeness of RODRIGUEZ and know that to be him. A photograph of RODRIGUEZ sitting in the vehicle after the transaction follows:



34. The counterfeit Adderall pills purchased on December 12, 2023, received initial examination at FBI Boston headquarters. The pills weighed 277 grams and field-tested positive for methamphetamine with a Thermoscientific TruNarc Analyzer. The drugs were then sent to the DEA Laboratory and determined to weigh 275.9 grams and contain methamphetamine. A photo of the seized drugs on a scale follows:




G. JUNE 18, 2024 CONTROLLED BUY OF COCAINE

35. On June 18, 2024, CI—8 coordinated the purchase of 250 grams of cocaine from Harvey RODRIGUEZ. This transaction was surveilled by the FBI using both physical and electronic means, including live monitoring of an audio-video recording device carried by CI— during the controlled buy. Investigators both live monitored the recording as it was generated and reviewed the recording after the



completion of the controlled buy. CI— was also debriefed and provided information about the controlled purchase that was consistent with what investigators saw and heard on the recording. Prior to the controlled purchase, CI— was searched for contraband and currency with negative results. CI— was then provided with an amount of U.S. currency in order to purchase the 250 grams of cocaine from RODRIGUEZ. The controlled purchase can be summarized as follows:

- 36. On June 18, 2024, CI— met with RODRIGUEZ and RODRIGUEZ's associate (the ASSOC.) in the vicinity of Washington St, Dorchester, MA. After waiting in the area for some time, investigators observed CI—, ASSOC., and RODRIGUEZ enter a gray Honda CRV which investigators knew to be an Uber. Investigators maintained surveillance of the vehicle until it dropped all three passengers off in the vicinity of Street, Cambridge, MA. RODRIGUEZ told ASSOC. and CI— that RODRIGUEZ was going to meet with his drug supplier and instructed CI-42 and ASSOC. to wait on the street until RODRIGUEZ returned.
 - a. At approximately 6:21 PM, RODRIGUEZ was observed speaking on his phone before leaving Buckingham Street via Healy Street. Healy Street is relatively short and connects Buckingham and Parker Streets.
 - b. At approximately 6:25 PM RODRIGUEZ was observed standing in front of Street and Schuyler OPPENHEIMER could be seen at the mouth of the alley between Parker and Parker. 32-38 Parker Street is a large single structure condominium with two front doors. When facing the building, the left door is marked and the right door is marked Investigators lost sight of both individuals but noted that they did not enter the front doors of Parker Street. Investigators believe that both OPPENHEIMER and RODRIGUEZ went down the alley between Parker and Parker before entering the rear of Parker Street
 - c. About 30 minutes later, at approximately 6:57 PM RODRIGUEZ was seen emerging from the alley and walking back towards the direction of ASSOC. and CI-42. A photograph taken by investigators conducting surveillance of RODRIGUEZ follows RODRIGUEZ can be observed with heavily laden pockets crossing Parker Street follows:



37. RODRIGUEZ returned to ASSOC. and CI— where RODRIGUEZ apologized for the long wait and mentioned that his drug supplier (referring to OPPENHEIMER) makes his associates turn off their phones as a security measure against law enforcement detection. In the recording, RODRIGUEZ can be seen pulling a package of white substances secured in clear plastic bags out of his right pocket before giving them into the possession of CI—. Screenshots of the recording showing RODRIGUEZ's face and then the package of cocaine in his hand follow:



38. At approximately 7:34 PM, RODRIGUEZ, ASSOC. and CI—separately departed the area. Investigators met with CI—where investigators took possession of the purchased drugs. Investigators took the drug evidence purchased from RODRIGUEZ and OPPENHEIMER and determined the weight to be approximately 245.2 grams before adding additional evidence packaging. Investigators also field tested the white rock like substance which tested positive for Cocaine. The drugs were later tested by the DEA laboratory and determined the substance weighed 222 grams and contained cocaine.

H. JUNE 26, 2024, CONTROLLED BUY OF FENTANYL

- 39. On June 26, 2024, at the direction of investigators, CI— facilitated a controlled drug purchase in which they obtained approximately 1,000 fentanyl pills in exchange for an amount of money. The transaction was arranged through RODRIGUEZ. The transaction was audio and video recorded.
- 40. At approximately 3:40 pm RODRIGUEZ was observed outside of Road with green pants and a ponytail hair style. RODRIGUEZ entered a Nissan Altima with Florida license plate with two other unidentified individuals. The Altima and passengers then proceeded to Avenue Woburn, MA where it arrived around 4:55 pm. CI-42 joined the RODRIGUEZ and the unidentified males who began walking around. Photos of RODRIGUEZ with a ponytail and green pants at the drug buy follow:





41. Eventually RODRIGUEZ, the unidentified males, and CI—returned to the Nissan Altima. At 5:15 PM, a Honda Accord parked near the subjects and RODRIGUEZ exited the Altima and entered the Accord. The Accord then traveled down the parking area where it stopped near a Chevrolet Malibu. The driver of the Accord got into the Malibu for approximately one minute then returned to the Accord. The Accord then drove back to the Altima where RODRIGUEZ exited and reentered the Altima. Based upon my experience I believe that the operator of the Accord was RODRIGUEZ's drug supplier, who was in turn supplied by the operator of the Malibu.

- 42. Approximately one minute after RODRIGUEZ returned, CI— exited the Altima and walked away. Once investigators were confident that CI— would not be seen with handling agents they were retrieved at approximately 5:43 pm. CI— surrendered the drugs and was searched with negative results.
- 43. The seized drugs were blue counterfeit 30mg Percocet pills. The weight before adding FBI packaging was 89.3 grams and the pills fielded tested positive for fentanyl. The drugs were later tested by the DEA Laboratory which determined the substance to be 87.968 grams of fentanyl.

I. REVIEW OF PHONE DERIVED DATA AND COMMUNICATIONS

1. OPPENHEIMER CELLULAR PHONE DATA

- 44. On May 23, 2024, Schuyler OPPENEHEIMER was arrested at Logan International Airport for state offenses related to violating a restraining order. OPPENHEIMER's phone, with a number ending in 6009 was detained by CBP which conducted an independent extraction of the device. Investigators obtained a search warrant in order to obtain the content of the device. The data from OPPENHEIMER's cellular phone contained chats, images, video, and other data indicative of his continued involvement in the manufacturing and distribution of controlled substances with RODRIGUEZ. OPPENHEIMER has since been charged with drug offenses, in part, related to the information described in this affidavit and is currently awaiting trial. See United States v. Oppenheimer, Docket No. 24-CR-10240-FDS.
- 45. In the data derived from OPPENHEIMER's cellular phone associated with the 6009 phone number, investigators located text messages between OPPENHEIMER and Harvey RODRIGUEZ, where drug distribution and manufacturing are discussed.
 - a. For example, investigators located a conversation taking place on February 16, 2024, between OPPENHEIMER (utilizing the 6009) and RODRIGUEZ (utilizing a 5190 number and the alias "jackoswald"). In the conversation, RODRIGUEZ informs OPPENHEIMER that he had obtained four kilograms of controlled substances (believed to be fentanyl or cocaine), and has one kilogram remaining ("I just got 4 whole things tossed to me I got 1 left"). RODRIGUEZ invites OPPENHEIMER to come inspect the kilogram and determine if he can find some customers ("come peep it see if u can get sum jugs"). The next day, RODRIGUEZ sends OPPENHEIMER an image of a kilogram of controlled substances that is vacuum-sealed. OPPENHEIMER responds approvingly ("Shit look litt") and RODRIGUEZ replies that he has a few

more kilograms coming next week ("Got a few of drse coming next week"). The text message conversation follows below:

b. Investigators located another example conversation taking place in November and December 2023 between OPPENHEIMER (utilizing the 6009 phone number) and RODRIGUEZ (utilizing an unknown number, and alias Jared). In the conversation, RODRIGUEZ advises OPPENHEIMER that he has a drug customer purchasing 250 grams ("bout to have a 250 play") and requests that OPPENHEIMER provide him with an ounce of controlled substances and that he will be able to sell it quickly ("Throw me like a zip ill get it off quick"). RODRIGUEZ indicates that he would

like to hand out samples of the drugs that OPPENHEIMER has available. Based upon the discussed drug weights and terminology used, investigators believe they are discussing cocaine or fentanyl. Shortly thereafter, RODRIGUEZ asks if OPPENHEIMER has any counterfeit Adderall pills ("U got Addie's?"). OPPENHEIMER responds in the negative ("Nah") and informs RODRIGUEZ that he has not had the opportunity to manufacture any counterfeit Adderall pills recently ("I ain't even been able to do non of that shit smh"). A few hours later RODRIGUEZ asks if OPPENHEIMER has "swapped it out", which I believe to refer controlled substances that OPPENHEIMER returned based on the drugs being low quality. OPPENHEIMER responds that the source of supply ("They") said the replacement would available by Thanksgiving ("said Thanksgiving"), which means OPPENHEIMER would have the controlled substances in two or three days. Five days later RODRIGUEZ asks what is going on ("Broda wtw"). The next day RODRIGUEZ again asks what is going on, and notes that his customers will go elsewhere ("Broda Wtw dese niggas jus gon go elsewhere") because they have been calling ("they been calling me") and RODRIGUEZ continues to avoid their calls ("I just been dubbin em"). RODRIGUEZ then informs OPPENHEIMER he has a sale for 100 grams ("Got jug fa 100") and the buyer is willing to pay \$1,900 ("He tryn pay 1900 tho"). RODRIGUEZ asks if OPPENHEIMER would like the sale ("U want it?"). On 12/7/23, RODRIGUEZ calls OPPENHEIMER, and OPPENHEIMER states he will call him back. RODRIGUEZ states he has a source of supply of kilograms for a low price ("Got things fa da low bro"). RODRIGUEZ states that he can get uncut controlled substances for \$15,000, and that he will be taking a trip to secure the supply ("I can get u raw fa 15 im bout to take trip"). RODRIGUEZ then states that if OPPENHEIMER comes with him on the trip, that the price will be \$13,000 ("If u come wit me 13"). OPPENHEIMER replies that he is driving and will call him back.

2. OPPENHEIMER CELLULAR PHONE DATA

- 46. Investigators also obtained cellular phone data related to OPPENHEIMER. In the data, investigators located a conversation between OPPENHEIMER (using the 6009 phone number) and a phone number ending in 6799 that is believed to be historically used by Harvey RODRIGUEZ. The conversation begins on January 19, 2022, with a message from the 6799 phone number identifying himself as "opp" and that this is his new number and to delete the old phone number ("Yo is opp lock dis number in delete da other one").
- 47. On March 4, 2022, the 6799 phone number sent the following messages to OPPENHEIMER on the 6009 phone number:

Yo can niggas slide I got mad shit I gotta pay fa bro we keep delaying it I got mad people on my back

- + I gotta get drac sum bread can I get sum of those u got done up my lil bro gon pay fa em ina couple days gotta keep things rollin w him he'a good bread
- 48. Investigators believe that in these messages RODRIGUEZ is asking OPPENHEIMER if he can come by OPPENHEIMER's residence ("can niggas slide"). RODRIGUEZ informs OPPENHEIMER that he needs to provide "drac" (believed to be a street name for a source of supply) with money ("sum bread") and asks for some of the pills that OPPENHEIMER has completed ("can I get sum of those u got done up"). RODRIGUEZ indicates that his associate ("lil bro") is going to pay

OPPENHEIMER for the pills in a couple days ("gon pay fa em ina couple days") and that the associate is trustworthy and requires pills in order to keep making money ("gotta keep things rollin w him he'[s] good bread.").

49. The conversation continued March 14, 2022, where OPPENHEIMER and RODRIGUEZ discuss payment to be made to OPPENHEIMER once a customer of RODRIGUEZ's makes a drug sale. The conversation follows:

50. Investigators believe that in this conversation, OPPENHEIMER asks RODRIGUEZ to contact RODRIGUEZ's associate and inquire about an amount owed to OPPENHEIMER for pills that were fronted ("Yo you think you can hit your man for me today and see if I can grab some of that before I slide tomorrow?"). RODRIGUEZ replies that the associate is not ready to pay ("he not ready") and had only recently paid RODRIGUEZ \$1,000 ("he just hit me with 1k yesterday"). RODRIGUEZ reiterates that the associate will have half of the amount owed in a few days and will need more pills ("he's bout to have ya half in full within next couple of days he's gonna need mo"). RODRIGUEZ then informs OPPENHEIMER

that there might be another anticipated sale ("I might have another play"). RODRIGUEZ then states that the associate has a sale for \$2,000 at 2 o'clock ("Got a play fa 2k at 2 o'clock he said"). RODRIGUEZ then arrives at OPPENHEIMER's residence ("I'm outside"). Fifteen minutes later, RODRIGUEZ informs OPPENHEIMER that the associate did not make the sale because the customer who wanted the drugs ("da nigga dat wanted da work") is not answering ("not answering him now").

- 51. On March 16, 2022, RODRIGUEZ sent OPPENHEIMER a link to a Salem News article related to Vincent CARUSO's guilty plea in federal court. As noted above, Vincent CARUSO, Harvey RODRIGUEZ, Michael NAGLE, and OPPENHEIMER were all known to associate with one another when CARUSO's DTO was located in Saugus, Massachusetts.
- 52. Investigators located a conversation between OPPENHEIMER (utilizing the 6009 phone number) and RODRIGUEZ (utilizing a phone number ending in 8272) taking place on June 28, 2023 and June 29, 2023. In the conversation, it appears that RODRIGUEZ asks "How we looking broad" and informs OPPENHEIMER he has "1 so far", which likely refers to \$1,000. RODRIGUEZ then asks if OPPENHEIMER has an unidentified item available for the following day ("Got me tomorrow?"). OPPENHEIMER agrees. The following day, RODRIGUEZ tells OPPENHEIMER that he needs the item that day, and that he has people who paid for a whole kilogram and they are pressuring him to pay him back ("get me dat today I got people dat threw down on da whole thing n dey on my back crazy"). Based upon later aspects of the conversation, and information provided by CW—, investigators believe that RODRIGUEZ is requesting OPPENHEIMER provide him with is a part to a pill press so that he can commence pressing his own pills.

53. The conversation between OPPENHEIMER (utilizing the 6009 phone number) and RODRIGUEZ (utilizing the 8272 phone number) continued on. In this conversation, it appears that RODRIGUEZ continues to ask OPPENHEIMER for the "piece" to the pill press (or potentially an entire pill press) that he referred to in the prior conversation ("I really need dat piece"). OPPENHEIMER indicates that he does not have access to it without his associates ("it's not about you going anywhere bro i can't just go and get it bro I don't got access wit out my ppl") and that he will go and "take care of that" for RODRIGUEZ the next day ("I'm sliding up there tomorrow to link them and take care of that"). They continue to discuss arranging OPPENHEIMER's retrieval of the part or press ("but I think today I can grab. It bro, I been. Hitting them to go pull up every day bro"). RODRIGUEZ replies that he understands and notes that he has a lot invested and would like the information about obtaining a press if OPPENHEIMER cannot provide a press itself ("I'm really tapped out at this point I got it all invested if not if u could help me figure out how to get one"). OPPENHEIMER then explains that he has been trying to contact his associates and they are not responding. RODRIGUEZ then asks if OPPENHEIMER can assist him in obtaining another pill press ("Bro I'm not trippin bout dat I jus asked u fa help to figure out another one I understand das dead"). OPPENHEIMER responds that he contacted the usual website he uses but it was not working, and has been checking reviews on websites ("other website I was using is dead to, we had sent a email to them and it bounced back bro, yesterday I was looking up other sites, reviews and all tk try and see what's valid").9 RODRIGUEZ then tells OPPENHEIMER that he only needs the information for the website and that he will have a female associate do the purchase ("I just need da info n I'll have dis bitch do it I ain't tryna bother u I kno u got a million things goin on daily but all I really need is information n I have dis bitch do it"). 54. On July 18, 2023, RODRIGUEZ (utilizing the phone number) asks OPPENHEIMER when he can meet up with OPPENHEIMER. Investigators know from other text messages sent around this time period and CSLI that OPPENHEIMER was located in Brockton, MA for hours on July 18, 2023. Investigators believe that OPPENHEIMER was likely in Brockton, MA, manufacturing pressed pills in a new location. Investigators believe RODRIGUEZ is asking OPPENHEIMER when they can meet up for a resupply of controlled substances.

Investigators also identified another part of the text message conversation taking place on August 16, 2023, between RODRIGUEZ (utilizing the phone number) and OPPENHEIMER (utilizing a 6009 phone number). In this part of the conversation, RODRIGUEZ asks if he can come retrieve an item believed to be drugs, because he is out of product ("but can I come grab dat I'm tapped out rn nbs). RODRIGUEZ then states that he has had difficulty collecting outstanding drug debts ("Waiting to collect dese niggas slow"). RODRIGUEZ then asks OPPENHEIMER when he wants to do "that" because another individual is telling RODRIGUEZ that will need to complete that task during the day ("when do u wanna do that dude saying we gotta try n bang shi out during day"). OPPENHEIMER then asks if RODRIGUEZ had obtained the "piece" for "it". In this second part of the conversation, investigators believe RODRIGUEZ is asking OPPENHEIMER to coordinate a time when they can make counterfeit pills at a location that is controlled by another individual. It would appear that the press is not readily accessible and is in the possession of another individual who will need to grant them access to the press. OPPENHEIMER then asks if RODRIGUEZ had obtained the part or "piece" needed for the press, which investigators believe is likely a reference to the molds used to form the pressed pills so that they resemble pharmaceutical pills.

3. OPPENHEIMER INSTAGRAM

56. Investigators reviewed data associated with Instagram account utilized by Schuyler OPPENHEIMER, a/k/a "SK". Investigators located a series of audio messages exchanged between Harvey

RODRIGUEZ's Instagram account username "bigoppzz" and OPPENHEIMER in January 2022. During the exchanges, RODRIGUEZ discusses a recent fight that took place with security at the Encore Casino in which he and another identified individual named "Mikey" were involved. RODRIGUEZ states that he was having difficulty getting through security in order to travel up the elevator to a hotel room. RODRIGUEZ tells OPPENHEIMER that "Mikey" smacked the shit out of a security guard and that RODRIGUEZ "had the pole with the switch in there" and states that he has been banned from the casino (filename: "unified_message_2837796473185398.m4a"). In one message, RODRIGUEZ tells OPPENHEIMER that he provided a fake name to the casino security and may in fact be able to return. I believe that RODRIGUEZ referring to his being in possession of a "pole with the switch" refers to the fact that during the struggle RODRIGUEZ was in possession of a firearm equipped with a machinegun conversion device.

- 57. I have obtained records and surveillance footage from the Encore Hotel and Casino in Everett, MA, and confirmed that this incident did in fact take place, on January 24, 2022. During the video, RODRIGUEZ can be observed in the company of Lawrence Michael NAGLE. I know from review of casino records related to the incident and review of the video footage that RODRIGUEZ was present during the incident and that the "Mikey" referred to in this incident is Lawrence Michael NAGLE. ¹⁰
- 58. The surveillance video reflects multiple BOE associates entering the Encore casino with RODRIGUEZ and NAGLE, and other individuals believed to be associated with NAGLE. Still images from the incident follow with RODRIGUEZ identified with a red box.
 - a. The first set of images depict RODRIGUEZ entering the Encore casino. RODRIGUEZ can be observed wearing the following: (1) in jeans with star embellishments, (2) winter hat with white writing, (3) black jacket and blue shirt, and (4) sneakers with predominantly white and red coloring. Notably, the "Big Opp" diamond-encrusted chain is also visible around RODRIGUEZ's neck. Multiple sources of information have informed investigators that this chain was stolen from RODRIGUEZ by rival gang members and he has never been able to recover it.

b. The fight in fact took place by the elevators in the Encore casino that allow access up to the hotel. The large group of RODRIGUEZ and NAGLE associates approach the elevator and appear to be denied entry. It appears that NAGLE confronts security and at one point pushes or slaps a male security guard by the elevator. In the images below, NAGLE can be seen confront a male security officer while a female security guard stands in between. NAGLE's arm then extends and slaps the male security guard.





c. The fight then ensues between the groups and security. Still images follow depicting the initial slap and struggle in front of the elevators that then continues out into the area leading to the elevators.



59. As the fight flows out into the hall leading to the elevators, RODRIGUEZ stands over NAGLE who is being held by Encore security. It appears that RODRIGUEZ attempts to free NAGLE and is then physically engaged by one of the Encore security guards.



4. RODRIGUEZ PHONE DATA

- 60. Investigators reviewed data derived from RODRIGUEZ's cellular phone. The data related the period of approximately September 2022 through January 2023.
- 61. A "Note" in the RODRIGUEZ data stated the website of Lemelange.com, and dye colors that investigators know are used in the manufacturing of counterfeit pills. This particular website was a source of pill manufacturing ingredient also utilized by OPPENHEIMER and was described at length in the affidavit supporting the criminal complaint against OPPENHEIMER. The note read as follows:

62. Investigators located a number of photographs of depicting quantities of controlled substances, including what appear to be pressed pills and stamped and sealed quantities of white substances

believed to be cocaine or fentanyl. Some of the identified images and videos follow with pertinent notes regarding the image.

The image and video depict what appears to be a kilogram quantity of white powder substance that investigators believe to be fentanyl or cocaine in a vacuum sealed package with the stamp of a horse. It appears that a knife has been used to cut open the package.

5. RODRIGUEZ TEXT MESSAGES

- 63. Investigators also located a number of text message conversations in the RODRIGUEZ data utilizing the iMessage application. For each of the text message conversations, RODRIGUEZ utilized the 8272 phone number.
- 64. Investigators located a text message conversation between RODRIGUEZ (utilizing the 8272 phone number) and CC-1 (utilizing a 6704 phone number). In the conversation, there is extensive discussion concerning the production of CC-1's music, drug distribution, and other aspects of promoting the reputation and image of BOE. Pertinent examples follow:
 - a. In one portion of the conversation on October 18, 2022, CC-1 tells RODRIGUEZ that they are going to "get Breezo," referring to an individual whose identity is known to me, "ASAP" ("Nbs we gonna get breezo) and RODRIGUEZ agrees, replying say no more ("Snm Les get it"). I am aware from other interviews conducting during this investigation that the individual whose true name I know and whom I will refer to as "BREEZO," consistent with RODRIGUEZ, was in fact a drug customer of RODRIGUEZ who was provided a kilogram of cocaine on consignment. BREEZO then claimed that the kilogram had been seized by police, but RODRIGUEZ and his associates in BOE did not believe this story to be true. According to multiple witnesses, RODRIGUEZ and others involved went to the Alta Clara apartment leased by RODRIGUEZ under a false name in order to force BREEZO to return a kilogram of cocaine that RODRIGUEZ had provided to BREEZO. Multiple criminal associates of RODRIGUEZ were present with at least one firearm when BREEZO was threatened and in fact beaten as part of RODRIGUEZ's efforts to secure return of the kilogram of cocaine. Ultimately, the kilogram was returned.

b. In another portion of the conversation on December 16, 2022, RODRIGUEZ invites CC-1 to drive and pickup "sum thing", which investigators believe refers to pills. RODRIGUEZ then tells CC-1 that they need to "sell" the things that they are going to pickup ("Bro we gotta sell dese double up"). RODRIGUEZ describes the things as the you know what ("is da u kno wha"), which investigator believe means fentanyl. RODRIGUEZ then tells CC-1 that he "can get all types" at a low price ("N fa da low").

c. In another portion of the conversation on December 21, 2022, CC-1 tells RODRIGUEZ to bring him "28", which investigators believe refers to 28 grams of drugs, likely cocaine. CC-1 states that he is trying to line up some sales ("try n get some moves").

- e. In another exchange on November 17, 2022, RODRIGUEZ asks CC-1 where RODRIGUEZ's firearm is ("Bro wea tf is my blick").
- f. In another exchange on September 10, 2022, CC-1 asks RODRIGUEZ if anyone has a firearm ("No one got a pole or none"). RODRIGUEZ replies that he does ("I do").
- 65. Investigators located a text message conversation between RODRIGUEZ (utilizing the 8272 phone number) and a contact that I will refer to as "Customer 1" (utilizing a phone number ending in 5860). In the conversation, there is extensive discussion concerning the sale of drugs to Customer 1 by RODRIGUEZ. Pertinent examples follow:

a. On September 17, 2022, Customer 1 asked RODRIGUEZ how much he was charging per gram ("How much a g") and informed RODRIGUEZ that she pays \$32 a gram at the moment ("Rn i pay 32"). RODRIGUEZ then tells Customer 1 that he can sell her half of one ounce for \$850 ("I can do u 850"). Customer 1 then begins to inquire about prices for 4 ounces, or 62 grams for \$2,000 ("Or a 62 2k"), at approximately \$31 or \$32 per gram ("31-32 a g"). RODRIGUEZ replies that he will sell her 250 grams for \$7,500 ("I'll jus throw u 250 fa 7500), which equates to \$30 per gram. Customer 1 then asks for 125 grams for \$3,500 ("Or 125 3500"), which equates to \$28 per gram. Later in the conversation, RODRIGUEZ indicates that he will sell Customer 1 250 grams for \$7,000 ("give u 250 fa 7 flat").

b. On October 2, 2022, RODRIGUEZ inquires about the repayment of the drug debt owed by Customer 1 ("Is iight how we lookin"). Customer 1 replies that she will pay \$2,500 or \$3,000 this weekend and her business was slow ("Ill giv u 2500/3k tm, this weekend was kinda slow thoo"). Customer 1 then asks when she obtained the drugs from RODRIGUEZ and he agrees that it was a week ago, but notes that he has some new drugs arriving soon that his associates are saying is much better quality ("Yea a week ago das smooth got sum fiyaa on da way niggas is saying is better").

c. On October 7, 2022, RODRIGUEZ again inquires about the outstanding drug debt with Customer 1 ("how long till u got da rest of dat"). Customer 1 replies it will take about a week, and RODRIGUEZ replies he needs the money sooner than that and indicates he cannot be waiting three weeks for \$7,000 ("I need dat bread sooner g I can't b waiting 3 weeks fa 7 bands"). RODRIGUEZ explains that he would have already sold the drugs and been paid by another customer and he provided the drugs to Customer 1 at a very low price so he is losing money ("I woulda already flipped dat n I'm throwing u a crazy number so I'm losing"). Customer 1 replies that her sales have been slow, and the individuals who buy large quantities already have drugs – Customer 1 then proposes returning 125 grams to RODRIGUEZ so he can sell it ("Its been slow everyone who buys bulk already got work, i can give u a 125 back and u can flip it"). Customer 1 then remarks that she usually clears \$12,500 per week, and the timing of when she obtained the drugs caused her to miss a weekend ("Usually i clear a 125 a week but wasnt boomin last weekend" "& i grabbed it on a sunday so i missed that whole weekend to clear it"). RODRIGUEZ agrees to the return of the drugs.

a. Conversations with FRANCIS FORSYTH, Jr.

- 66. Investigators are familiar with Francis FORSYTH, Jr., a/k/a "Kranko," who has a date of birth xx/xx/1999. FORSYTH pleaded guilty to Indictment from Suffolk Superior Court charging him with trafficking in 36 grams or more of a class B substance. That case relates to an April 11, 2022, search warrant at FORSYTH's residence in East Boston, where approximately 70 grams of fentanyl were recovered. FORSYTH was charged that day and posted bail. Based on the investigation thus far, investigators believe that the fentanyl pills recovered during the search warrant were in fact obtained from RODRIGUEZ. FORSYTH has since pleaded guilty to this case and was sentenced to 30 months in the house of correction. See Commonwealth v. Forysth, Suffolk Superior Court, Docket No. 2284CR00718. The filed statement of the case in Suffolk Superior Court states as follows:
 - a. On April 8, 2022, members of the Winthrop Police Department and Boston Police Departments executed a search warrant for the residence of in East Boston. Once inside, Ms. Constantino (wife of Mr. Forsyth Sr. and mother of Mr. Forsyth Jr.) told officers where everyone's bedrooms were. From the bedroom that Mr. Forsyth Jr. shared with his girlfriend, officers recovered 8 plastic bags of blue pills marked A 215 that were tested and found to contain 73.71g fentanyl. Mr. Forsyth Jr. later admitted to possessing all of the pills found inside of his bedroom. Officers also executed a search warrant for Mr. Forsyth Jr.'s person, and they recovered an iPhone as well as \$770.
- 67. Investigators are also familiar with a separate Drug Enforcement Administration (DEA) investigation of FORSYTH taking place in 2022, while FORSYTH was on pretrial release for the April 11, 2022, state search warrant case. Specifically, investigators have reviewed audio and video recordings of FORSYTH selling CW— two firearms and 1000 blue pressed fentanyl pills. FORSYTH was federally

charged with these offenses, pleaded guilty, and was sentenced to 47 months imprisonment. *See United States v. Francis Forsyth*, Docket No. 24-cr-10103-FDS.

a. On March 23, 2022, CW-27 made a recording of a Facetime call with FORSYTH. During the conversation, CW-27 spoke with FORSYTH about the purchase of a firearm. Investigators have reviewed the recording, and an accurate transcript of the pertinent portion of the recording follows. During the recording, FORSYTH discusses having a source of supply for firearms, including ghost guns ("ghost") and then indicates that the source of supply owes him a firearm already:

FF: Let me know.

CW-27: Fuck it, I'll just get a ghost then. Is that – Is that easier? Is that – Is that easier?

FF: (Speaking at the same time as CW-27): Yeah, that's probably (inaudible) on everything else. I'll be able to get you a good ticket on it.

CW-27: Yeah, I – I obviously can't give you the things for them anymore.

FF: I know, yeah I know. Yeah, nah, I'll you a good ticket though. That's why it was – it was easier, you know what I'm saying?

CW-27: Yeah.

FF: Like that was easier. But now it goes (inaudible) enough to my pocket like a band or something.

CW-27: Yeah, well I got – I'll give you whatever – whatever it costs, I'll give it to you.

FF: Yeah.

CW-27: I got - I got cash.

FF: I'm supposed to meet – meet up with the kid tonight. 'Cause he owes me – he owes me one, so he's about to bring me money anyway, and I'm just gonna put in the order for yours, and he'll let me know tonight when it's gonna be in.

CW-27: Alright, alright. Just let me know.

FF: I'll just let you know, you know what I mean? I can have enough –

CW-27: Just – Just make sure you FaceTime me. Don't – Don't send no text or

anything.

FF: Yeah, no I got you, I got you. Yeah, but I should call you – When I'm with him, I'll call you tonight.

CW-27 Alright, let me know. And just send me –

FF: Alright.

CW-27: Just let me know the price, and I'll – I'll give it to you.

- b. On April 11, 2022, CW-27 made a recording of Facetime calls with FORSYTH where FORSYTH spoke about law enforcement conducting a search of his residence (the East Boston Search warrant case) and police seizing 800 fentanyl pills.
- c. On June 6, 2022, FORSYTH sold CW-27 an AK-47 rifle with an obliterated serial number, and 223 rounds of 7.62x39mm ammunition, for \$2,200. This transaction was audio recorded. In a number of audio recordings before and afterward, FORSYTH discusses the sale of the AK-47, and the fact that it was stolen. Prior to the purchase, CW-27 made a number of recordings of Facetime calls with FORSYTH on May 13, 2022, June 2, 2022, and June 6, 2022, to arrange the purchase of the AK-47. During prior recordings regarding the sale of this AK-47, FORSYTH stated that RODRIGUEZ was the original buyer for the weapon after the death of "40" (who investigators know to be David MARTINEZ, a/k/a "40," who was murdered in September 2020, along with a second individual in Charlestown, Massachusetts). I am also aware that RODRIGUEZ was a relation of MARTINEZ, and that following the murder of MARTINEZ, RODRIGUEZ was believed to have put a \$100,000 on the heads of CARUSO and ERNEST JOHNSON (charged and convicted in *U.S. v. Johnson*, Docket No. 22-CR-10103-LTS). A transcript of that May 13, 2022, recording follows:

According to information from CW-9 and CI-5, as a result of MARTINEZ's murder, RODRIGUEZ and RODRIGUEZ's associates, who were formerly aligned with CARUSO did not agree with the murder of MARTINEZ and purportedly placed a \$100,000 bounty on CARUSO's head for killing MARTINEZ. CARUSO and JOHNSON repeatedly referenced this bounty in various interceptions made by a cooperating witness and JOHNSON has also repeatedly referenced it in videos that he posts online to social media accounts that he controls. During the investigation of Operation Street Sweeper, Vincent CARUSO, a/k/a "FATZ" was captured on recording during a call in May 2021, where he discussed the fact that a mutual acquaintance (who I will refer to as "M-A") was known to have been spending time with RODRIGUEZ and Big Opp Entertainment, who was then responsible for the \$100,000 bounty on CARUSO's head. CARUSO states "your man [M-A] is going to end up in a real fucked up situation" because he was spending time with the rival drug dealers. CARUSO states, "it's about to get real 40ish. Not with [M-A]. I would never do that to [M-A]. But it's about to get real 40ish, on dogs. You know who I'm talking about." I believe in this statement CARUSO is stating that he is contemplating procuring the murder of RODRIGUEZ in the same manner that he procured the murder of MARTINEZ, and uses the

- d. On July 11, 2022, FORSYTH sold CW-27 a Glock .40 caliber pistol for \$1,400. This firearm was comprised of a Glock upper and a Polymer80 lower. During the conversation for the sale of the Glock, CW-27 arranged for the purchase of 1,000 pressed fentanyl pills from FORSYTH for \$2,000. This transaction on July 11, 2022, was audio-video recorded and FORSYTH can be observed handling the firearm in the recording.
- e. On July 14, 2022, FORSYTH sold CW-27 1,000 blue pressed fentanyl pills bearing the M30 stamp for \$2,000. This transaction on July 14, 2022, was audio-video recorded and FORSYTH can be observed in the recording pulling the pills out of his pocket and handling the pills before passing them to CW-27. The pressed fentanyl pills were tested at the DEA laboratory and determined to contain fentanyl and weight 145 grams.
- 68. During the review of RODRIGUEZ's phone data, investigators identified a text message conversation between RODRIGUEZ (utilizing the 8272 Phone Number) and FORSYTH. In the text message conversation, they discuss the distribution of controlled substances, and the purchase of diamond chains. Pertinent examples follow:
 - a. On December 9, 2022, FORSYTH and RODRIGUEZ discussed the price for buying a diamond-encrusted ("fully flooded") 700 gram gold chain ("700 gram Cuban"). During the discussion. FORSYTH states that he has a 200 gram chain that he purchased for \$20,000, but it is not diamond encrusted ("I got a 500 gram for 20 bands but is plain"). Investigators believe they are discussing the expenditure of drug proceeds to make these purchases.

FORSYTH tells RODRIGUEZ to give him \$700 for 3 lines and that the source has 13 lines remaining. FORSYTH then tells RODRIGUEZ that he will buy 8 lines and store them ("I'm bout to grab a 8 n stash it"). FORSYTH then tells RODRIGUEZ that he will store the 8 lines so that RODRIGUEZ does not think that FORSYTH is joking about buying an entire kilogram, which is referred to as a "ticket" ("Jus so u don't think I'm capping bout da ticket too"). Investigators believe that RODRIGUEZ obtains marijuana from FORSYTH but supplies FORSYTH with cocaine and fentanyl.

- 69. During the review of RODRIGUEZ's data, investigators identified a text message conversation between RODRIGUEZ (utilizing the 8272 Phone Number) FORSYTH (utilizing a 8366 phone number). In RODRIGUEZ's data, the 8366 phone number was associated with a contact named "Kranko," which investigators know is FORSYTH's street name. In the conversations, they discuss the distribution of controlled substances. Pertinent examples follow:
 - a. On September 7, 2022, RODRIGUEZ and FORSYTH discuss an outstanding debt owed to RODRIGUEZ by FORSYTH. RODRIGUEZ asks if FORSYTH can pay any of the debt ("Yo u got any bread u could throw me?") and informs FORSYTH that three "things" of "da girl" will be arriving ("landing") on Saturday. Investigators believe that the "things" are kilograms of cocaine, as "girl" is a common term for "cocaine". FORSYTH replies that he has no money available, and that a number of customers owe him substantial amounts. These customers include "mike moe," who owes FORSYTH \$1,000 ("a band") and another individual from Revere who owes



b. On September 9, 2022, RODRIGUEZ and FORSYTH discussed the distribution of kilogram of controlled substances that is about to be received by RODRIGUEZ ("Bout to touch down"). RODRIGUEZ asks FORSYTH to identify customers and tell him how he needs ("Lmk who needs what if Dey still need it"), and informs FORSYTH that one of the kilograms was seized by law enforcement ("First pack had gotten seized). FORSYTH then states that he would like three ounces ("3 zips still a go"). RODRIGUEZ tells FORSYTH to setup the sales and they will quickly sell them and RODRIGUEZ can give FORSYTH 250 grams of raw cocaine for FORSYTH to adulterate himself that FORSYTH can make extra money ("Set those up well bang Those out n ima throw u like 250 fa ya self fa da breakdown"). c. On September 13, 2022, RODRIGUEZ and FORSYTH discuss the quality of a recent quantity of drugs that FORSYTH obtained from RODRIGUEZ. FORSYTH sends a screen capture of a text message from a contact named "Jacob", where Jacob informs FORSYTH that he had customers tell him it was the best batch of drugs that have received ("had ppl say best batch ever"). RODRIGUEZ acknowledges the quality of the drugs ("I told u it was fire"). Investigators reasonably believe that this refers to a batch of blue pressed fentanyl pills, which can widely vary in quality based on the skill of the manufacturer and quality of the drugs, and precision of the manufacturing equipment and process.

RODRIGUEZ replies that he sells at the low price as a favor and that he can conduct individual sales of 250 gram quantities for \$9,000 to \$10,000 each. RODRIGUEZ then tells FORSYTH that his "bitch can sell 250 grams through multiple smaller sales for a total of \$13,000. RODRIGUEZ and FORSYTH then confirm that FORSYTH will purchase the 2 ropes the following day, and FORSYTH indicates that he may obtain 3 ropes.

b. Conversation with "JACOB"

- 70. Investigators are familiar with an individual whose identity is known to me that I will refer to as "Jacob." During the review of RODRIGUEZ's data, investigators identified a text message conversation between RODRIGUEZ (utilizing the 8272 Phone Number) and Jacob (utilizing a phone number ending in 2354). In the conversation, RODRIGUEZ and Jacob discuss the distribution of controlled substances and the payment of outstanding drug debts. Pertinent examples follow:
 - a. On September 13, 2022, RODRIGUEZ directed "Jacob" to meet him at Street, Chelsea, Massachusetts. Jacob stated that he dropped RODRIGUEZ's keys to "Gurk" (who investigators know to be Gustavo DEOLIVEIRA-SOUZA, who was charged in Cr. No. 24-cr-10396-FDS) in order to walk the dog. Jacob then apologizes to RODRIGUEZ and states that he would not have dropped off RODRIGUEZ's "shit" to anyone and that he only did so because he had spoken to "John" (referring to CC-1), "zef" (referring to CC-5)¹² and "gurk" (meaning DEOLIVEIRA-SOUZA).

b. On October 8, 2022, Jacob tells RODRIGUEZ that he will pay \$700 the following day because he has just obtained drugs from an associate ("I jus grabbed from bro on blocc n came"). RODRIGUEZ tells Jacob to not bring anyone to RODRIGUEZ's residence, and that only Jacob's girlfriend is allowed. Jacob replies that the individual he brought to RODRIGUEZ's residence was his "stash", meaning an individual who stores drugs on Jacob's behalf, and that Jacob was obtaining drugs at the moment ("I got u he jus my stash I'm grabbin work now"). Jacob states that his residence has been drawing too much attention and that the individual serving as his "stash" does not even know what town Jacob resides in.

d. On October 15, 2022, RODRIGUEZ and Jacob discussed the distribution of controlled substances. Jacob states that he has an ounce of drugs for RODRIGUEZ, likely marijuana, on his person and asks where RODRIGUEZ wants to meet ("W ur zip", "Wea u wanna link"). Jacob then asks RODRIGUEZ if he can pay for the last ounce he sold him ("U can't toss any fa last one?"), and that Jacob will need money when he goes to get drugs from CC-1 ("I'm finna have no bresd one me wen I grab this from Johnny"). RODRIGUEZ states that he will pay Jacob the following day and that the \$600 he owes Jacob is a very small amount ("Bro ima get u ya bread tomorrow stop buggin ima owe u lil 600 das lunch money"). RODRIGUEZ then

boasts that he needs to collect money because he recently spent \$70,000 in the last two weeks ("I gotta go get mo bread dropped like 70k dese last 2 weeks I gotta wait to collect lol") and that an apartment complex that he utilizes just charged him \$3,000 ("complex jus jacked me fa 3k lol").

Jacob explains that the controlled substances, likely pills, are a "lil powdery" and is worried about customers complaining ("don't want no one being annyoing Niggas be aggy asf lol"). RODRIGUEZ replies that the drugs came a little powdery and did not know why that was, but assures Jacob that the drugs were not cut with anything ("jus came

a lil powdery idk why but is not cut at all"). RODRIGUEZ then advises Jacob to have his customers test the drugs to check the quality ("Have niggas test it" "U gon see"). RODRIGUEZ then tells Jacob that he will return from Puerto Rico in 3 days and will swap the drugs ("I'm back from pr 3 days worse comes to worse I swap u fa a hard one"). Jacob agrees, and RODRIGUEZ replies with the "100" emoji and the TARGET emoji, which is a BOE symbol. Jacob then reiterates that he owes RODRIGUEZ "72", referring to \$7,200.

j. On December 29, 2022, Jacob asks RODRIGUEZ to bring him an ounce of drugs and that he will pay for the drugs the following day or day after. In the following days, Jacob tells RODRIGUEZ that no one has complained about the drugs, but people have commented about the color. RODRIGUEZ asks if the drugs being described as potent ("Fiya thou right"). Jacob replies that he will see RODRIGUEZ the following night with all of the outstanding money owed ("I'll see you Tommorw nite with it all"). Jacob then tells RODRIGUEZ on January 5, 2023, that two customers have complained and want the regular type of drugs. Jacob indicates he will come by and pay RODRIGUEZ what he owes.

c. Conversation with "Breezo"

- 71. Investigators are familiar with an individual, whose identity is known to me, who I will refer to as "Breezo". Breezo was identified as having been kidnapped by RODRIGUEZ, Claudio MELO (who was charged in Cr. No. 25-cr-10071-FDS), and other associates on or about December 2022, based on RODRIGUEZ's belief that Breezo had stolen a kilogram of cocaine. This kidnapping was undertaken in furtherance of RODRIGUEZ's ongoing drug manufacturing and distribution conspiracy and multiple drug conspirators and BOE associates were involved in the incident.
- 72. CW— generated a recording of Breezo describing the incident that investigators have reviewed. During the recording, Breezo describes the incident, specifically that:
 - a. Breezo told RODRIGUEZ that the police were chasing him and they seized the kilogram after Breezo fled on foot. Breezo indicates that they believed him at first. However, CC-1 did not believe Breezo and caused the members of BOE to come to Breezo's residence and kidnap him.
 - b. Breezo stated that they brought him to RODRIGUEZ's "crib" that was an apartment rented in a fraudulent name. Breezo clarifies that it was not the Ironwood that CW-originally believed it was. Investigators believe it was in fact RODRIGUEZ's apartment at Alta Clara Apartments in Stoneham where RODRIGUEZ was living under a fraudulent identity. Breezo stated that CC-1 made contact with a number of individuals while Breezo was in their custody and relayed information that numerous individuals believed Breezo had in fact stolen the kilogram.
 - c. Breezo stated that RODRIGUEZ showed Breezo messages from his phone from the source of supply indicating that the source of supply was going to hold RODRIGUEZ accountable for the loss. RODRIGUEZ indicated that he had to hold Breezo accountable since he himself was going to face consequences as well.
- 73. Investigators identified a text message conversation between RODRIGUEZ (utilizing the 8272 Phone Number) and Breezo (utilizing phone number ending in 1123). The 1123 phone number was saved in RODRIGUEZ's data as "Breezo."
- 74. In the conversation, RODRIGUEZ and Breezo discuss the distribution of controlled substances and the payment of outstanding drug debts. Additionally, RODRIGUEZ threatens Breezo in text messages for apparently stealing an amount of drugs, consistent with the information from CW— and the recording of Breezo concerning the kidnapping. Pertinent examples follow:

a. On December 6, 2022, Breezo asks RODRIGUEZ if the user of the phone number ending in 8272 is "Opp", meaning Big Opp. RODRIGUEZ replies in the affirmative.

Breezo indicates that he told the associate to plan for Friday, but the associate needs an amount immediate. RODRIGUEZ states that he will need to wait one more day because he does not want to sell the items at the moment. RODRIGUEZ then directs Breezo to
Street, Chelsea, MA.




c. On January 3, 2023, RODRIGUEZ and Breezo discussed the stolen kilogram. CWreported that the kilogram was returned by another individual on Breezo's behalf.
RODRIGUEZ appears to accuse Breezo of taking an amount of the cocaine out of the kilogram before returning it. RODRIGUEZ tells Breezo he will "pay" for what he "took out there." Breezo indicates that he did not take anything out that pack of drugs ("On my mother I didn't take nothing out that shit", "On dead dogs I didn't touch that shit" "Cuz opp, I didn't touch that pack Nigga"). RODRIGUEZ does not believe Breezo and states that he will have money and is done talking ("I ain't gon talk no mo I want my bread niggas talked enough"). Breezo indicates that all he did was open the kilogram and that why would he return it if he took some out of it ("Nigga why tf would I give it back and take sun out of it"). RODRIGUEZ tells


Breezo that he will be attacked ("u really food now"). RODRIGUEZ tells Breezo that he wants \$2,000 ("I want my 2 bands"), and advises Breezo that if he does not pay the money to RODRIGUEZ that Breezo should purchase a firearm ("blick") because he is not one to trifle with ("cuz jus go spend it on a blick cuz niggas gave u enough chances u must think niggas bitch or sum").

CONCLUSION

Based on the foregoing, there is probable cause that HARVEY RODRIGUEZ Conspired to Manufacture, Distribute, and Possess with Intent to Distribute, Controlled Substances, in violation of 21 U.S.C. § 846, commencing at an unknown time, but from at least approximately 2019 through December 2023. Further, based on the foregoing, there is probable cause that HARVEY RODRIGUEZ, and others, Conspired to Interfere with Commerce by Robbery, on or about January 30, 2023, in violation of 18 U.S.C. § 1951(a).
