INDICTMENT

The Grand Jury charges:

COUNT ONE

From on or about July 25, 2022 through on or about September 19, 2022, in the Middle District of Florida, in the Eastern District of Texas, and elsewhere, the defendant,

SETH ESTES VANOVER,
a/k/a "jattleson,"

using facilities of interstate commerce, that is, by cellular telephone and the internet, did knowingly and willfully attempt to persuade, induce, entice, and coerce a person whom the defendant believed had not attained the age of 18 years to engage in any sexual activity for which any person can be charged with a criminal offense under the laws of the state of Florida, that is, the crime of lewd or lascivious molestation against a person less than 12 years of age, in violation of Section 800.04(5)(a) & (b), Florida Statutes.

All in violation of 18 U.S.C. § 2422(b).

FORFEITURE

1. The allegations contained in Count One of this Indictment is hereby incorporated by reference for the purpose of alleging forfeiture, pursuant to the provisions of 18 U.S.C. § 2428.

2. Upon conviction of a violation of 18 U.S.C. § 2422(b), the defendant, SETH ESTES VANOVER, a/k/a “jattleson,” shall forfeit to the United States, pursuant to 18 U.S.C. § 2428:

a. any property, real or personal, that was used or intended to be used to commit or to facilitate the commission of such violation; and

b. any property, real or personal, constituting or derived from any proceeds that such person obtained, directly or indirectly, as a result of such violation.

3. If any of the property described above, as a result of any act or omission of the defendant:

a. cannot be located upon the exercise of due diligence;

b. has been transferred or sold to, or deposited with, a third person;

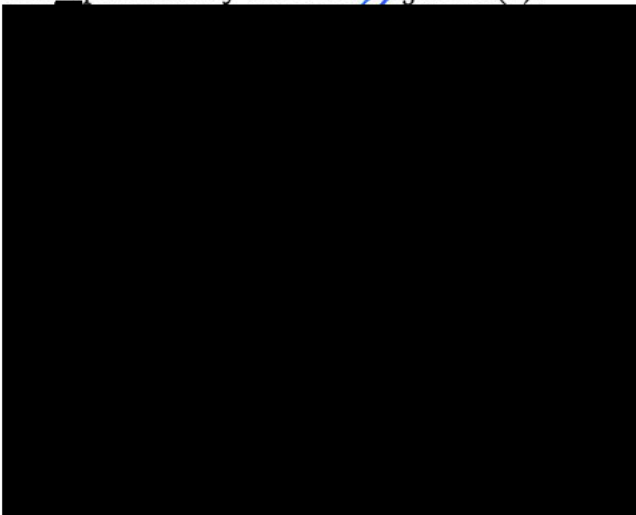
c. has been placed beyond the jurisdiction of the Court;

d. has been substantially diminished in value; or

e. has been commingled with other property which cannot be subdivided without difficulty;

the United States of America shall be entitled to forfeiture of substitute property pursuant to 21 U.S.C. § 853(p), and as incorporated by 28 U.S.C. § 2461(c).

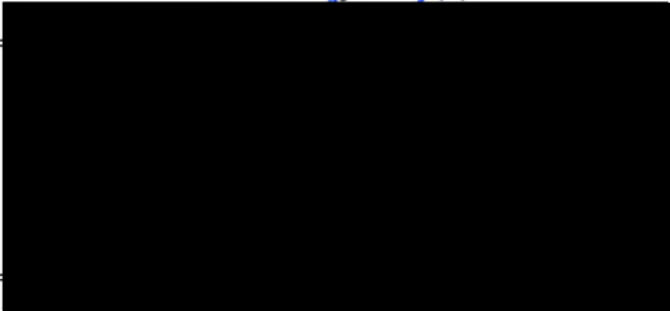
