<u>INDICTMENT</u>

The Grand Jury charges:

COUNT ONE

On or about November 3, 2023, in the Middle District of Florida, the defendant,

BARUCH ROCHE II,

did knowingly attempt to possess or cause to be present a firearm, that is, a Colt 5.56 Carbine, in a Federal facility.

In violation of 18 U.S.C. § 930(a).

FORFEITURE

- 1. The allegations contained in Count One are incorporated by reference for the purpose of alleging forfeiture, pursuant to the provisions of 18 U.S.C. § 2253.
- 2. Upon conviction of a violation of 18 U.S.C. § 930(a), the defendant shall forfeit to the United States, pursuant to 18 U.S.C. § 924(d) and

28 U.S.C. § 2461(c), all firearms and ammunition involved in or used in the violation.

- 3. The property to be forfeited includes, but is not limited to, the following: a Colt 5.56 Carbine (Serial No. CR814550) and five magazines that contain a total of 125 rounds of ammunition.
- 4. If any of the property described above, as a result of any act or omission of the defendant:
 - a. cannot be located upon the exercise of due diligence;
 - b. has been transferred or sold to, or deposited with, a third person;
 - c. has been placed beyond the jurisdiction of the Court;
 - d. has been substantially diminished in value; or
 - e. has been commingled with other property which cannot be subdivided without difficulty;

the United States shall be entitled to forfeiture of substitute property pursuant to 21 U.S.C. § 853(p), as incorporated by 18 U.S.C. § 2253(b).
