



Child Sex Trafficking

Course Description:

This training is designed to provide law enforcement investigators, patrol officers and social service providers with the information necessary to properly understand, recognize, and respond to cases involving child sex trafficking and exploitation. Learn the dynamics of trafficking and exploitation to improve skills related to victim identification and recovery, interviewing techniques for recovered victims, and effective techniques for a fully corroborated investigation to hold the perpetrator(s) accountable.

Objectives/Goals:

Upon completion of this training, you will be able to:

- Fully understand the dynamics of child sex trafficking, victim selection, control techniques and why this crime is often undetected and under investigated.
- Effectively recognize and recover victims of child sex trafficking
- Utilize victim centered interview techniques with recovered victims
- Learn to utilize effective techniques for the investigation of child sex trafficking.
