

**MICHAEL J. MORRIS**, 67, of Seal Beach, California, was sentenced to 208 months in prison, five years of supervised release, and \$750,000 in restitution for conspiracy to commit sex trafficking, sex trafficking by use of force, fraud, and coercion, conspiracy to commit transportation to engage in prostitution, conspiracy to engage in money laundering, and conspiracy to use a communication facility to promote prostitution.

**PAWINEE UNPRADIT**, 48, of Dallas, Texas, was sentenced to 162 months in prison, five years of supervised release, and \$400,000 in restitution for conspiracy to commit sex trafficking, conspiracy to commit transportation to engage in prostitution, conspiracy to engage in money laundering, and conspiracy to use a communication facility to promote prostitution.

**SAOWAPHA THINRAM**, 47, of Hutto, Texas, was sentenced to 72 months in prison, five years of supervised release, and \$250,000 in restitution for conspiracy to commit sex trafficking, conspiracy to commit transportation to engage in prostitution, conspiracy to engage in money laundering, and conspiracy to use a communication facility to promote prostitution.
