
***CASE SUBMISSION CHECKLIST FOR
NARCOTICS AND OCDETF CASES***

- ☐ Copies of all agency forms and reports related to the counts to be indicted; including reports of investigation; reports of drug property collected, purchased, or seized; lab reports; reports of acquisition of non-drug property seizures, and copies of all non-drug exhibits.
- ☐ All state and local case reports written by TFOs or assisting agencies that document the incident(s) presented for prosecution. (Not applicable ☐)
- ☐ Identifying information on each suspect known in the investigation. (*i.e.*, full name, DOB, DL #, SS#, home address, *etc.*)
- ☐ Criminal history, including copies of any certified prior conviction(s), of each target of the investigation: NCIC and LETS.
- ☐ All recordings of any controlled purchase or surveillance related to the investigation. (Not applicable ☐)
- ☐ All recordings of any telephone calls or body wire recordings from confidential source or undercover agent. [This should include all recordings made of any body wire worn by any government agent, including confidential sources. If there was a second recording from a transmitter, a copy of that audio should be provided as well, regardless of whether it is a duplicate]. (Not applicable ☐)
- ☐ Information concerning any possible asset forfeiture property (homes, cars, cash, bank accounts, *etc.*). (Not applicable ☐)
- ☐ All photographs of/from any surveillance, search warrant, exhibits, or seized items collected by DEA, local, or state agency. (Not applicable ☐)
- ☐ Toll records of phones related to the case. [If the case involves messaging between the CS, agents, and the defendant, all texts should be downloaded from the phone and provided to the prosecutor]. (Not applicable ☐)
- ☐ Complete data from any phone download or extraction whether obtained via search warrant or by consent of the owner. (Not applicable ☐)
- ☐ All recordings and statements of any interview of the defendants, suspects, or witnesses/cooperators involved in the investigation. If there was a recording, provide the recording. [If the statement was oral, provide a detailed report of the statement and maintain your rough notes of the statement]. (Not applicable ☐)

- ☐ Search warrants, including the signed search warrant affidavit of any search conducted in the case, attachments and return and inventory forms. [This also includes any recording, audio/video, and photos of/from the search of the residence]. (Not applicable ☐)
