

INDICTMENT

The Grand Jury charges:

COUNT ONE: (18 U.S.C. § 2251(a) – Production of Child Pornography)

On or about April 9, 2022, in the Northern District of California, the defendant,
RICCI LEE WYNNE,
did employ, use, persuade, induce, entice, and coerce a minor, known here as Minor 1, to engage in
sexually explicit conduct for the purpose of producing a visual depiction of such conduct, knowing and
having reason to know that such visual depiction would be transported using any means and facility of
interstate and foreign commerce, and knowing and having reason to know that such visual depiction
would be transported in and affecting interstate and foreign commerce, and using materials that have

1 been mailed, shipped, and transported in and affecting interstate and foreign commerce by any means,
 2 including by computer, and the visual depiction was transported using any means and facility of
 3 interstate and foreign commerce, and the visual depiction was transported in and affecting interstate and
 4 foreign commerce, all in violation of Title 18, United States Code, Section 2251(a).

5 COUNT TWO: (18 U.S.C. § 2251(a) – Production of Child Pornography)

6 On or about October 29, 2022, in the Northern District of California, the defendant,

7 RICCI LEE WYNNE,

8 did employ, use, persuade, induce, entice, and coerce a minor, known here as Minor 2, to engage in
 9 sexually explicit conduct for the purpose of producing a visual depiction of such conduct, knowing and
 10 having reason to know that such visual depiction would be transported using any means and facility of
 11 interstate and foreign commerce, and knowing and having reason to know that such visual depiction
 12 would be transported in and affecting interstate and foreign commerce, and using materials that have
 13 been mailed, shipped, and transported in and affecting interstate and foreign commerce by any means,
 14 including by computer, and the visual depiction was transported using any means and facility of
 15 interstate and foreign commerce, and the visual depiction was transported in and affecting interstate and
 16 foreign commerce, all in violation of Title 18, United States Code, Section 2251(a).

17 FORFEITURE ALLEGATION: (18 U.S.C. § 2253(a))

18 The allegations contained in this Indictment are re-alleged and incorporated by reference for the
 19 purpose of alleging forfeiture pursuant to Title 18, United States Code, Section 2253.

20 Pursuant to Title 18, United States Code, Section 2253, upon conviction of the offenses set forth
 21 in this Indictment, the defendant,

22 RICCI LEE WYNNE,

23 shall forfeit to the United States of America:

- 24 a. any visual depiction described in Title 18, United States Code, Sections 2251 or
 25 2251A, or 2252, or any book, magazine, periodical, film, videotape, or other matter
 26 which contains any such visual depiction, which was produced, transported, mailed,
 27 shipped or received in violation of Title 18, United States Code, Chapter 110;
