18 The United States Attorney and the Assistant Attorney General charge:

19 At all times relevant to this Information:

20 1. Defendant SCOTT SHAW was employed by San Jose State University from 2006 until
21 2020. While employed by San Jose State University, defendant SCOTT SHAW served as Head Athletic
22 Trainer and Director of Sports Medicine.

23 2. San Jose State University, a member of the California State University System, was a
24 public university.

25 3. By virtue of being employed by San Jose State University, defendant SCOTT SHAW
26 was required to act in compliance with the United States Constitution.

27 4. Victim One, Victim Two, Victim Three, and Victim Four were students on women’s
28 athletic teams at San Jose State University.

1 COUNT ONE: (18 U.S.C. § 242 – Deprivation of Rights Under Color of Law)

2 5. Between on or about September 1, 2017, and on or about November 30, 2017, in the
3 Northern District of California, the defendant,

4 SCOTT SHAW

5 while acting under the color of law, and acting without a legitimate purpose, touched Victim One’s
6 breast without her consent, thereby willfully depriving Victim One of liberty without due process of law,
7 which includes the right to bodily integrity, a right secured and protected by the Constitution and laws of
8 the United States.

9 All in violation of Title 18, United States Code, Section 242 (Class A Misdemeanor).

10
11 COUNT TWO: (18 U.S.C. § 242 – Deprivation of Rights Under Color of Law)

12 6. On one or more occasions between on or about September 1, 2017, and on or about
13 November 30, 2017, in the Northern District of California, the defendant,

14 SCOTT SHAW

15 while acting under the color of law, and acting without a legitimate purpose, touched Victim Two’s
16 breast without her consent, thereby willfully depriving Victim Two of liberty without due process of
17 law, which includes the right to bodily integrity, a right secured and protected by the Constitution and
18 laws of the United States.

19 All in violation of Title 18, United States Code, Section 242 (Class A Misdemeanor).

20
21 COUNT THREE: (18 U.S.C. § 242 – Deprivation of Rights Under Color of Law)

22 7. Between on or about September 1, 2018, and on or about May 30, 2019, in the Northern
23 District of California, the defendant,

24 SCOTT SHAW

25 while acting under the color of law, and acting without a legitimate purpose, touched Victim Two’s
26 buttocks without her consent, thereby willfully depriving Victim Two of liberty without due process of
27 law, which includes the right to bodily integrity, a right secured and protected by the Constitution and
28 laws of the United States.

1 All in violation of Title 18, United States Code, Section 242 (Class A Misdemeanor).

2
3 COUNT FOUR: (18 U.S.C. § 242 – Deprivation of Rights Under Color of Law)

4 8. Between on or about March 1, 2019, and on or about April 21, 2019, in the Northern
5 District of California, the defendant,

6 SCOTT SHAW

7 while acting under the color of law, and acting without a legitimate purpose, touched Victim Three’s
8 breast without her consent, thereby willfully depriving Victim Three of liberty without due process of
9 law, which includes the right to bodily integrity, a right secured and protected by the Constitution and
10 laws of the United States.

11 All in violation of Title 18, United States Code, Section 242 (Class A Misdemeanor).

12
13 COUNT FIVE: (18 U.S.C. § 242 – Deprivation of Rights Under Color of Law)

14 9. Between on or about December 1, 2019, and on or about December 31, 2019, in the
15 Northern District of California, the defendant,

16 SCOTT SHAW

17 while acting under the color of law, and acting without a legitimate purpose, touched Victim Four’s
18 breast without her consent and touched Victim Four’s buttocks without her consent, thereby willfully
19 depriving Victim Four of liberty without due process of law, which includes the right to bodily integrity,
20 a right secured and protected by the Constitution and laws of the United States.

21 All in violation of Title 18, United States Code, Section 242 (Class A Misdemeanor).

22
23 COUNT SIX: (18 U.S.C. § 242 – Deprivation of Rights Under Color of Law)

24 10. Between on or about January 15, 2020, and on or about February 28, 2020, in the
25 Northern District of California, the defendant,

26 SCOTT SHAW

27 while acting under the color of law, and acting without a legitimate purpose, touched Victim Four’s
28 buttocks without her consent, thereby willfully depriving Victim Four of liberty without due process of

1 law, which includes the right to bodily integrity, a right secured and protected by the Constitution and
2 laws of the United States.

3 All in violation of Title 18, United States Code, Section 242 (Class A Misdemeanor).
