defendant herein, using a means and facility of interstate and foreign commerce and in and affecting interstate commerce by any means, namely, the Internet, knowingly transported and caused to be transported child pornography, as that term is defined in Title 18, United States Code, Section 2256(8)(A), namely, an electronic file titled "me" with hash value 0E35162E083D178F3220056D64DBA862;

In violation of Title 18, United States Code, Section 2252A(a)(1) and 2252A(b)(1).

## **COUNT TWO**

The FEBRUARY 2017 GRAND JURY further charges:

On or about January 6, 2013, at Lake in the Hills, in the Northern District of Illinois, Western Division, and elsewhere,

#### PAUL W. CHRISTMANN,

defendant herein, using a means and facility of interstate and foreign commerce and in and affecting interstate commerce by any means, namely, the Internet, knowingly transported and caused to be transported child pornography, as that term is defined in Title 18, United States Code, Section 2256(8)(A), namely, an electronic file titled "me" with hash value 9E48BAB63F8FB1F70AD211A87D3EBDFE;

In violation of Title 18, United States Code, Section 2252A(a)(1) and 2252A(b)(1).

## **COUNT THREE**

The FEBRUARY 2017 GRAND JURY further charges:

On or about June 22, 2017, at Lake in the Hills, in the Northern District of Illinois, Western Division,

#### PAUL W. CHRISTMANN,

defendant herein, knowingly possessed material, namely, (a) a black Dell N7110 laptop computer, model number P14 E, and (b) a gray Dell laptop computer, model number P32E, serial number GHMSG22, that contained images of child pornography as defined in Title 18, United States Code, Section 2256(8)(A), such images having been mailed, shipped, and transported using any means and facility of interstate or foreign commerce, and such image having been produced using materials that had been shipped and transported in and affecting interstate and foreign commerce by any means, including specifically \$RQQQILV.mp4, (Kinderkutje) 12 Yo!!! New 0607!!! NAT1(VHS Series) Inc.avi, and (Asian Lolita) cambodian little girls [asian] #U79d8#U5bc6#U82b1#U56ed.avi;

In violation of Title 18, United States Code, Sections 2252A(a)(5)(B) and 2252A(b)(2).

seized from defendant's residence on or about June 22, 2017

a. black Dell N7110 laptop computer, model number P14 E; and

b. gray Dell laptop computer, model number P32E, serial number
