### **COUNT ONE**

The MAY 2018 GRAND JURY charges:

On or about February 24, 2016, at South Beloit, in the Northern District of Illinois, Western Division, and elsewhere,

#### DAVID WITTWER,

defendant herein, knowingly transported and caused to be transported child pornography, as defined in Title 18, United States Code, Section 2256(8)(A), including files titled "T\*\*I (02)" and "T\*\*I (12)," using a means and facility of interstate and foreign commerce, and in and affecting interstate commerce by any means, including by computer;

In violation of Title 18, United States Code, Section 2252A(a)(1).

## **COUNT TWO**

The MAY 2018 GRAND JURY further charges:

On or about April 21, 2017, at South Beloit, in the Northern District of Illinois, Western Division, and elsewhere,

#### DAVID WITTWER,

defendant herein, knowingly possessed material, namely, a Dell 3830 Venue 8 tablet computer with serial number "GMN6JZ1," and a Samsung Galaxy S III cellphone with Mobile Equipment Identifier 256691517608464530, that contained an image of child pornography as defined in Title 18, United States Code, Section 2256(8)(A), involving a prepubescent minor and a minor who had not attained 12 years of age, such image having been shipped and transported using any means and facility of interstate and foreign commerce, and such images having been produced using materials that had been shipped and transported in and affecting interstate and foreign commerce by any means, including by computer;

In violation of Title 18, United States Code, Sections 2252A(a)(5)(B) and 2252A(b)(2).

### **FORFEITURE ALLEGATION**

The MAY 2018 GRAND JURY further alleges:

1. The allegations in Counts One and Two of this Indictment are realleged here for the purpose of alleging forfeiture pursuant to Title 18, United

States Code, Section 2253.

2. As a result of his violations of Title 18, United States Code, Section

2252A, as alleged in the foregoing Indictment,

DAVID WITTWER,

defendant herein, shall forfeit to the United States any and all right, title and

interest defendant has in any matter that contains visual depictions described in

Title 18, United States Code, Section 2252A; and any and all property used or

intended to be used in any manner or part to commit and to promote the

commission of the said violations, including, but not limited to,

a. a Dell 3830 Venue 8 tablet computer with serial number "GMN6JZ1";

and

b. a Samsung Galaxy S III cellphone with Mobile Equipment Identifier
