## **COUNT ONE**

The SPECIAL APRIL 2021 GRAND JURY charges:

On or about May 20, 2021, at Chicago, in the Northern District of Illinois, Eastern Division,

### KIAR EVANS,

defendant herein, with the intent to cause death and serious bodily harm, attempted to take by force and violence, and by intimidation, a motor vehicle, namely, a 2018 Chevrolet Impala, that had been transported, shipped, or received in interstate and foreign commerce, from the person and presence of Victim A and Victim B;

In violation of Title 18, United States Code, Section 2119(1).

#### **COUNT TWO**

The SPECIAL APRIL 2021 GRAND JURY further charges:

On or about May 20, 2021, at Chicago, in the Northern District of Illinois, Eastern Division,

#### KIAR EVANS,

defendant herein, did use, carry, brandish and discharge a firearm, namely, a loaded Glock model 19, 9-millimeter pistol, bearing serial number BPWR950, during and in relation to a crime of violence for which defendant may be prosecuted in a court of the United States, namely, attempted carjacking, in violation of Title 18, United States Code, Section 2119(1), as charged in Count One of this Indictment;

In violation of Title 18, United States Code, Section 924(c)(1)(A)(ii) and (iii).

### **COUNT THREE**

The SPECIAL APRIL 2021 GRAND JURY further charges:

On or about May 20, 2021, at Chicago, in the Northern District of Illinois, Eastern Division,

#### KIAR EVANS,

defendant herein, with the intent to cause death and serious bodily harm, took by force and violence, and by intimidation, a motor vehicle, namely, a 2015 Nissan Altima, that had been transported, shipped, or received in interstate and foreign commerce, from the person and presence of Victim C;

In violation of Title 18, United States Code, Sections 2119(1).

#### **COUNT FOUR**

The SPECIAL APRIL 2021 GRAND JURY further charges:

On or about May 20, 2021, at Chicago, in the Northern District of Illinois, Eastern Division,

#### KIAR EVANS,

defendant herein, did use, carry and brandish a firearm, namely, a loaded Glock model 19, 9-millimeter pistol, bearing serial number BPWR950, during and in relation to a crime of violence for which defendant may be prosecuted in a court of the United States, namely, carjacking, in violation of Title 18, United States Code, Section 2119(1), as charged in Count Three of this Indictment;

In violation of Title 18, United States Code, Section 924(c)(1)(A)(ii).

#### **COUNT FIVE**

The SPECIAL APRIL 2021 GRAND JURY further charges:

On or about May 20, 2021, at Chicago, in the Northern District of Illinois, Eastern Division,

#### KIAR EVANS,

defendant herein, knowing that he had previously been convicted of a crime punishable by a term of imprisonment exceeding one year, did knowingly possess in and affecting interstate and foreign commerce a firearm, namely, a loaded Glock model 19, 9-millimeter pistol, bearing serial number BPWR950, which firearm had traveled in interstate and foreign commerce prior to defendant's possession of the firearm;

In violation of Title 18, United States Code, Section 922(g)(1).
