**I N F O R M A T I O N**

The defendant having waived in open court prosecution by Indictment, the United States Attorney for the District of New Jersey charges:

From on or about April 12, 2022 through on or about August 3, 2022, in Atlantic County, in the District of New Jersey, and elsewhere, the defendant,

ANTHONY BARBARINO,

did knowingly possess and attempt to possess material that contained at least three images of child pornography, as defined in Title 18, United States Code, Section 2256(8), involving a prepubescent minor and a minor who had not attained 12 years of age, which images had been mailed, shipped, and transported in and affecting interstate and foreign commerce by any means, including by computer, and which images were produced using materials that had been mailed, shipped, and transported in or affecting interstate or foreign commerce by any means, including by computer.

In violation of Title 18, United States Code, Sections 2252A(a)(5)(B) and (b)(2).

## **FORFEITURE ALLEGATION**

1. The United States hereby gives notice that upon the conviction of the defendant Anthony Barbarino of the offense in violation of 18 U.S.C. § 2252A(a)(5)(B) and (b)(2) charged in Count One of this Information, the United States will seek forfeiture, in accordance with 18 U.S.C. § 2253, of all right, title and interest of the defendant in the following:

- (a) any visual depiction described in 18 U.S.C. §§ 2251, 2251A, 2252, 2252A, 2252B, or 2260, or any book, magazine, periodical, film, videotape, or other matter which contains any such visual depiction, which was produced, transported, mailed, shipped or received in violation of Title 18, United States Code, Chapter 110;
  - (b) any property, real or personal, constituting or traceable to gross profits or other proceeds obtained from the offense charged in Count One of this Information, and all property traceable to such property; and
  - (c) any property, real or personal, used or intended to be used to commit or to promote the commission of such offense,
- and all property traceable to such property.

2. The property to be forfeited includes, but is not limited to, all right, title, and interest of the defendant in the following items seized from the defendant's residence on or about August 3, 2022:

- (a) One Seagate FreeAgent Go 250GB HDD, Model 9ZA2A4-500, serial number 2GE22A3V;
- (b) One iBUYPOWER Tower Computer, Model i-Series R165A663 062921, serial number D18A-BD09-93C6-1967-17; and
- (c) One Samsung Galaxy S22 Ultra Cellular Telephone, Model SM-S908U, serial number R5CT40TAJNP.

**Substitute Assets Provision**

3. If any of the above-described forfeitable property, as a result of any act or omission of the defendant:

- (a) cannot be located upon the exercise of due diligence;
- (b) has been transferred or sold to, or deposited with, a third person;
- (c) has been placed beyond the jurisdiction of the Court;
- (d) has been substantially diminished in value; or
- (e) has been commingled with other property which cannot be subdivided without difficulty;

it is the intent of the United States, pursuant to 21 U.S.C. § 853(p), as incorporated by 18 U.S.C. § 2253, to seek forfeiture of any other property of the defendant up to the value of the forfeitable property listed above.
