INDICTMENT

The Grand Jury in and for the District of New Jersey,
sitting at Newark, charges:

COUNT ONE

(Production of Child Pornography)

1. On or about August 19, 2012, in the District of New
Jersey, and elsewhere, the defendant,

JUSTIN KINNEY,

did knowingly employ, use, persuade, induce, entice, and coerce
a minor to engage in sexually explicit conduct for the purpose
of producing a visual depiction of such conduct, which visual
depiction was produced using materials that were mailed,
shipped, and transported in and affecting interstate and foreign
commerce by any means, including by computer;

In violation of Title 18, United States Code, Section
2251(a).

COUNT TWO

(Production of Child Pornography)

1. On or about October 10, 2012, in the District of New Jersey, and elsewhere, the defendant,

JUSTIN KINNEY,

did knowingly employ, use, persuade, induce, entice, and coerce a minor to engage in sexually explicit conduct for the purpose of producing a visual depiction of such conduct, which visual depiction was produced using materials that were mailed, shipped, and transported in and affecting interstate and foreign commerce by any means, including by computer;

In violation of Title 18, United States Code, Section 2251(a).

FORFEITURE ALLEGATION

1. The allegations contained in pages One through Two of this Indictment are hereby realleged and incorporated by reference for the purpose of alleging forfeiture pursuant to Title 18, United States Code, Section 2253(a).

2. Upon conviction for violating Title 18, United States Code, Sections 2251(a), the defendant,

JUSTIN KINNEY,


shall forfeit to the United States any and all matter that contains visual depictions of minors engaged in sexually explicit conduct in violation of the charged offenses; any property constituting or derived from any proceeds the defendant obtained directly or indirectly as a result of the said violations; and any and all property used or intended to be used in any manner or part to commit and to promote the commission of the aforementioned violations or any property traceable to such property, including but not limited to the following property seized from the defendant's residence on or about February 5, 2013:

a. one Dell Inspiron 1545 Laptop Computer, bearing serial number 4DYH7H1, which was surrendered to law enforcement on or about October 24, 2012; and

b. one blue Nokia cellular telephone with cracked screen, seized from the defendant's residence on or about October 25, 2012.
