Re: Plea Agreement with Biodiagnostic Laboratory Services, LLC

Dear Mr. Backfisch,

This letter sets forth the plea agreement between your client, Biodiagnostic Laboratory Services, LLC ("Biodiagnostic Laboratory Services"), through you as its authorized representative, and the United States Attorney for the District of New Jersey ("this Office").

Charge

Conditioned on the understandings specified below, this Office will accept a guilty plea from Biodiagnostic Laboratory Services to a two-count Information, which charges conspiracy to bribe physicians, contrary to 42 U.S.C. § 1320a-7b(b)(2)(A), N.J.S.A. § 2C:21-10, 18 U.S.C. § 1952(a)(3), and 18 U.S.C. §§ 1343 and 1346, in violation of 18 U.S.C. § 371, and conspiracy to commit money laundering, in violation of 18 U.S.C. § 1956(h). If Biodiagnostic Laboratory Services enters a guilty plea and is sentenced on these charges, and otherwise fully complies with all of the terms of this agreement, this Office will not initiate any further criminal charges against Biodiagnostic Laboratory Services for the bribing of physicians for the referral of blood specimens to Biodiagnostic Laboratory Services between 2006 and 2013. However, in the event that a guilty plea in this matter is not entered for any reason or the judgment of conviction entered as a result of this guilty plea does not remain in full force and effect, Biodiagnostic Laboratory Services agrees that any dismissed charges and any other charges that are not time-barred by the applicable statute of limitations on the date this agreement is signed by Biodiagnostic Laboratory Services may be commenced against it, notwithstanding the expiration of the limitations period after Biodiagnostic Laboratory Services signs the agreement.

Sentencing

The violation of 18 U.S.C. § 371 to which Biodiagnostic Laboratory Services agrees to plead guilty carries a statutory minimum term of probation of 1 year, a statutory maximum term of probation of 5 years, and a statutory maximum fine equal to the greatest of: (1) \$500,000; (2) twice the gross amount of any pecuniary gain that any persons derived from the offense; or (3) twice the gross amount of any pecuniary loss sustained by any victims of The violation of 18 U.S.C. § 1956 to which Biodiagnostic the offense. Laboratory Services agrees to plead quilty carries a statutory minimum term of probation of 1 year, a statutory maximum term of probation of 5 years and a statutory maximum fine equal to the greatest of: (1) \$500,000; (2) twice the gross amount of any pecuniary gain that any persons derived from the offense; or (3) twice the gross amount of any pecuniary loss sustained by any victims of The sentence on each count may run consecutively. the offense. Fines imposed by the sentencing judge may be subject to the payment of interest.

The sentence to be imposed upon Biodiagnostic Laboratory Services is within the sole discretion of the sentencing judge, subject to the provisions of the Sentencing Reform Act, 18 U.S.C. § 3551-3742, and the sentencing judge's consideration of the United States Sentencing Guidelines. The United States Sentencing Guidelines are advisory, not mandatory. The sentencing judge may impose any reasonable sentence up to and including the statutory maximum term of probation and the maximum statutory fine. This Office cannot and does not make any representation or promise as to what guideline range may be found by the sentencing judge, or as to what sentence Biodiagnostic Laboratory Services ultimately will receive.

Further, in addition to imposing any other penalty on Biodiagnostic Laboratory Services, the sentencing judge: (1) will order Biodiagnostic Laboratory Services to pay an assessment of \$400 per count pursuant to 18 U.S.C. § 3013, which assessment must be paid by the date of sentencing; (2) may order Biodiagnostic Laboratory Services to pay restitution pursuant to 18 U.S.C. § 3663 <u>et seq</u>., 18 U.S.C. § 3563(b)(2), or 18 U.S.C. § 3583(d); (3) may order Biodiagnostic Laboratory Services, pursuant to 18 U.S.C. § 3555, to give notice to any victims of its offenses; and (4) must order forfeiture, pursuant to 18 U.S.C. § 982 and 18 U.S.C. § 981(a)(1)(C), and 28 U.S.C. § 2461.

Rights of This Office Regarding Sentencing

Except as otherwise provided in this agreement, this Office reserves its right to take any position with respect to the appropriate sentence to be imposed on Biodiagnostic Laboratory Services by the sentencing judge, to correct any misstatements relating to the sentencing proceedings, and to provide the sentencing judge and the United States Probation Office all law and information relevant to sentencing, favorable or otherwise. In addition, this Office may inform the sentencing judge and the United States Probation Office of: (1) this agreement; and (2) the full nature and extent of Biodiagnostic Laboratory Services' activities and relevant conduct with respect to this case.

Stipulations

This Office and Biodiagnostic Laboratory Services agree to stipulate at sentencing to the statements set forth in the attached Schedule A, which hereby is made a part of this plea agreement. This agreement to stipulate, however, cannot and does not bind the sentencing judge, who may make independent factual findings and may reject any or all of the stipulations entered into by the parties. To the extent that the parties do not stipulate to a particular fact or legal conclusion, each reserves the right to argue the existence of and the effect of any such fact or conclusion upon the sentence. Moreover, this agreement to stipulate on the part of this Office is based on the information and evidence that this Office possesses as of the date of this agreement. Thus, if this Office obtains or receives additional evidence or information prior to sentencing that it determines to be credible and to be materially in conflict with any stipulation in the attached Schedule A, this Office shall not be bound by any such stipulation. A determination that any stipulation is not binding shall not release either this Office or Biodiagnostic Laboratory Services from any other portion of this agreement, including any other stipulation. If the sentencing court rejects a stipulation, both parties reserve the right to argue on appeal or at post-sentencing proceedings that the sentencing court was within its discretion and authority to do so. These stipulations do not restrict the Government's right to respond to questions from the Court and to correct misinformation that has been provided to the Court.

Waiver of Appeal and Post-Sentencing Rights

As set forth in Schedule A, this Office and Biodiagnostic Laboratory Services waive certain rights to file an appeal, collateral attack, writ, or motion after sentencing, including but not limited to an appeal under 18 U.S.C. § 3742 or a motion under 28 U.S.C. § 2255.

Forfeiture

As part of its acceptance of responsibility, Biodiagnostic Laboratory Services agrees to forfeit to the United States: (a) as to Count One, (i) pursuant to 18 U.S.C. §§ 982(a)(7) and 982(b) and 21 U.S.C. § 853, all property, real and personal, that constitutes or is derived, directly and indirectly, from gross proceeds traceable to the conspiracy to violate 42 U.S.C. § 1320a 7b(b)(2)(A), a Federal health care offense as defined in 18 U.S.C. § 24, and (ii) pursuant to 18 U.S.C. § 981(a)(1)(C) and 28 U.S.C. § 2461, all property, real and personal, that constitutes or is derived from proceeds traceable to the conspiracy to violate 18 U.S.C. §§ 1952(a)(3), 1343 and 1346; and (b) as to Count Two, pursuant to 18 U.S.C. § 982(a)(1), all property, real and personal, involved in the money laundering conspiracy offense, and all property traceable to such property. The property subject to forfeiture includes, but is not limited to, all right, title and interest of Biodiagnostic Laboratory Services in the following:

- (a) The valuable and readily salable assets of Biodiagnostic Laboratory Services, formerly located at 181 New Road, Suite 307, Parsippany, New Jersey, and the net proceeds from the sale of such assets, including but not limited to, the assets listed on Schedule B hereto; and
- (b) All funds on deposit or formerly on deposit in PNC Bank Account Nos. 0999, 0999, 3109 and 2223, held in the name of Bio Diagnostic Laboratory

(hereinafter referred to collectively as the "Specific Property").

Pursuant to Rule 32.2(b)(4) of the Federal Rules of Criminal Procedure, Biodiagnostic Laboratory Services consents to the entry of a Consent Preliminary Order of Forfeiture that will be final as to Biodiagnostic Laboratory Services prior to sentencing. Further, because all of the specific property subject to forfeiture as a result of Biodiagnostic Laboratory Services' conviction of the offenses charged in Counts One and Two of the Information may not have been identified as of the date of this agreement, and may not be identified prior to sentencing, Biodiagnostic Laboratory Services agrees to consent to the entry of amended preliminary orders of forfeiture if additional specific property is identified, pursuant to Rule 32.2(b)(2)(C) of the Federal Rules of Criminal Procedure.

Biodiagnostic Laboratory Services further consents to the administrative and/or civil forfeiture of the Specific Property pursuant to 18 U.S.C. § 981(a). Biodiagnostic Laboratory Services agrees that it will not file a claim or a petition for remission or mitigation in any forfeiture proceeding involving the Specific Property and will not cause or assist anyone else in doing so. То the extent Biodiagnostic Laboratory Services has filed a claim or petition in any administrative forfeiture proceeding involving the Specific Property, such claims or petitions are hereby deemed withdrawn. Biodiagnostic Laboratory Services further agrees to take all necessary steps to pass clear title to the Specific Property to the United States, including, but not limited to, the surrender of such property to the United States Marshals Service and the execution of all necessary documentation. It is further understood that any forfeiture of Biodiagnostic Laboratory Services' assets shall not be treated as satisfaction of any fine, restitution, or any other penalty the Court may impose upon it in addition to forfeiture. Biodiagnostic Laboratory Services hereby waives any and all claims that the forfeiture constitutes an excessive fine and agrees that the forfeiture does not violate the Eighth Amendment.

Biodiagnostic Laboratory Services waives the requirements of Rules 32.2 and 43(a) of the Federal Rules of Criminal Procedure regarding notice of the forfeiture in the charging instrument, announcement of the forfeiture at sentencing, and incorporation of the forfeiture in the judgment. Biodiagnostic Laboratory Services understands that the forfeiture of the Specific Property, as well as any additional specific property that may be identified subsequent to the date of this agreement, is part of the sentence that may be imposed in this case and waives any failure by the court to advise it of this pursuant to Rule 11(b)(1)(J) of the Federal Rules of Criminal Procedure at the guilty plea proceeding.

Biodiagnostic Laboratory Services is hereby barred from asserting any claim against the United States, its departments and agencies, agents and employees, in their individual and official capacities, in connection with or arising out of, the United States' seizure, restraint, constructive possession and or management of the property that was seized or restrained pursuant to a seizure warrant issued on or about April 9, 2013, by the Honorable Madeline Cox Arleo, then United States Magistrate Judge for the District of New Jersey, including but not limited to the actions or inactions undertaken pursuant to the Stipulation and Order entered into between the Office and Biodiagnostic Laboratory Services on or about April 30, 2013.

Biodiagnostic Laboratory Services further agrees to hold harmless the United States, its departments and agencies, agents and employees, in their individual and official capacities, from any and all claims, including, without limitation, third party claims, in connection with or arising out of, the United States' seizure, restraint, constructive possession and or management of the property that was seized or restrained pursuant to a seizure warrant issued on or about April 9, 2013, by the Honorable Madeline Cox Arleo, then United States Magistrate Judge for the District of New Jersey, including but not limited to the actions or inactions undertaken pursuant to the Stipulation and Order entered into between the Office and Biodiagnostic Laboratory Services on or about April 30, 2013.

Other Provisions

This agreement is limited to the United States Attorney's Office for the District of New Jersey and cannot bind other federal, state, or local authorities. However, this Office will bring this agreement to the attention of other prosecuting offices, if requested to do so.

This agreement was reached without regard to any civil or administrative matters that may be pending or commenced in the future against Biodiagnostic Laboratory Services. This agreement does not prohibit the United States, any agency thereof (including the Internal Revenue Service), or any third party from initiating or prosecuting any civil or administrative proceeding against Biodiagnostic Laboratory Services.

Biodiagnostic Laboratory Services agrees that it is authorized to enter into this agreement, that it has authorized the undersigned corporate representative to take this action, and that all corporate formalities for such authorization have been observed. Biodiagnostic Laboratory Services further agrees that the plea of guilty will be entered by Steven Backfisch, Biodiagnostic Laboratory Services' authorized corporate representative, and that Steven Backfisch is authorized to enter a plea of guilty on Biodiagnostic Laboratory Services' behalf. By entering this guilty plea, Biodiagnostic Laboratory Services hereby waives all objections to the form of the charging documents and admits that it is in fact guilty of the offense as set forth in the Information.

Biodiagnostic Laboratory Services further agrees that, promptly after the Court's acceptance of this guilty plea and its entry on the docket, Biodiagnostic Laboratory Services shall file a certificate of dissolution with the appropriate New Jersey state agency and take any other steps necessary to dissolve the LLC under state and local law. Following the wind up of its affairs, with the prior concurrence of the Office, Biodiagnostic Laboratory Services shall file a certificate of termination with the appropriate New Jersey state agency.

No Other Promises

This agreement constitutes the plea agreement between Biodiagnostic Laboratory Services and this Office and supersedes any previous agreements between them. No additional promises, agreements, or conditions have been made or will be made unless set forth in writing and signed by the parties.

Plea Agreement with Biodiagnostic Laboratory Services

Schedule A

- 1. This Office and Biodiagnostic Laboratory Services recognize that the United States Sentencing Guidelines are not binding upon the Court. This Office and Biodiagnostic Laboratory Services nevertheless agree to the stipulations set forth herein, and agree that the Court should sentence Biodiagnostic Laboratory Services in accordance with those stipulations.
- 2. The version of the United States Sentencing Guidelines effective November 1, 2015, applies in this case.
- 3. The applicable guideline is U.S.S.G. § 8A1.1.
- 4. The parties agree that the Court should not impose a fine, as Biodiagnostic Laboratory Services will not have any remaining ability to pay a fine after payment of the agreed-upon forfeiture.
- 5. The parties agree that the Court should impose a one-year term of probation on each count, to run concurrently, as Biodiagnostic Laboratory Services is no longer in operation.
- 6. If the sentencing court accepts a stipulation set forth above, both parties waive the right to file an appeal, collateral attack, writ, or motion claiming that the sentencing court erred in doing so. Otherwise, both parties reserve the right to file, oppose, or take any position in any appeal, collateral attack, or proceeding involving post-sentencing motions or writs.
