INDICTMENT

The Grand Jury in and for the District of New Jersey, sitting at Newark, charges:

COUNT ONE

(Possession of a Firearm and Ammunition by a Convicted Felon)

On or about May 9, 2022, in Essex County, in the District of New Jersey, and elsewhere, the defendant,

IBRAHEEM MUHAMMAD,

knowing that he had previously been convicted of a crime punishable by a term of imprisonment exceeding one year, did knowingly possess a firearm and ammunition, namely a loaded Girsan 9mm, semi automatic handgun, bearing serial number T6368-20A V05055 and fourteen (14) rounds of 9mm ammunition, and the firearm and ammunition were in and affecting commerce.

In violation of Title 18, United States Code, Section 922(g)(1).

COUNT TWO

(Possession with Intent to Distribute Controlled Substances)

On or about May 9, 2022, in Essex County, in the District of New Jersey, and elsewhere, the defendant,

IBRAHEEM MUHAMMAD,

did knowingly and intentionally possess with intent to distribute a quantity of a mixture and substance containing a detectable amount of heroin, a Schedule I controlled substance, and a quantity of a mixture and substance containing a detectable amount of cocaine, a Schedule II controlled substance.

In violation of Title 21, United States Code, Sections 841(a)(1) and 841(b)(1)(C).

COUNT THREE

(Possession of a Firearm in Furtherance of a Drug Trafficking Crime)

On or about May 9, 2022, in Essex County, in the District of New Jersey, and elsewhere, the defendant,

IBRAHEEM MUHAMMAD,

in furtherance of a drug trafficking crime for which the defendant may be prosecuted in a court of the United States, namely, possession with intent to distribute controlled substances as charged in Count Two of this Indictment, did knowingly possess a firearm, namely, a Girsan 9mm, semi-automatic handgun, bearing serial number T6368-20A V05055.

In violation of Title 18, United States Code, Section 924(c)(1)(A)(i).

FORFEITURE ALLEGATION AS TO COUNTS ONE AND THREE

Upon conviction of the offenses in violation of Title 18, United States Code, Sections 922(g)(1) and 924(c) as set forth in Counts One and Three of this Indictment, the defendant,

IBRAHEEM MUHAMMAD,

shall forfeit to the United States any firearms and ammunition involved in or used in the commission of those offenses, including, but not limited to, a Girsan 9mm, semi-automatic handgun, bearing serial number T6368-20A V05055, which was loaded with fourteen rounds of 9-millimeter ammunition.

FORFEITURE ALLEGATION AS TO COUNT TWO

Pursuant to Title 21, United States Code, Section 853, upon conviction of the offense in violation of Title 21, United States Code, Sections 841(a)(1) and 841(b)(1)(C) as set forth in Count Two of this Indictment, the defendant,

IBRAHEEM MUHAMMAD,

shall forfeit to the United States of America any property constituting, or derived from, any proceeds obtained, directly or indirectly, as the result of such offense and any and all property used or intended to be used in any manner or part to commit and to facilitate the commission of the offense alleged in Count Two of this Indictment.

SUBSTITUTE ASSETS PROVISION
(Applicable to all Forfeiture Allegations)

If any of the above described forfeitable property, as a result of any act or omission of the defendant:

- (a) cannot be located upon the exercise of due diligence;
- (b) has been transferred or sold to, or deposited with, a third person;
- (c) has been placed beyond the jurisdiction of the Court;
- (d) has been substantially diminished in value; or
- (e) has been commingled with other property which cannot be subdivided without difficulty;

it is the intent of the United States, pursuant to Title 21, United States Code, Section 853(p), to seek forfeiture of any other property of the defendant up to the value of the above described forfeitable property.
