#### INFORMATION

The defendant having waived in open court prosecution by Indictment, the United States Attorney for the District of New Jersey charges:

#### COUNT ONE (Wire Fraud)

On or about November 3, 2023, in Essex County, in the District of New Jersey, and elsewhere, the defendant,

#### KARIEEM STAMPS,

did knowingly and intentionally devise and intend to devise a scheme and artifice to defraud, and to obtain money and property from the victim by means of materially false and fraudulent pretenses, representations, and promises, and for the purpose of executing and attempting to execute such scheme and artifice, did knowingly and intentionally transmit or cause to be transmitted signals by means of wire in interstate commerce.

In violation of Title 18, United States Code, Section 1343.

## **COUNT TWO** (Aggravated Identity Theft)

On or about November 3, 2023, in Essex County, in the District of New Jersey, and elsewhere, the defendant,

#### KARIEEM STAMPS,

did knowingly use, without lawful authority, a means of identification of another person during and in relation to a felony violation enumerated in Title 18, United States Code, Section 1028A(c), to wit, wire fraud, in violation of Title 18, United States Code, Secitor 1343, as described in Count One of this Information, knowing that the means of identification belonged to another actual person.

In violation of Title 18, United States Code, Section 1028A(a)(1).

#### COUNT THREE

(Possession of a Firearm and Ammunition by a Convicted Felon)

On or about August 1, 2024, in Essex County, in the District of New Jersey, and elsewhere, the defendant,

#### KARIEEM STAMPS,

knowing that he had previously been convicted of a crime punishable by a term of imprisonment exceeding one year, did knowingly possess a firearm, namely a Glock 29 Gen5 handgun, bearing serial number CCRT895 with an extended magazine and twenty-six rounds of 9mm ammunition, and the firearm and ammunition were in and affecting commerce.

In violation of Title 18, United States Code, Section 922(g)(1).

#### FORFEITURE ALLEGATION AS TO COUNT ONE

Upon conviction of the offense in violation of Title 18, United States Code, Section 1343 charged in Count One of this Information, the defendant,

#### KARIEEM STAMPS,

shall forfeit to the United States of America, pursuant to Title 18, United States Code, Section 981(a)(1)(C) and Title 28, United States Code, Section 2461(c), all property, real and personal, the defendant obtained that constitutes or is derived from proceeds traceable to the commission of such offense.

## FORFEITURE ALLEGATION AS TO COUNT THREE

Upon conviction of the offense in violation of Title 18, United States Code, Section 922(g)(1) alleged in Count Three of this Information, the defendant,

## KARIEEM STAMPS,

shall forfeit to the United States, pursuant to Title 18, United States Code, Section 924(d)(1) and Title 28, United States Code, Section 2461(c), any firearms and ammunition involved in or used in the commission of such offense, including, but not limited to, the following:

- (a) one Glock 29 Gen5 handgun, bearing serial number CCRT895, with an extended magazine; and
- (b) twenty-six rounds of 9mm ammunition.

## SUBSTITUTE ASSETS PROVISION (Applicable to All Forfeiture Allegations)

If any of the above-described forfeitable property, as a result of any act or omission of the defendant:

- cannot be located upon the exercise of due diligence; (a)
- has been transferred or sold to, or deposited with, a third party; (b)
- (c) has been placed beyond the jurisdiction of the Court;
- (d) has been substantially diminished in value; or
- (e) has been commingled with other property which cannot be subdivided without difficulty,

it is the intent of the United States, pursuant to Title 21, United States Code, Section 853(p), as incorporated by Title 28, United States Code, Section 2461(c), to seek forfeiture of any other property of the defendant up to the value of the forfeitable property described above.
