**I N F O R M A T I O N**

The defendant having waived in open court prosecution by Indictment, the United States Attorney for the District of New Jersey charges:

On or about October 29, 2024, in Ocean County, in the District of New Jersey and elsewhere, the defendant,

JOHN MANGAN,

did knowingly possess and attempt to possess a Samsung Galaxy Note 10 cellphone, bearing serial number R58MA71L6BR, that contained at least three images of child pornography, as defined in Title 18, United States Code, Section 2256(8), that had been mailed, shipped, and transported in and affecting interstate and foreign commerce by any means, including by computer, and which images were produced using materials that had been mailed, shipped, and transported in and affecting interstate and foreign commerce by any means, including by computer, after having previously been convicted, in New Jersey Superior Court, of sexual assault in the second degree, in violation of N.J.S.A. 2C:14-2(c)(5), and, in the United States District Court for the District of New Jersey, of possession of child pornography, in violation of 18 U.S.C. § 2252A(a)(5)(B).

In violation of Title 18, United States Code, Sections 2252A(a)(5)(B) and 2252A(b)(2).

## **FORFEITURE ALLEGATIONS**

As a result of committing the offense alleged in the sole count of this Information, the defendant,

JOHN MANGAN,

shall forfeit to the United States, pursuant to 18 U.S.C. § 2253, all of defendant MANGAN's right, title and interest in the following:

- a. any visual depiction described in 18 U.S.C. §§ 2251, 2251A, 2252, 2252A, 2252B, or 2260, or any book, magazine, periodical, film, videotape, or other matter which contains any such visual depiction, which was produced, transported, mailed, shipped or received in violation of 18 U.S.C. Part I, Chapter 110;
- b. any property, real or personal, constituting or traceable to gross profits or other proceeds obtained from the offenses charged in this Information, and all property traceable to such property; and
- c. any property, real or personal, used or intended to be used to commit or to promote the commission of such offense, and all property traceable to such property.


The property to be forfeited includes, but is not limited to, all of MANGAN's right, title, and interest in a Samsung Galaxy Note 10 cellphone, bearing serial number R58MA71L6BR.

### **SUBSTITUTE ASSETS PROVISION**

If any of the forfeitable property described above, as a result of any act or omission of the defendant:

- a. cannot be located upon the exercise of due diligence;
- b. has been transferred or sold to, or deposited with, a third party;
- c. has been placed beyond the jurisdiction of the court;
- d. has been substantially diminished in value; or
- e. has been commingled with other property which cannot be divided without difficulty,

it is the intent of the United States, pursuant to 21 U.S.C. § 853(p), as incorporated by 18 U.S.C. § 2253 and 28 U.S.C. § 2461(c), to seek forfeiture of any other property of the defendant up to the value of the above forfeitable property.
