I N F O R M A T I O N

The defendant having waived in open court prosecution by Indictment, the United States charges:

(Fraud and Related Activity in Connection with Access Devices)

On or about May 19, 2023, in the District of New Jersey and elsewhere, the defendant,

**FERAS KHALIL AHMAD ALBASHITI,
a/k/a “r1z,”
a/k/a “Feras Bashiti,” and
a/k/a “Firas Bashiti,”**

knowingly and with intent to defraud, trafficked in and used one or more unauthorized access devices, that is, login credentials, during any one-year period, and by such conduct obtained anything of value aggregating \$1,000 or more during that period.

In violation of Title 18, United States Code, Sections 1029(a)(2) and (c)(1)(A)(i).

FORFEITURE ALLEGATION

1. As a result of committing the offense charged in this Information, the defendant,

**FERAS KHALIL AHMAD ALBASHITI,
a/k/a “r1z,”
a/k/a “Feras Bashiti,” and
a/k/a “Firas Bashiti,”**

shall forfeit to the United States, pursuant to Title 18, United States Code, Section 981(a)(1)(C) and Title 28, United States Code, Section 2461, all property, real and personal, that constitutes or is derived from proceeds traceable to the commission of the said offense, and all property traceable thereto.

SUBSTITUTE ASSETS PROVISION (Applicable to All Forfeiture Allegations)

2. If any of the above-described forfeitable property, as a result of any act or omission of the Defendant:


- a. cannot be located upon the exercise of due diligence;
- b. has been transferred or sold to, or deposited with a third party;
- c. has been placed beyond the jurisdiction of the court;
- d. has been substantially diminished in value; or
- e. has been commingled with other property which cannot be divided without difficulty,

it is the intent of the United States, pursuant to Title 21, United States Code, Section 853(p), as incorporated by Title 28, United States Code, Section 2461(c), to seek

forfeiture of any other property of the defendant up to the value of the above-described forfeitable property.
