I N F O R M A T I O N

The defendant having waived in open court prosecution by Indictment, the United States charges:

COUNTS 1–17
(Misbranding of Prescription Drug)

1. At all times relevant to this Information, Louis Morelli was a licensed physician in the State of New Jersey practicing psychiatry at Louis C. Morelli, M.D. P.C.

2. On or about the dates listed below, in Atlantic County, in the District of New Jersey, and elsewhere, the defendant,

LOUIS MORELLI,

caused, with intent to defraud and mislead, the below-listed prescription drugs, or their generic equivalents, to be dispensed without valid prescriptions, which resulted in the drugs being misbranded while held for sale after such drugs were shipped in interstate commerce:

FORFEITURE ALLEGATION AS TO COUNTS 1 THROUGH 17

Upon conviction of the offenses in violation of Title 21, United States Code, Sections 331(k), 333(a)(2), and 353(b)(1), set forth in Counts One through Seventeen of the Information, the defendant, LOUIS MORELLI, shall forfeit to the United States, pursuant to Title 18, United States Code, Sections 24 and 982(a)(7), any and all property constituting or derived from any proceeds the defendant obtained directly or indirectly as a result of the offenses charged in Counts 1 through 17 of this Information, and any and all property used or intended to be used in any manner or part to commit and to facilitate the commission of such offenses, which totals \$2,125.00.

SUBSTITUTE ASSETS PROVISION (Applicable to All Forfeiture Allegations)

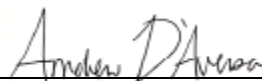
If any of the above forfeitable property, as a result of any act or omission of the defendant:

- (a) cannot be located upon the exercise of due diligence;
- (b) has been transferred or sold to, or deposited with, a third person;
- (c) has been placed beyond the jurisdiction of the Court;
- (d) has been substantially diminished in value; or
- (e) has been commingled with other property which cannot be subdivided without difficulty;

the United States intends, pursuant to Title 18, United States Code, Sections 24 and 982(a)(7), as incorporated by Title 28, United States Code, Section 2461(c), to seek

forfeiture of any other property of the defendant up to the value of the above-described forfeitable property.
