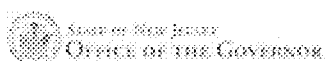

ReCap: I met with Mayor Menna at his law office to distribute a flag from the 10th anniversary of 9/11. He was very honored to be able to receive a flag and will be presenting it to council at the next meeting.

He has several issues for the administration to consider. The first is that Red Bank is a regional hub, with many non-profit agencies in the town, and many of those agencies are looking to expand. Currently 18% of Red Bank's taxable property is being utilized by a non-profit agency, which prevents tens of thousands of dollars from being collect in local taxes. He asks that we consider supporting legislation that would require a PILOT from non-profits for any ADDITIONAL expansion, but not to be a PILOT for their current facilities. This would help ensure that the non-profits consider the taxable impact they have on expansion. Secondly, he is concerned about school funding, but I assured him of our talking points that the Governor is committed to reforms and to fully funding the school funding formula within 5 years.

Overall, this was a great meeting, and while he will likely not endorse us, he does have sincere appreciation for what we are doing.
