**INDICTMENT**

The Grand Jury in and for the District of New Jersey, sitting at Newark, charges:

**COUNT ONE**  
*(Drug Conspiracy)*

From at least in or around September 2018 through on or about October 1, 2019, in Passaic County, in the District of New Jersey, and elsewhere, defendant

**KEITH BRINKLEY,**  
**a/k/a "K,"**  
**a/k/a "K Murder"**

did knowingly and intentionally conspire and agree with others, known and unknown, to distribute and possess with intent to distribute a mixture and substance containing a detectable amount of fentanyl, (N-phenyl-N-[1-(2-phenylethyl)-4-piperidinyl] Propanamide), a Schedule II controlled substance, contrary to Title 21, United States Code, Sections 841(a)(1) and (b)(1)(C).

In violation of Title 21, United States Code, Section 846.

**COUNT TWO**

*(Distribution of Fentanyl)*

On or about April 23, 2019, in Passaic County, in the District of New Jersey, defendant

**KEITH BRINKLEY,  
a/k/a "K,"  
a/k/a "K Murder"**

did knowingly and intentionally distribute a mixture and substance containing a detectable amount of a mixture and substance containing a detectable amount of fentanyl, (N-phenyl-N-[1-(2-phenylethyl)-4-piperidinyl] Propanamide), a Schedule II controlled substance.

In violation of Title 21, United States Code, Sections 841(a)(1) and 841(b)(1)(C).

**FORFEITURE ALLEGATION**

1. The allegations set forth in Counts One and Two of this Indictment are hereby realleged and incorporated by reference for the purpose of alleging forfeiture pursuant to Title 21, United States Code, Section 853.

2. Pursuant to Title 21, United States Code, Section 853, upon conviction of the controlled substance offense alleged in Counts One and Two of this Indictment, defendant

**KEITH BRINKLEY,  
a/k/a "K,"  
a/k/a "K Murder"**

shall forfeit to the United States of America any and all property constituting or derived from any proceeds the defendant obtained directly or indirectly as a result of that offense, and any and all property used or intended to be used in any manner or part to commit and to facilitate the commission of that offense.

3. If any of the property described above, as a result of any act or omission of the defendant:

- a. cannot be located upon the exercise of due diligence;
- b. has been transferred or sold to, or deposited with, a third party;
- c. has been placed beyond the jurisdiction of the court;
- d. has been substantially diminished in value; or
- e. has been commingled with other property which cannot be divided without difficulty,

the United States shall be entitled, pursuant to 21 U.S.C. § 853(p), to the forfeiture of any other property of the defendant up to the value of the above-described forfeitable property.
