### INFORMATION

The defendant having waived in open court prosecution by indictment,
the Acting United States Attorney for the District of New Jersey charges:

On or about July 24, 2020, in Ocean County, in the District of New Jersey, and elsewhere, the defendant,

### KEVON BELFON,

knowing that he had previously been convicted of a crime punishable by imprisonment for a term exceeding one year in a court in the State of New York, did knowingly possess a firearm, namely, a Taurus 9 millimeter semi-automatic handgun, bearing serial number ABC398644, and the firearm was in and affecting commerce.

In violation of Title 18, United States Code, Section 922(g)(1),

#### FORFEITURE ALLEGATION

- The allegations contained in this Information are hereby realleged and incorporated by reference as though set forth in full herein for the purpose of alleging forfeiture pursuant to Title 18, United States Code, Section 924(d)(1) and Title 28, United States Code, Section 2461(c).
- Upon conviction of the offense in violation of Title 18. United States
   Code, Section 922(g)(1), set forth in this Information, the defendant.

#### KEVON BELFON,

shall forfeit to the United States, pursuant to Title 18, United States Code.

Section 924(d)(1) and Title 28, United States Code, Section 2461(c), any

firearms and ammunition involved in or used in the commission of the offense,
including, but not limited to, the following:

- One (1) Taurus 9 millimeter semi-automatic handgur, bearing serial number ABC398644; and
- (ii) ten (10) rounds of 9 millimeter ammunition.

## Substitute Assets Provision

- If any of the above-described forfeitable property, as a result of any act or omission of the defendant:
  - (a) cannot be located upon the exercise of due diligence;
  - (b) has been transferred or sold to, or deposited with, a third person;
  - (c) has been placed beyond the jurisdiction of the Coun;
  - (d) has been substantially diminished in value; or
  - has been commingled with other property which cannot be subdivided without difficulty;

it is the intent of the United States, pursuant to 21 U.S.C. § 853(p), as incorporated by 28 U.S.C. § 2461(c), to seek forfeiture of any other property of said defendant up to the value of the above forfeitable property.
