INDICTMENT

The Grand Jury in and for the District of New Jersey, sitting at Newark,
charges:

COUNT ONE

(Possession of a Firearm and Ammunition by a Convicted Felon)

On or about February 23, 2021, in Essex County, in the District of New
Jersey and elsewhere, the defendant,

**DAVONE ADAMS,
a/k/a "Dikim Adams,"**

knowing that he had previously been convicted of at least one crime punishable
by a term of imprisonment exceeding one year, did knowingly possess in and
affecting interstate commerce two firearms, namely one Ruger, Model P95, 9
millimeter Luger pistol, bearing serial number 31606006, loaded with ten (10)
rounds of 9 millimeter ammunition, and one Windam Weaponry, Model WW-
15, .223/5.56 millimeter rifle, bearing serial number WW236809, loaded with
thirty (30) rounds of 5.56 millimeter ammunition.

In violation of Title 18, United States Code, Section 922(g)(1).

FORFEITURE ALLEGATION

As a result of committing the instant firearms offense in violation of 18 U.S.C. § 922(g)(1), as charged in this Indictment, the defendant,

**DAVONE ADAMS,
a/k/a "Dikim Adams,"**

shall forfeit to the United States, pursuant to 18 U.S.C. § 924(d) and 28 U.S.C. § 2461(c), any firearms and ammunition involved in or used in the commission of such offense, including, but not limited to, one Ruger, Model P95, 9 millimeter Luger pistol, bearing serial number 31606006, one Windam Weaponry, Model WW-15, .223/5.56 millimeter rifle, bearing serial number WW236809, ten (10) rounds of 9 millimeter ammunition, and thirty (30) rounds of 5.56 millimeter ammunition.

Substitute Assets Provision

If any of the property described above, as a result of any act or omission of the defendant:


- a. cannot be located upon the exercise of due diligence;
- b. has been transferred or sold to, or deposited with, a third party;
- c. has been placed beyond the jurisdiction of the court;
- d. has been substantially diminished in value; or
- e. has been commingled with other property which cannot be divided without difficulty,

it is the intent of the United States, pursuant to 21 U.S.C. § 853(p), as incorporated by 28 U.S.C. § 2461(c), to seek forfeiture of any other property of the defendant up to the value of the above forfeitable property.
